## THE THREE RIVERS (VARIOUS ROADS) (PROHIBITION OF STOPPING ON FOOTWAYS, CYCLE TRACKS AND VERGES) ORDER 2012 (AMMENDMENT No 1) ORDER 2013

The Three Rivers District Council ("the Council"), pursuant to arrangements made under Section 19 of the Local Government Act 2000 and the Local Government (Arrangements for Discharge of Functions) (England) Regulations 2000 with the Hertfordshire County Council, and in exercise of the powers conferred on that County Council under Sections 1, 2, 3 and 4 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act of 1984") and of all other enabling powers, and after consulting with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

- 1. This Order may be cited as "The Three Rivers (Various Roads) (Prohibition of Stopping on Footways, Cycle Tracks and Verges) Order 2012 (Amendment No 1) Order 2013 [this Order]" and shall amend the "The Three Rivers District Council (Various Roads) (Prohibition of Stopping on Footways, Cycle Tracks and Verges) Order 2012" [the Order of 2012 or that Order] and shall come into operation on the 13<sup>th</sup> May 2013.
- 2. The Order of 2012 shall have effect as if the Schedule to that Order were substituted by the Schedule to this Order.
- The restrictions imposed by this Order shall be in addition to, and not in derogation of, any restriction or requirement imposed by any regulation made or having effect as if made under the Act of 1984 or by or under any other enactment.

## SCHEDULE PROHIBITION OF STOPPING ON FOOTWAYS, CYCLE TRACKS AND VERGES

item number	LOCATION
01	Beechwood Avenue, Chorleywood
02	Blacketts Wood Drive, Chorleywood
03	Brushwood Drive, Chorleywood
04	Capell Way, Chorleywood
05	Capell Road (part), Chorleywood From its junction with Capell Way southwest to a point opposite the common boundary of 30 and 32, Capell Road.
06	Carpenters Wood Drive, Chorleywood
07	Chalfont Lane, Chorleywood
08	Grove Way, Chorleywood
09	Grovewood Close, Chorleywood
10	Hubbards Road (part), Chorleywood From its junction with Chorleywood Bottom southwest to a point 15 metres northeast of the northeast kerbline of Copmans Wick.
11	Meadow Way, Bedmond
12	St Peters Way, Chorleywood
13	Whitelands Avenue (part), Chorleywood From a point aligned with the southeast (flank) wall of 2, Whitelands Avenue to its northwest limit but excluding, between Nos. 95 and 129 on its southwest side and 108 and 136 on the northeast side, those parts of vehicular footway crossings that lie between the back edge of the footway and the highway boundary and providing that such vehicular footway crossings are authorised by the County Council for use as a vehicular footway crossing and that the limit of the exclusion has been marked with single white broken line 50mm wide with 600mm long lines spaced with 600mm long gaps.
