

**THE THREE RIVERS (VARIOUS ROADS, CHORLEYWOOD OUTER AREA) (PARKING PLACES) ORDER 2006 (AMENDMENT No. 2) (VARIOUS ROADS INCLUDING WHITELANDS AVENUE) ORDER 2013**

The Three Rivers District Council ("the Council"), pursuant to arrangements made under Section 19 of the Local Government Act 2000 and the Local Government (Arrangements for Discharge of Functions) (England) Regulations 2000 with the Hertfordshire County Council, and in exercise of the powers conferred on that County Council under Sections 1, 2, 3, 4, 32, 35, 45, 46, 47, 49 and 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act of 1984") and of all other enabling powers, and after consulting with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

1. This Order may be cited as The Three Rivers (Various Roads, Chorleywood Outer Area) (Parking Places) Order 2006 (Amendment No. 2) (Various Roads Including Whiteland Avenue) Order 2013 [this order] and shall amend the Three Rivers (Various Roads, Chorleywood Outer Area) (Parking Places) Order 2006 [the order of 2006] and shall come into operation on **13<sup>th</sup> May 2013**.
2. The order of 2006 shall have effect as though:
  - a) .... Schedule 2A of this order were added to that order.
  - b) ....at Schedule 5 of that order there were added the rows at Schedule 5 of this order.
  - c) ....at Schedule 6 of that order there were added the rows at Schedule 6 of this order.
3. The Three Rivers (Various Roads, Chorleywood Central Area) (Parking Places) (Amendment No. 1) Order 2003 shall have effect as though the item referring to Blacketts Wood Drive at Schedule 2 of that Order were omitted.
4. The restrictions imposed by this Order shall be in addition to, and not in derogation of, any restriction or requirement imposed by any regulation made or having effect as if made under the Act of 1984 or by or under any other enactment.

**Schedule 2A: Unmarked Resident Permit Parking Places Monday to Friday 11am to 12 noon, Except Bank Holidays, in the following roads:**

Permit Area	Road	Parts of road
OW	Beechwood Avenue	Its whole length
OW	Blacketts Wood Drive	From its junction with Whitelands Avenue to a line drawn between the west boundaries of Nos. 32 and 39, Blacketts Wood Drive.
OW	Brushwood Drive	From its junction with Whitelands Avenue to a line drawn between the southwest boundaries of Nos. 13 and 14, Beechwood Avenue.
OW	Carpenters Wood Drive	From its junction with Whitelands Avenue to a line drawn at right angles to the kerblines from the southern corner of the land appurtenant to No. 64, Carpenters Wood Drive.
OW	Whitelands Avenue	From a line drawn at right angles to the kerblines from the southeast boundary of No. 2, Whitelands Avenue to its northwest end.
