## THE THREE RIVERS (VARIOUS ROADS, CHORLEYWOOD OUTER AREA) (PARKING PLACES) ORDER 2006 (AMENDMENT No. 3) (BLACKETTS WOOD DRIVE and BRUSHWOOD DRIVE) ORDER 2014

The Three Rivers District Council ("the Council"), pursuant to arrangements made under Section 19 of the Local Government Act 2000 and the Local Government (Arrangements for Discharge of Functions) (England) Regulations 2000 with the Hertfordshire County Council, and in exercise of the powers conferred on that County Council under Sections 1, 2, 3, 4, 32, 35, 45, 46, 47, 49 and 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act of 1984") and of all other enabling powers, and after consulting with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

- This Order may be cited as The Three Rivers (Various Roads, Chorleywood Outer Area) (Parking Places) Order 2006 (Amendment No. 3) (Blacketts Wood Drive and Brushwood Drive) Order 2014 [this order] and shall amend the Three Rivers (Various Roads, Chorleywood Outer Area) (Parking Places) Order 2006 [the order of 2006] and shall come into operation on 24 March 2014.
- 2. The order of 2006 shall have effect as though:
  - a) .... Schedule 1A of that order were substituted by schedule 1A of this order.
  - b) ....at Schedule 5 of that order there were substituted for the rows referring to Blacketts Wood Drive and Brushwood Drive the rows at Schedule 5 of this order referring to Blacketts Wood Drive and Brushwood Drive.
- The restrictions imposed by this Order shall be in addition to, and not in derogation of, any restriction or requirement imposed by any regulation made or having effect as if made under the Act of 1984 or by or under any other enactment.
