

**THREE RIVERS DISTRICT COUNCIL****TRAFFIC REGULATION ORDER****2015 No. 3****THE THREE RIVERS (RESTRICTION OF WAITING, VARIOUS ROADS) ORDER  
2015**

The Three Rivers District Council (hereinafter referred to as "the Council"), pursuant to arrangements made under Section 19 of the Local Government Act 2000 and the Local Government (Arrangements for Discharge of Functions) (England) Regulations 2000 with the Hertfordshire County Council, and in exercise of the powers conferred on that County Council under Sections 1, 2 and 3 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act of 1984") and of all other enabling powers, and after consulting with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

**Commencement and citation**

1. This Order may be cited as The Three Rivers (Restriction of Waiting, Various Roads) Order 2015 (hereinafter referred to as "this Order") and shall come into operation on 30 March 2015.
2.
  - (1) In this Order, except where the context otherwise requires, the following expressions have the meaning hereby respectively assigned to them:
 

"civil enforcement officer" shall have the same meaning as in section 76 of the Traffic Management Act 2004, where the local authority referred to therein is Three Rivers District Council;

"Council" means Three Rivers District Council and includes any parking services contractors or authorised agent appointed by and acting on behalf of the Council for the purposes of any function under the provisions of this Order;

"disabled parking disc" means a device which:

    - (a) is coloured blue;
    - (b) has been issued by a local authority and has not ceased to be valid;

and

    - (c) is capable of showing the quarter hour period during which a period of waiting has begun.

"disabled person's badge" means a badge which was-

    - (a) issued, or has effect as if issued, to a disabled person or an institution under the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000 or under regulations having effect in Scotland or Wales under section 21 of the Chronically Sick and Disabled Persons Act 1970; and
    - (b) has not ceased to be in force;

as defined in The Local Authorities' Traffic Orders (Exemption for Disabled Persons) (England) Regulations 2000;

"disabled person's vehicle" means a vehicle lawfully displaying a disabled persons badge, as defined under Section 142 of the Act;

"driver", in relation to a vehicle waiting in a parking place, or restricted waiting area, or street or part of a street specified in this Order, means the person in charge of the vehicle at the same time it was left in the parking place or restricted waiting area or street or part of a street aforesaid;

"enactment" means any enactment, whether public general or local, and includes any order, byelaw, rule, regulation, scheme or other instrument having effect by virtue of an enactment;

"goods" includes all chattels personal, whether animate or inanimate, including postal packets of any description, other than things in action and money, and "delivery and collection", in relation to any goods, includes checking the goods for the purpose of their delivery or collection;

"owner", in relation to a vehicle, means the person named in the vehicle registration document or the person by whom such vehicle is kept and used;

"penalty charge" has the same meaning as in Section 82(1) of the Road Traffic Act 1991;

"postal packet" means a letter, parcel, packet or other article transmissible by post as defined in Section 125 of the Postal Services Act 2000;

"relevant position" in relation to a parking ticket means the ticket is exhibited on the dashboard or facia or windscreen of the vehicle, so that the front of the ticket is clearly legible from the outside of the vehicle at all times;

"telecommunication apparatus" has the same meaning as in Section 4 of the Telecommunications Act 1984;

"the Act of 1984" means the Road Traffic Regulation Act 1984;

"universal service" has the same meaning as in the Postal Services Act 2000;

"universal service provider" has the same meaning as in the Postal Services Act 2000;

"vehicle" means a motor vehicle and "motor vehicle" has the same meaning as in section 136 of the Act;

- (2) For the purposes of this Order a vehicle shall be regarded as displaying a disabled person's badge in the relevant position when it is so regarded for the purposes of Regulation 4 of The Local Authorities Traffic Orders (Exemption for Disabled Persons)(England) Regulations 2000.

**Restriction of waiting**

3.

- (1) Save as provided in Article 4 of this Order, no person shall, except upon the direction or with the permission of a Police Constable in uniform or with the permission of a Civil Enforcement Officer appointed by the Council, cause or permit any vehicle to wait on any length of road referred to in Schedule 1 at any time.
- (2) Save as provided in Article 4 of this Order, no person shall cause or permit any vehicle to wait on the sides of roads or in the lengths of roads referred to in Schedule 2 at the times and on the days specified in that Schedule.

**Exemptions from the provisions of this order**

4.

- (1) It shall not contravene Article 3 of this Order to cause or permit any vehicle to wait in the parts of the road referred to therein for so long as may reasonably be necessary to enable:
  - (a) goods to be loaded on or unloaded from the vehicle;
  - (b) a person to board or alight from the vehicle;
  - (c) the vehicle if it cannot conveniently be used for such purpose in any other position to be used in the service of a local authority or local water authority in pursuance of statutory powers or duties;
  - (d) the vehicle to be used for fire brigade, ambulance or police purposes;
  - (e) the vehicle to be used by a universal service provider in the course of provision of a universal service for the purpose of delivering or collecting postal packets; or
  - (f) the vehicle, if it cannot conveniently be used for such purpose in any other position, to be used in connection with:
    - (i) building, industrial or demolition operations;
    - (ii) the removal of any obstructions to traffic;
    - (iii) the maintenance, improvement or reconstruction of the highway; or
    - (iv) the laying, erection, alteration, repair, cleaning or maintenance of any sewer or of any main pipe or apparatus for the supply of gas, water or electricity, or of any telecommunications code system or any other telecommunications apparatus lawfully kept installed in any position.
- (2) It shall not contravene any of the Articles of this Order to cause or permit a vehicle to wait in any part of the road if the vehicle is prevented from proceeding by circumstances beyond the driver's control or if the driver of the vehicle has stopped the vehicle in order to avoid or prevent injury to persons or damage to property or is required to do so by law.
- (3) Nothing in Article 4 of this Order shall render it unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a disabled person's badge and a parking disc, to wait at any time in the lengths of road specified in Schedule 1 of this Order for a period not exceeding 3 hours (not being a period separated by an interval of less than 1 hour from a previous period of waiting by the same vehicle in the same length of road).
- (4) Nothing in Article 4 of this Order shall render it unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a disabled person's badge and a parking disc, to wait at any time in the lengths of road specified in Schedule 2 of this Order.

- (5) Nothing in Article 3 of this Order shall apply to anything done at the direction or with the permission of a Civil Enforcement Officer or Police Constable in uniform.

### Revocations

5. The provisions of the following Order are hereby revoked but only in so far as it is affected by this Order:
- The Three Rivers District Council (Waiting Restrictions) (Various Locations Including Valley Road) Order 2011
6. The provisions of the following Order are hereby revoked but only in so far as it is affected by The Three Rivers (Eastbury Avenue, Northwood)(Waiting Restrictions) Order 2014:
- The Hertfordshire (Various Roads, Watford Rural) (Waiting Restrictions) (Consolidation) Order 2001

### Schedule 1: No waiting at any time

Item no.	Street name	Side of street	Location
1	Bourne End Road, Northwood	Both	From its junction with Westbury Road south-eastwards for a distance of 10 metres.
2	High Close, Rickmansworth	Both	From its junction with The Drive northwards for a distance of 10 metres.
3	Uxbridge Road Service Road leading to Long Lane, Chorleywood	North	From a point eight metres south-west of its junction with Uxbridge Road north-eastwards for its entire length.
4	Uxbridge Road Service Road leading to Long Lane, Chorleywood	South	From a point fifteen metres south-west of its junction with Uxbridge Road north-eastwards for its entire length.
5	Spencer Walk, Rickmansworth	Both	From its junction with The Drive northwards for a distance of 10 metres.
6	Spencer Walk, Rickmansworth	Both	From a point 58 metres north of its junction with The Drive northwards and westwards to a point 13 metres east of the mutual property boundary of no.s 1 and 3 Spencer Walk.


<b>Item no.</b>	<b>Street name</b>	<b>Side of street</b>	<b>Location</b>
7	The Drive, Rickmansworth	North	From a point 10 metres south-east of its junction with Spencer Walk north-westwards to a point 10 metres north-west of that junction.
8	The Drive, Rickmansworth	North	From a point 10 metres east of its junction with High Close westwards to a point 10 metres west of that junction.
9	The Drive, Rickmansworth	Both	From a point 10 metres south-east of its junction with The Climb north-westwards to a point 10 metres north-west of that junction.
10	The Climb, Rickmansworth	Both	From its junction with The Drive southwards for a distance of 15 metres.
11	Uxbridge Road, Chorleywood (A412)	Both	From a point 15 metres south-west of its north-eastern junction with Long Lane, north-eastwards to a point 15 metres north east of its junction with The Willows.
12	Westbury Road, Northwood	Both	From the eastern face of the viaduct (between the junctions of Westbury Road with South Approach and with Bourne End Road) eastwards and north eastwards to a point 10 metres north-east of its junction with Bourne End Road.

2	The Drive, Rickmansworth	South	From a point 10 metres west of its junction with High Close westwards and north-westwards to a point 10 metres south-east of its junction with The Climb.	Monday to Friday	9-10 am
