**THE THREE RIVERS (RICKMANSWORTH) (CONTROLLED PARKING ZONES) ORDER
2006 (AMENDMENT No. 6) ORDER 2015**

The Three Rivers District Council ("the Council"), pursuant to arrangements made under Section 19 of the Local Government Act 2000 and the Local Government (Arrangements for Discharge of Functions) (England) Regulations 2000 with the Hertfordshire County Council, and in exercise of the powers conferred on that County Council under Sections 1, 2, 3, 4, 32, 35, 45, 46, 47, 49 and 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act of 1984") and of all other enabling powers, and after consulting with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

1. This Order may be cited as The Three Rivers (Rickmansworth) (Controlled Parking Zones) Order 2006 (Amendment No. 6) Order 2015 (hereinafter referred to as "this Order") and shall amend:

The Hertfordshire (Various Roads, Central Area, Chorleywood)(Parking Places) Order 2001 (hereinafter referred to as "the order of 2001");

The Three Rivers (Rickmansworth) (Controlled Parking Zones) Order 2006 (hereinafter referred to as "the order of 2006");

The Three Rivers (Various Roads, Chorleywood Outer Area)(Parking Places) Order 2006 (hereinafter referred to as "the second order of 2006");

The Three Rivers (Winton Drive, Springfield Close, Girton Way and Winton Approach, Croxley Green) (Parking and Waiting Restrictions) Order 2006 (hereinafter referred to as "the third order of 2006"); and

The Three Rivers (Rickmansworth)(Controlled Parking Zones) Order 2006 (Amendment No. 4) Order 2012 (hereinafter referred to as "the amendment order of 2012")

and shall come into operation on 30 March 2015.

2. The order of 2001 shall have effect as though paragraph (2) of Article 6 of that order were omitted.
3. The order of 2006 shall have effect as though paragraph (2) of Article 14 of that order were omitted.
4. The order of 2006 shall have effect as though every reference in that order to "Schedules 4 and 5" were a reference to "Schedules 4, 5, 22 and 23".
5. The order of 2006 and the amendment order of 2012 shall have effect as though every reference contained in or introduced by the amendment order of 2012 to "Schedule 22" were to read "Schedule 24".

6. The order of 2006 is hereby revoked in so far as it refers to the following lengths of road in the schedule indicated:

Schedule 8 – Short Stay Parking (up to 2 hours), Monday to Saturday 8.30am to 6.30pm, Except Bank Holidays

7. There shall be inserted into the order of 2006 the following items within the schedules indicated:

Schedule 8 – Short Stay Parking (up to 2 hours), Monday to Saturday 8.30am to 6.30pm, Except Bank Holidays

Northway	North	From a point 15 metres east of its junction with Station Road eastwards for a distance of 65 metres

Schedule 17 – Parking Bays for Disabled Badge Holders Only At Any time

Northway	North	From a point 80 metres east of its junction with Station Road eastwards for a distance of 7 metres

Schedule 18: Addresses within Parking Zones

Resident Permit Zone A

Rectory Road (Southern and eastern side of street, excepting no.s 1, 1A, 3, 3A, 5, 5A, 7 and 7A)

Resident Permit Zone A1

Rectory Road (No.s 1, 1A, 3, 3A, 5, 5A, 7 and 7A)

Resident Permit Zone B

Rectory Road (Northern and western side of street)

8. The second order of 2006 shall have effect as though paragraph (2) of Article 9 of that order were omitted.
9. The third Order of 2006 shall have effect as though paragraph (1) of Article 9 of that order were omitted.
10. There shall be inserted into the third order of 2006 the following paragraph after paragraph (2) of Article 44:
(3) Nothing in this Order shall render it unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a disabled person's

badge and a parking disc, to wait at any time in the lengths of road specified in Schedule 3 of this Order for a period not exceeding 3 hours (not being a period separated by an interval of less than 1 hour from a previous period of waiting by the same vehicle in the same length of road).

11. The restrictions imposed by this Order shall be in addition to, and not in derogation of, any restriction or requirement imposed by any regulation made or having effect as if made under the Act of 1984 or by or under any other enactment.
