

THE COUNTY COUNCIL OF KENT (CORK STREET AND VARNES STREET, ECCLES, AYLESFORD) (PROHIBITION OF WAITING) ORDER, 1968

The County Council of the Administrative County of Kent in exercise of their powers under subsections (1), (2) and (3) of Section 1 and subsection (4) of Section 2 of the Road Traffic Regulation Act 1967, and of all other powers enabling them in that behalf hereby make the following Order:-

1. Save as provided in Article 2 of this Order no person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle to wait on Mondays to Saturdays, inclusive, in either of the parts of road specified in the Schedule to this Order.
2. Nothing in Article 1 of this Order shall prevent any person from causing or permitting a vehicle to wait in either of the parts of road referred to in that Article for so long as may be necessary:-
 - (a) to enable a person to board or alight from the vehicle;
 - (b) to enable goods to be loaded on to or unloaded from the vehicle;
 - (c) to enable the vehicle, if it cannot conveniently be used for such purpose elsewhere, to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the carrying out of any roadworks or the laying, erection, alteration or repair of any sewer or of any main, pipe or apparatus, for the supply of gas, water or electricity, or of any telegraph or telephone wires, cables, posts or supports; or
 - (d) if either (i) the person driving the vehicle is in possession of a disabled driver's badge issued by a local Health and Welfare Authority, or (ii) the vehicle being driven by that person is an invalid vehicle which has been issued to that person by the Ministry of Health.
3. The restrictions imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any regulations made or having effect as if made under the Road Traffic Regulation Act 1967, or by or under any other enactment.
4. The Interpretation Act, 1889, shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
5. This Order shall come into operation on the **Thirty-first** day of **July** 1968, and may be cited as "The County Council of Kent (Cork Street and Varnes Street, Eccles, Aylesford) (Prohibition of Waiting) Order, 1968".

SCHEDULE

PARTS OF ROAD IN THE PARISH OF AYLESFORD

(1) Station Road

- (a) on the north side between a point 30 yards west and a point 30 yards east of the centre of its junction with Mill Hall;
- (b) on the south side between a point 30 yards west and a point 53 yards east of the centre of its junction with Teapot Lane.

(2) Teapot Lane from its junction with Station Road for a distance of 15 yards in a southerly direction.

SCHEDULE

PARTS OF ROAD AT ECCLES IN THE PARISH OF AYLESFORD

- (1) Cork Street from its junction with Bull Lane for a distance of 90 yards in a north-westerly direction to a point 10 yards north-west of the north-western side of its junction with Varnes Street.
- (2) Varnes Street from its junction with Cork Street for a distance of 15 yards in a north-easterly direction.
