THE KENT COUNTY COUNCIL (VARIOUS ROADS, BIRLING)
(PROHIBITION OF WAITING) ORDER 1975

The Kent County Council in exercise of their powers under Section 1(1), (2) and (3) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968 and by Schedule 19 to the Local Government Act 1972 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Section 84C(1) of the said Act of 1967, hereby make the following Order:-

1. Save as provided in Articles 2 and 3 of this Order no person shall, except upon the direction or with the permission of a police constable in uniform or a traffic warden, cause or permit any vehicle to wait in any of the parts of the road specified in the Schedule to this Order.
2. Nothing in Article 1 of this Order shall prevent any person from causing or permitting a vehicle to wait in any of the parts of road specified in that Article for so long as may be necessary:-
 - (a) to enable a person to board or alight from the vehicle;
 - (b) to enable goods to be loaded on to or unloaded from the vehicle; or
 - (c) to enable the vehicle, if it cannot conveniently be used for such purposes elsewhere, to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the carrying out of any roadworks or the laying, erection, alteration or repair of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity, or of any telegraph wires, cables, posts or supports.
3. Nothing in Article 1 of this Order shall apply to any vehicle which is either displaying a disabled person's car badge issued by a local authority or is an invalid vehicle which has been issued to the driver thereof by the Department of Health and Social Security, provided that, except upon the direction or with the permission of a police constable in uniform or of a traffic warden, no person shall cause any such vehicle to wait in any of the parts of road referred to in that Article (i) for a longer period than 2 hours, or (ii) if a period of less than 1 hour has elapsed since the termination of the last period of waiting (if any) of that vehicle in that part of road during the hours of operation of the restrictions imposed by this Order as specified in the aforesaid Article 1.
4. The restrictions imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any regulations made or having effect as if made under the said Act of 1967, or by or under any other enactment.
5. The Interpretation Act 1889 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
6. This Order shall come into operation on the thirteenth day of August 1975, and may be cited as "The Kent County Council (Various Roads, Birling) (Prohibition of Waiting) Order 1975".

SCHEDULE

PARTS OF ROAD IN THE PARISH OF BIRLING

1. Apple Close from the centre of its junction with Malling Road in an easterly direction for a distance of 11 yards.
2. Brook Lane from the centre of its junction with Malling Road in an easterly direction to a point in line with the eastern wall of the Freemasons Arms public house.
3. Malling Road (A. 228) from a point 46 yards north of the centre of its junction with Simpson Road for a distance of 417 yards in a southerly direction.
4. Simpson Road from the centre of its junction with Malling Road in an easterly direction for a distance of 33 yards.
