

THE KENT COUNTY COUNCIL (VARIOUS ROADS, BOROUGH GREEN)

(PROHIBITION OF WAITING ORDER) 1994

The Kent County Council in exercise of its powers under Sections 1, 2 and 124 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the said Act of 1984, hereby makes the following Order:-

1. "The Kent County Council (Various Roads, Borough Green) (Prohibition of Waiting) Order 1991" is hereby revoked.
2. Save as provided in Articles 3 and 4 of this Order no person shall, except upon the direction or with the permission of a Police Constable in uniform or of a Traffic Warden cause or permit any vehicle to wait:-
 - (a) in any of the lengths of road specified in the First Schedule to this Order;
 - (b) between the hours of 8.30am and 6.30pm on Mondays to Saturdays inclusive in any of the lengths of road specified in the Second Schedule to this Order; and
 - (c) between the hours of 8.30am and 6.30pm on Mondays to Saturdays inclusive of any of the lengths of road specified in the Third Schedule to this Order;
 - (i) for a longer period than two hours; or
 - (ii) if a period of less than one hour has elapsed since the termination during the said hours of the last period of waiting (if any) of that vehicle in that length of road;
3. Nothing in Article 2 of this Order shall prevent any person from causing or permitting a vehicle to wait in any of the lengths of road referred to in that Article for so long as may be necessary:-
 - (a) to enable a person to board or alight from the vehicle;
 - (b) to enable goods to be loaded onto or unloaded from the vehicle;
 - (c) to enable the vehicle, if it cannot conveniently be used for such purpose elsewhere, to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the carrying out of any roadworks or the laying, erection, and alteration or repair of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity, or of any telegraph or telephone wires, cables, posts or supports; or
 - (d) to enable the vehicle to be used for Police, Ambulance or Fire Brigade purposes.

FIRST SCHEDULE

(No Waiting at any time)

Lengths of Road in the Parish of Borough Green

1. High Street:

- a) on the north-west side from the centre of its junction with Western road, in a south-westerly direction to its junction with Sevenoaks Road;
- b) on the south-east side from the north-eastern side of the junction with Sevenoaks Road, for a distance of 42 metres in a north-easterly direction;
- c) on the south-east side, between points 16 metres north-east and 31 metres south-west of the centre of its junction with the entrance to the Village Hall car park;
- d) on the south-east side from a point 14 metres south-west of the centre of its junction with Western Road for a distance of 55 metres in a north-easterly direction, to its junction with Station Road.

2. Hillview Road:

- a) on the east side from the northern side of its junction with Maidstone Road, for a distance of 23 metres in a northerly direction;
- b) on the west side between points 11 and 23 metres north of the northern side of its junction with Maidstone Road;

3. Western Road (A227):

- a) on the north side from the centre of its junction with High Street, in a westerly direction, for a distance of 16 metres;
- b) on the north side from the centre of its junction with Sevenoaks Road, in an easterly direction for a distance of 17 metres;
- c) on the north side from a point in line with the east wall of the Fire Station, in a westerly direction for a distance of 22 metres;
- d) on the south side from the centre of its junction with Sevenoaks Road in an easterly direction for a distance of 69 metres;
- e) on the south side from a point in line with the east wall of no 57 Western Road, in an easterly direction for a distance of 30 metres;
- f) on the south side between points 16 metres east and 16 metres west of the centre of the entrance to the public car park;
- g) on the south side from the centre of its junction with High Street in a westerly direction for a distance of 73 metres.

4.) Quarry Hill:

- a) On the north-west side from the southern side of its junction with Sevenoaks Road, in a south-westerly direction to the centre of its junction with Rock Road;

SECOND SCHEDULE

(Waiting prohibited from 8.30am to 6.30pm
on Mondays to Saturdays)

Lengths of Road in the Parish of Borough Green

1. Western Road - on the north side from a point 16 metres west of the centre of its junction with High Street to a point in line with the east wall of the Fire Station.
2. Station Road - from a point in line with the south wall of No 5 Kent Villas in a southerly direction to a point in line with the south side of the steps in front of No 7 Spencer Cottages.
