ROAD TRAFFIC REGULATION ACT 1984 - SECTIONS 1, 2 AND 124

THE KENT COUNTY COUNCIL (VARIOUS ROADS, SNODLAND)
(ONE-WAY AND PROHIBITION OF WAITING ORDER), 1993

The Kent County Council, in exercise of its powers under Sections 1, 2 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the said Act of 1984, hereby makes the following Order:-

1. "The Kent County Council (Various Roads, Birling) (Prohibition of Waiting) Order 1975" as having effect by virtue of Section 144(1) of and paragraph 3 of Schedule 10 to the Road Traffic Regulation Act 1984 and "The Kent County Council (Various Roads, Snodland) (One-Way and Prohibition of Waiting) Order 1990" are hereby revoked.

2. Save as provided in Articles 3 and 4 of this Order no person shall, except upon the direction or with the permission of a Police Constable in uniform or of a Traffic Warden, cause or permit any vehicle to proceed in any of the lengths of road specified in the First Column of the First Schedule to this Order otherwise than in the direction specified opposite to that length in the second column of the said Schedule.

3. Nothing in Article 2 of this Order shall apply to a handcart which is being used for the conveyance of postal packets in that part of High Street, Snodland, which extends between its junction with Queen's Avenue and the Post Office.

4. Save as provided in Articles 5 and 6 of this Order no person shall, except on the direction or with the permission of a Police Constable in uniform or of a Traffic Warden, cause or permit any vehicle to wait:-

- (a) in any of the lengths of road specified in the Second Schedule to this Order;
- (b) between the hours of 8.30 am and 6.30 pm on Mondays to Saturdays inclusive in any of the lengths of road specified in the Third Schedule to this Order;
- (c) between the hours of 8.30 am and 6.30 pm on Mondays to Saturdays inclusive of any of the lengths of road specified in the Fourth Schedule to this Order:-
 - (i) for a longer period than thirty minutes; or
 - (ii) if a period of less than thirty minutes has elapsed since the termination during the said hours of the last period of waiting (if any) of that vehicle in that length of road;
- (d) between the hours of 8.30 am and 6.30 pm on Mondays to Saturdays inclusive in the length of road specified in the Fifth Schedule to this Order:-
 - (i) for a longer period than one hour; or
 - (ii) if a period of less than one hour has elapsed since the termination during the said hours of the last period of waiting (if any) of that vehicle in that length of road.

5. Nothing in Article 4 of this Order shall prevent any person from causing or permitting a vehicle to wait in any of the lengths of road referred to in that Article for so long as may be necessary:-

- (a) to enable a person to board or alight from the vehicle;
- (b) to enable goods to be loaded onto or unloaded from the vehicle;
- (c) to enable the vehicle, if it cannot be conveniently used for such purpose elsewhere, to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the carrying out of any roadworks or the laying, erection and alteration or repair of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity, or of any telegraph or telephone wires, cables, posts or supports; or
- (d) to enable the vehicle to be used for Police, Ambulance or Fire Brigade purposes.

6 (1) Nothing in Article 4 of this Order shall render it unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a disabled person's badge, and a parking disc (on which the driver, or other person in charge of the vehicle, has marked the time at which the period of waiting began) to wait in any of the lengths of road referred to in the Second or Third Schedules to this Order for a period not exceeding 3 hours (not being a period separated by an interval or less than 1 hour from a previous period of waiting by the same vehicle in the same length of road).

(2) Nothing in Article 4 of this Order shall render it unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a disabled person's badge to wait in any of the lengths of road specified in the Fourth and Fifth Schedules to this Order.

7. The restrictions imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any regulations made or having effect as if made under the said Act of 1984, or by or under any other enactment.

8. In this Order:-

"disabled person's vehicle" has the same meaning as in the Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England and Wales) (Amendment) Regulations 1991;

"disabled person's badge" has the same meaning as in the Disabled Persons (Badges for Motor Vehicles) (Amendment) Regulations 1991;

"parking disc" means a disc, issued by a local authority, 125mm in diameter, coloured orange, and capable of showing the quarter hour period during which a period of waiting begins; and

"relevant position" means:-

- (i) in the case of a vehicle fitted with a dashboard or facia panel, the badge is exhibited thereon so that Part I of the badge is legible from outside the vehicle; or
- (ii) in the case of a vehicle not fitted with a dashboard or facia panel, the badge is exhibited in a conspicuous position on the vehicle so that Part I of the badge is legible from outside the vehicle.

9. This Order shall come into operation on the Twenty-Ninth day of January 1993 and may be cited as "The Kent County Council (Various Roads, Snodland) (One-Way and Prohibition of Waiting) Order 1993."

FIRST SCHEDULE

(One-Way Streets)

| <u>Lengths of Road in the Parish of Snodland</u> | <u>Direction</u> |
|---|------------------|
| 1 High Street, from its junction with Holborough Road and Malling Road to its junction with Queen's Avenue. | West to East |
| 2 Queen's Avenue, from its junction with High Street to the Public Baths. | South to North |
| 3 Queen's Avenue, from the Public Baths to the junction with Holborough Road. | East to West |

SECOND SCHEDULE

(Waiting Prohibited at All Times)

Lengths of Road in the Parish of Snodland

- 1 Birling Road:
 - (a) on the north and west sides from a point in line with the party wall of numbers 72 and 74 Birling Road to a point in line with the northern boundary of number 38 Birling Road;
 - (b) on the east side from its junction with Constitution Hill to its junction with Charles Close;
 - (c) on the west side from its junction with Constitution Hill in a southerly direction to a point in line with the northern boundary of number 8 Birling Road.
- 2 Bramley Road, from its junction with Malling Road for a distance of 14 metres in a westerly direction.
- 3 Church Field, on the east side from the centre of the junction with Mill Street in a northerly direction for a distance of 26 metres.
- 4 Constitution Hill:
 - (a) on the south side from a point 10 metres east of the eastern boundary of number 1 Constitution Hill in a westerly direction to a point in line with the party wall on numbers 48 and 50 Constitution Hill;
 - (b) on the north side from the eastern boundary wall of number 2 Constitution Hill to the party wall of numbers 6 and 8 Constitution Hill.
- 5 High Street:
 - (a) on the north side from a point 5 metres east of the centre of its junction with Waghorn Road in an easterly direction to a point 21 metres east of the east wall of number 73 High Street;

- (b) on the south side between points 5 and 21 metres east of the east wall of number 73 High Street;
 - (c) on the north side from its junction with Holborough Road for a distance of 92 metres in a westerly direction.
- 6 Holborough Road:
- (a) on the west side from its junction with High Street to a point 15 metres north of the centre of its junction with Lee Road;
 - (b) on the east side from its junction with Ostlers Court for a distance of 6 metres in a northerly direction; and
 - (c) on the east side from its junction with Ostlers Court for a distance of 6 metres in a southerly direction.
- 7 Lee Road, from the west side of its junction with Holborough Road for a distance of 18 metres in a westerly direction.
- 8 Malling Road:
- (a) on the east side from a point in line with the party wall of numbers 39 and 41 Malling Road in a southerly direction to a point in line with the party wall of numbers 51 and 53 Malling Road;
 - (b) on the west side from its junction with High Street to the north side of its junction with St Katharine's Lane;
 - (c) on the east side from the north flank wall of the Salvation Army Hall to the party wall of numbers 117/119 Malling Road for a distance of 38 metres in a southerly direction.
- 9 Rocfort Road:
- (a) from the centre of its junction with Malling Road for a distance of 26 metres in an easterly direction;
 - (b) on the north side from the centre of its junction with the unnamed road leading to the public car park for a distance of 23 metres in a westerly direction.
- 10 Stevens Close, on the east side from its junction with High Street in a northerly direction for a distance of 25 metres.
- 11 Ostlers Court:
- (a) on the south side from its junction with Holborough Road for a distance of 10 metres in an easterly direction; and
 - (b) on the north side from its junction with Holborough Road for a distance of 10 metres in an easterly direction.
- 12 Apple Close, both sides, from the centre of its junction with Malling Road in an easterly direction to the party wall of numbers 2 and 4 Apple Close.
- 13 Brook Lane, both sides, from the centre of its junction with Malling Road in an easterly direction to a point in line with the eastern wall of the Freemasons Arms public house.

- 14 Malling Road, both sides, from a point 43 metres north of the centre of its junction with Simpson Road for a distance of 382 metres in a southerly, direction.
- 15 Simpson Road, from the centre of its junction with Malling Road in an easterly direction for a distance of 31 metres.

THIRD SCHEDULE

(Waiting Prohibited between 8.30 am and 6.30 pm on Mondays to Saturdays)

Lengths of Road in the Parish of Snodland

- 1 High Street:
 - (a) on the north side from its junction with Holborough Road to a point 12 metres east of the east side of that junction;
 - (b) on the north side from a point 55 metres east of the east side of its junction with Holborough Road to a point 16 metres east of the centre of its junction with Queen's Avenue;
 - (c) on the north side from a point in line with the eastern boundary of number 59 High Street to a point 5 metres east of the centre of its junction with Waghorn Road;
 - (d) on the south side from a point 16 metres west of the west side of its junction with Malling Road to a point in line with the party wall of numbers 63 and 65 High Street.
- 2 Holborough Road:
 - (a) on the east side from the north side of its junction with High Street in a northerly direction to a point 6 metres south of its junction with Ostlers Court.
 - (b) on the east side from a point 15 metres north of the centre of its junction with Queen's Avenue to a point opposite the party wall of numbers 22 and 24 Holborough Road.
- 3 Malling Road, on the east side from its junction with High Street for a distance of 38 metres in a southerly direction.
- 4 Mill Street, on the north side between points 9 metres east and 9 metres west of the centre of the entrance to All Saints Church.
- 5 Queen's Avenue:
 - (a) on the east and north sides from its junction with High Street to its junction with Holborough Road;
 - (b) on the west side from the north side of its junction with High Street for a distance of 36 metres in a northerly direction;
 - (c) on the west and south sides from a point 25 metres north of the centre of its junction with Queen's Road in a northerly and then westerly direction for a total distance of 33 metres;

- (d) on the south side from the east side of its junction with Holborough Road for a distance of 14 metres in an easterly direction.
- 6 Queen's Road from the east side of its junction with Queen's Avenue for a distance of 18 metres in an easterly direction.

FOURTH SCHEDULE

(Waiting Limited to Thirty Minutes in any hour between 8.30 am and 6.30 pm
on Mondays to Saturdays)

Length of Road in the Parish of Snodland

High Street, on the north side from a point 12 metres east of the east side of its junction with Holborough Road for a distance of 41 metres in an easterly direction.

FIFTH SCHEDULE

Waiting Limited to One Hour in any hour between 8.30 am and 6.30 pm
on Mondays to Saturdays)

Length of Road in the Parish of Snodland

Malling Road, on the east side from a point 42.5 metres south of its junction with High Street to a point in line with the party wall of numbers 39 and 41 Malling Road.
