
THE KENT COUNTY COUNCIL (VARIOUS ROADS, TONBRIDGE)  
(VARIATION OF BOROUGH OF TONBRIDGE AND MALLING 1986 CONSOLIDATED  
TRAFFIC ORDER (VARIATION NO. 35) ORDER 1995

The Kent County Council in exercise of powers under Section 1(1), (2) and (3) and 124(1) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (as amended) (hereinafter referred to as the Act of 1984) and of all other enabling powers after consultation with the Chief Officer of the Police in accordance with Part III of Schedule 9 of the Act of 1984 hereby makes the following Order:-

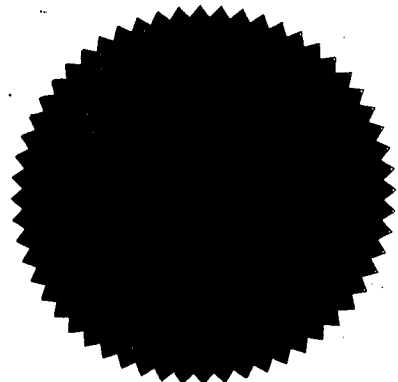
1. This Order shall come into operation on *4<sup>th</sup> March 1996* and may be cited as "The Kent County Council (Various Roads, Tonbridge) (Variation of Borough of Tonbridge and Malling 1986 Consolidated Traffic Order) (Variation No. 35)) Order 1995".
2. The Interpretation Act 1978 shall apply to the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. Except where the context otherwise admits any reference to a Schedule is a reference to a Schedule to this Order.
4. In this Order the expression "Order of 1986" means the "Borough of Tonbridge and Malling (Consolidation of Traffic Orders) (Various Roads, Tonbridge) Order 1986".
5. The Order 1986 shall have effect as though the Lengths of road specified in Schedule I to this Order were included in Schedule I thereto.
6. The Order of 1986 shall have effect as though the lengths of road specified in Schedule 2 to this Order were included in Schedule 17 thereto.
7. The Order of 1986 shall have effect as though the lengths of road specified in Schedule 3 to this Order were omitted therefrom.
8. The restrictions imposed by this Order shall be in addition to and not in derogation of any restrictions or requirements imposed by any Regulations made or having effect as if made under the Act of 1984 as amended as aforesaid or by or under any other enactments.

**SCHEDULE 1**

**Lengths of Road to be included in  
Schedule I (No Waiting at Any Time) to  
the Order of 1986**

<u>Road</u>	<u>Length of Road</u>
Hectorage Road	<p><u>South Side:</u> for a distance of 234 metres west of the junction with Lodge Oak Lane (to a point opposite 110 Hectorage Road).</p> <p><u>South Side:</u> for a distance of 28 metres east of the junction with Goldsmid Road.</p> <p><u>North Side:</u> for a distance of 28 metres east of the junction with Lodge Oak Lane.</p> <p><u>North Side:</u> from a point 214 metres west of the junction with Lodge Oak Lane for a distance of 37 metres westerly.</p> <p><u>North Side:</u> for a distance of 34 metres east of the junction with Goldsmid Road.</p>

**SCHEDULE 2**

**Lengths of Road to be included in  
Schedule 17 (No Waiting 8.00 am to 6.00 pm  
Monday to Friday) to the Order of 1986**

<u>Road</u>	<u>Length of Road</u>
Hectorage Road	<p><u>South Side:</u> from a point 28 metres east of the junction with Goldsmid Road for a distance of 105 metres easterly.</p> <p><u>South Side:</u> from a point 259 metres east of the junction with Goldsmid Road for a distance of 40 metres easterly.</p> <p><u>North Side:</u> from a point 94 metres east of the junction with Goldsmid Road for a distance of 147 metres easterly.</p> <p><u>North Side:</u> from a point 251 metres west of the junction with Lodge Oak Lane for a distance of 17.5 metres westerly.</p>

1	No Waiting at Any Time	Hectorage Road	<u>Both Sides:</u> from junction with Lodge Oak Lane to a point 20 metres west of the western boundary of 121 Hectorage Road.
1	No Waiting at Any Time	Hectorage Road	<u>North Side:</u> from junction with Goldsmid Road for a distance of 35 metres.
17	No Waiting 8.00 am to 6.00 pm Monday to Friday	Hectorage Road	<u>South Side:</u> from a point 60 metres from the junction with Goldsmid Road to a point 2.5 metres east of the boundary of 104/106 Hectorage Road.
1	No Waiting at Any Time	Hectorage Road	<u>South Side:</u> from the junction with Goldsmid Road for a distance of 60 metres.
