THE KENT COUNTY COUNCIL (VARIOUS ROADS, TONBRIDGE) (VARIATION OF BOROUGH OF TONBRIDGE AND MALLING 1986 CONSOLIDATED TRAFFIC ORDER) (VARIATION NO 38) ORDER 1996

The Kent County Council in exercise of powers under Sections 1(1), (2) and (3) and 124(1) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (as amended) (hereinafter referred to as the Act of 1984) and of all other enabling powers after consultation with the Chief Officer of the Police in accordance with Part III of Schedule 9 of the Act of 1984 hereby makes the following Order:-

- This Order shall come into operation on 4th November 1996 and may be cited as "The Kent County Council (Various Roads, Tonbridge) (Variation of Borough of Tonbridge and Malling 1986 Consolidated Traffic Order) (Variation No 38) Order 1996".
- 2. The Interpretation Act 1978 shall apply to the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 3. Except where the context otherwise admits any reference to a Schedule is a reference to a Schedule to this Order.
- 4. In this Order the expression "Order of 1986" means the "Borough of Tonbridge and Malling (Consolidation of Traffic Orders) (Various Roads, Tonbridge) Order 1986."
- 5. The Order 1986 shall have effect as though:
 - (a) the lengths of road specified in Schedule I to this Order were included in Schedule I thereto;
 - (b) the lengths of road specified in Schedule 2 to this Order were included in Schedule 10 thereto;
 - (c) the length of road specified in Schedule 3 to this Order was included in Schedule 16 thereto; and
 - (d) the lengths of road specified in Schedule 4 to this Order were omitted therefrom.
- 6. The restrictions imposed by this Order shall be in addition to and not in derogation of any restrictions or requirements imposed by any Regulations made or having effect as if made under the Act of 1984 as amended as aforesaid or by or under any other enactments.
