Tonbridge & Malling Borough Council (Off-Street Parking Places) (Consolidation) Order 2012

The Tonbridge & Malling Borough Council, in exercise of its powers under sections 32, 35 and 124 and Schedule 9 of the Road Traffic Regulation Act 1984, as amended, and Part 6 of the Traffic Management Act 2004 and of all other enabling powers, with the consent of the County Council of Kent in accordance with section 39(3) of the Act and after consulting the chief officer of police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:

1. Citation and Commencement

1.1 This Order may be cited as the *Tonbridge & Malling Borough Council (Off-Street Parking Places) (Consolidation) Order 2012*, and shall come into operation on Monday, the **13**th **February, 2012**.

2. Revocations and Consolidation

2.1 The Tonbridge & Malling Borough Council (Off-Street Parking Places) (Amendment & Consolidation) Order 2010 and the Tonbridge & Malling Borough Council (Off-Street Parking Places) (Amendment No. 1) Order 2011 are revoked. The provisions contained in those Orders are consolidated in this Order and has no other effect.

3. <u>Definitions & Interpretation</u>

3.1 In this Order, except where the context otherwise requires, the following expressions, have the meanings hereby respectively assigned to them:

| "contravention" | means any breach of the provisions herein contained; |

| "motor cycle bay" | means a parking bay marked out on the surface of the parking place, or indicated by sign(s), that is reserved for parking of solo motorcycles only; |
| "off peak season ticket" | means a ticket issued by the Council, according to the provisions of this Order, to an individual to park a vehicle in the parking places identified in the Schedule; |
| "On Street Parking Order" | means The Kent County Council (Various Roads, Tonbridge and Malling) (Waiting Restrictions and On-Street Parking Places) (Consolidation) Order 2010 or any subsequent Amendment or Consolidation of that Order; |
| "parking bay" | means any areas of a parking place which is provided for the leaving of a vehicle and indicated by markings on the surface of the parking place; |
| "parking charge" | means the charge specified in respect of a parking place in the Part (I) of the Schedule; |
| "Parking Manager" | means the officer with responsibilities for managing the Parking Service on behalf of the Council; |
| "parking period" | means the period during which the vehicle is parked in the parking |

| "pay by phone" | means a method of payment whereby the parking charge specified in Part (1) of the Schedule (and any appropriate administration charge) is collected by a Council appointed third party, via an arranged account, with payment being made over the telephone or by other electronic system (including the internet) by credit or debit card or other means of secure authorised payment. This method requires contact with the Council appointed third party immediately upon parking to register the act of parking; |
| "penalty charge" | means a charge of the appropriate higher/lower level rates, set in accordance with the provisions of the Act of 2004 payable to the Council in the event of any contravention of this Order; |
| "penalty charge notice" "PCN" | means a notice attached to the vehicle, or personally served to the driver or served by post to the registered keeper in appropriate circumstances as laid down in the Act of 2004; |
| "permit" | means a permit issued by the Council to an individual to park a vehicle in the parking places(s) identified in the Schedule, with or without restrictions, but subject otherwise to the provisions of this Order; |

3.2 In the case of a disabled person's badge, this must be clearly displayed at all times in accordance with the directions/guidance issued by the Department for

- 3.3 The season tickets referred to in Article 6 (paragraphs 6.9.2 and 6.9.3) are issued at the discretion of the Parking Manager to workers in West Malling town centre, and workers in Borough Green town centre, i.e. GROUP 10 and GROUP 13 respectively of the Schedule.
- 3.4 Unless expressly stated to the contrary any reference to a specific statute includes any statutory extension or modification, amendment or re-enactment of that statute and any regulations or orders made under it, and any general reference to a statute includes regulations or orders made under that statute.
- 3.5 Reference to any order regulation or statutory instrument includes any order replacing or amending the order regulation or statutory instrument.
- 3.6 The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

4. General provisions relating to the use of parking places

- 4.1 In Part (1) of the Schedule, each area of land specified by name in Column 1 may be used, as a parking place for vehicles of the specified class, on the days, times and conditions specified in Column 2, and at a charge, if any, indicated in Column 3.
- 4.2 Unless previously agreed in writing by the Council, the driver of a vehicle shall not cause it to park in a parking place unless the vehicle is of the specified class for that parking place and parking bay.
- 4.3 Where within a parking place, there are surface markings which indicate parking bays; the driver of a vehicle shall not cause it to park otherwise than wholly within such a parking bay, specific to that class of vehicle.
- 4.4 The Council may at any time change the location or number of such parking bays within a parking place.
- 4.5 Where, within a parking place, there is a sign or surface marking which indicates that a parking bay is available only for a disabled person's vehicle, the driver of a vehicle shall not cause it to park in that parking bay unless it displays a current 'disabled person's badge' in accordance with the provisions of the Regulations of 2000 and the registered disabled person is either the driver or a passenger in the vehicle. The driver of a vehicle displaying a current 'disabled person's badge' in accordance with the provisions of the Regulations of 2000 may park the vehicle, free of charge in a parking place provided that the period of stay does not exceed the maximum stay for that parking place. A driver displaying a current 'disabled person's' valid badge may also park in a normal bay under the same conditions.
- 4.6 The driver of a vehicle shall not cause or allow that vehicle to remain in the parking place for longer than the maximum period of time indicated on the relevant parking place notice.
- 4.7 The driver of a vehicle shall not cause or allow that vehicle to return to the parking place within the period of time specified on the parking place notice.

5. Suspension of use of parking places

- 5.1 Notwithstanding any other provision of this Order, the Council may close a parking place, or any part of a parking place, for such period as it considers appropriate.
- 5.2 The driver of a vehicle shall not leave the vehicle in a parking place at any time when it is closed in accordance with the provisions of paragraph 5.1 of this Article.

6. Authority to park and conditions of use

- 6.1 Except as otherwise provided in this Order, no vehicle shall be left in a parking place during a charging period unless the driver has first obtained one of the following: p & d ticket, t & d ticket, season ticket (including off peak season tickets), preferential permit or permit and displayed it in the relevant position, or made use of the pay by phone option.
- 6.2 Whenever a vehicle occupies any of the parking places specified in Part (1) of the Schedule and is required to display one of the following: p & d ticket, t & d ticket, season ticket (including off peak season tickets), preferential permit or permit it must be done in a manner so that the expiry time or date, or any other condition of parking is clearly visible at all times.
- 6.3 Whenever the pay by phone option is used it is the driver's responsibility to ensure that their period of stay has been recorded with the relevant company. This registration is not transferable and a fresh notification is required if the vehicle is moved to a different parking place.
- 6.4 Unless otherwise directed, a p & d ticket shall only be valid for use in a parking place in which it was purchased or in any other parking place within the same charge group within column 1 of Part (1) of the Schedule.
- 6.5 Additional p & d tickets may be purchased to allow the vehicle to remain up to the maximum period of stay.
- 6.6 T & d tickets shall only be valid for use in a parking place in which it was obtained
- 6.7 P & d tickets and t & d tickets are not transferable between vehicles.
- 6.8 The registered keeper of a vehicle may, on application to the Council, purchase a season ticket which will enable a vehicle to park a) in a parking place for which season tickets are available and b) for a charge, both of which are identified in Part (1) of the Schedule.
- 6.9 Season tickets are issued subject to the provisions of this Order, and to availability, in:
 - 6.9.1 respect of the parking place or places for which it was issued,
 - 6.9.2 the case of Western Road, Borough Green Car Park, season tickets will only be issued to those working in Borough Green town centre,

- 6.9.3 the case of Ryarsh Lane, West Malling Car Park, the Car Park is reserved for season ticket holders only during the specified hours of the Schedule and they will only be issued to those working in West Malling town centre:
- 6.10 The registered keeper of a vehicle may, on application to the Council, purchase a preferential permit provided they meet the Zone R qualifications established in the Preferential Parking Scheme in the On Street Parking Order. This will allow parking in the Village Field Car Park, East Malling listed in GROUP 15, Part (1) of the Schedule.
- 6.11 The owners of the Village Field Car Park, East Malling, currently East Malling and Larkfield Parish Council, may at any time, whether on payment or otherwise, grant permission for vehicles to park in the Village Field Car Park, East Malling, listed in GROUP 15, Part (1) of the Schedule, at such times as it may consider appropriate:
 - PROVIDED that no vehicle shall be left in a parking place in reliance upon such permission, and unless a permit is displayed in a relevant position on or in the vehicle in respect of which it was issued.
- 6.12 The Council may at any time, whether on payment or otherwise, grant written permission by way of a permit for vehicles to park in such parking places and at such times as it may consider appropriate:
 - 6.12.1 Provided that a Permit Application Form (obtainable from the Council) is completed and submitted, together with the relevant authorisation(s) and any appropriate fee
 - 6.12.2 Applicants for these permits shall complete all information required by such Forms, and the Council may, at any time, before or after its issue, require an applicant to produce to an officer of the Council reasonable evidence which verifies the information provided.

PROVIDED that no vehicle shall be left in a parking place in reliance upon such permission, and unless a permit issued in accordance with such permission is fixed in the relevant position on or in the vehicle in respect of which it was issued.

- 6.12 Without prejudice to the Council's powers as set out in this Order, the Council shall have discretion not to issue preferential permits, permits or season tickets (including off-peak season ticket) to a vehicle which has three or more unpaid and unchallenged penalty charge notices issued by the Council, being those penalty charge notices where payment is lawfully due.
- 6.13 Without prejudice to the Council's powers as set out in this Order, the Council shall have discretion not to issue preferential permits, permits or season tickets (including off peak season tickets) if the applicant has three or more unpaid and unchallenged penalty charge notices issued by the Council, being those penalty charge notices where payment is lawfully due.
- 6.14 A vehicle that exhibits an expired or amended p & d ticket, t & d ticket, season ticket (including off peak season tickets), preferential permit or permit is invalid and renders the vehicle subject to the provisions of this Order.

- 6.15 An administrative charge, currently £10, may be made to replace any season ticket (including off peak season ticket), preferential permit or permit; or to change any details thereon.
- 6.16 The Council shall be entitled to terminate all rights granted by the issue of any season ticket (including off peak season ticket), preferential permit, or permit if at any time the holder is in contravention of any of the provisions contained in this Order. In any such circumstance the holder shall not be entitled to any refund whatsoever without prejudice to any other right of action the Council may have whether under this Order or otherwise.
- 6.17 Notwithstanding paragraph 6.16 above, the Council shall be entitled to terminate, without notice and for any reason, any season ticket (including off peak season ticket), preferential permit or permit, but subject to a full refund for any unused period.

7. Exemptions from charges in parking places

7.1 Part (II) of the Schedule shall have effect for the purpose of exempting drivers of vehicles from payment of a parking charge.

8. Parked vehicles to be licensed and insured

- 8.1 The driver of a vehicle shall not cause that vehicle to park in a parking place:
 - 8.1.1 if the vehicle has been declared S.O.R.N,
 - 8.1.2 unless there is displayed on the vehicle a valid vehicle excise licence issued in pursuance of the provisions of the Act of 1994,
 - 8.1.3 unless the driver possesses a policy and certificate of insurance, in relation to the use of the vehicle by the driver, that complies with the requirements of the Act of 1988, and
 - 8.1.4 unless the vehicle registration number plate is visible at all times and, that if it is obscured by any covering on the vehicle, the CEO shall be empowered to uncover the plate to record the registration number;

9. Activities prohibited in parking place

- 9.1 The driver of a vehicle using a parking place shall stop the engine as soon as the vehicle is in position in the parking place, and shall not start the engine except when about to change the position of the vehicle in, or to depart from, the parking place.
- 9.2 The driver of a vehicle using a parking place shall not sound any horn or other similar instrument except when about to change the position of the vehicle in, or to depart from, the parking place.
- 9.3 Except with the prior written permission of the Council, no person shall use any part of a parking place or any vehicle left in a parking place
 - 9.3.1 for sleeping, camping or cooking;
 - 9.3.2 to erect, or cause to be erected, any tent, booth, stand, building, structure or any other thing;
 - 9.3.3 to light, allow or cause any fire to be lit;

- 9.3.4 to display, place on vehicles or distribute, or cause to be displayed, placed or distributed any notice, leaflet, handbill, booklet, book or other item; display or distribute, or cause to be displayed or distributed, any notice, leaflet, handbill, booklet, book or other item;
- 9.3.5 for the unauthorised sale of any article to persons in or near the parking place, or in connection with the selling or offering for hire of his skill or services:
- 9.3.6 for the furtherance of business of any kind, private or otherwise;
- 9.3.7 for the purpose of servicing or washing any vehicle or part thereof, other than is reasonably necessary to enable that vehicle to depart from the parking place;
- 9.3.8 for the display of any vehicle for sale or to sell any vehicle;
- 9.3.9 to park any caravan or trailer unless otherwise approved before parking, in which case the caravan or trailer must be connected to the towing vehicle at all times, both units must fit wholly within marked bays and towing vehicle must display consecutive valid pay and display tickets for the number of spaces occupied.
- 9.3.10 to carry out repairs or adaptations to the vehicle unless the need for such works was not identified until after parking took place and that without them the vehicle could not be moved from the parking place PROVIDED such repairs are carried out within 24 hours of the identification of the breakdown.
- 9.4 No person in a parking place shall:
 - 9.4.1 shout or make or cause any loud noise to be made to the annoyance or disturbance of any users of the parking place, any occupants of adjoining or neighbouring premises or any passers-by;
 - 9.4.2 use any threatening, abusive or insulting language, gesture or conduct likely to occasion, or occasioning, a breach of the peace;
 - 9.4.3 deposit litter or fly tip any items;
 - 9.4.4 cycle, skateboard, or play any ball game or any other game;

10. Alteration of the position, clamping and removal, of vehicles

- 10.1 If a vehicle is left in a parking place in a position other than in accordance with the provisions of Article 4 of this Order, an authorised person may alter, or cause to be altered, the position of the vehicle so that its position is in accordance with the said Article.
- 10.2 If a vehicle is left in a parking place in contravention of any of the provisions of this Order, an authorised person may clamp or remove the vehicle from that parking place or arrange for such removal.
- 10.3 For the purpose of meeting the requirement of an emergency, an authorised person may alter, or cause to be altered, the position of a vehicle in a parking place or remove or arrange for the removal of a vehicle from a parking place.
- 10.4 An authorised person may move, or cause to be moved, any vehicle or other

container containing any substance which appears to him to be hazardous to health as defined by the Control of Substances Hazardous to Health Regulations 1988 or any other legislation relating to health or safety.

10.5 The Council will clamp and/or remove any vehicle, where the vehicle with that registration number has more than three unpaid and unchallenged penalty charge notices issued by the Council, which are lawfully due and outstanding for more than 3 months.

10.6 A person –

- 10.6.1 altering, or causing the alteration of, the position of a vehicle by virtue of this Article; or
- 10.6.2 removing, or causing the removal of, a vehicle by virtue of this Article, may do so by towing or driving the vehicle or in such other manner as he may think reasonably necessary to enable the position of the vehicle to be altered or the vehicle to be removed.
- 10.7 The cost of clamping, removal and any associated costs will be charged to the registered keeper and must be paid along with any outstanding PCNs before release of the said vehicle. Failure to do so may result in the vehicle being disposed of, to meet such costs.
- 10.8 Any person removing or arranging the removal of a vehicle by virtue of this Article shall make such arrangements as he considers reasonably necessary for the safety of the vehicle in the place to which it is removed.

11. Disposal of Vehicles abandoned in a Parking Place.

11.1 The Council, as respects any vehicle which has been or could at any time be removed from a parking place in pursuance of this Article if it appears to them to have been abandoned, may sell or otherwise dispose of the vehicle and may recover any expenses and charges reasonably incurred from any person responsible.

12. Restrictions on driving of vehicles in parking places

- 12.1 Where in a parking place signs are erected, or surface markings are laid, for the purpose of a) indicating the entrance to, or exit from, the parking place; or b) indicating that a vehicle using the parking place shall proceed in a specified direction within the parking place, no person shall drive, or cause to be driven, any vehicle
 - 12.1.1 so that it enters the parking place otherwise than by an entrance so indicated;
 - 12.1.2 so that it leaves the parking place otherwise than by an exit so indicated; or
 - 12.1.3 in a direction other than so specified.
- 12.2 No person shall, except with the prior written permission of the Council, drive or cause to be driven any vehicle in a parking place for any purpose other than the purpose of leaving that vehicle in the parking place in accordance with the provisions of this Order or for the purpose of departing from the parking place.

13. Contraventions of this Order- penalty charge notice

13.1 Where a vehicle is left in a parking place in contravention of any of the provisions of this Order, a civil enforcement officer may attach to the vehicle in a conspicuous position a penalty charge notice, in accordance with the Act of 2004. PROVIDED ALWAYS that the requirements of this paragraph shall not apply to a breach of this Order if the vehicle is removed from the parking place before the penalty charge notice can be completed or affixed to the vehicle;

PART II

(1) Exemptions from initial charges in parking places

The drivers of the following vehicles shall be exempt from payment of an initial charge during the charging periods:

- (a) A disabled person's vehicle parked in accordance with the provisions of paragraph (4) of Article 3.
- (b) A motor cycle (without a sidecar) or a moped as defined in the Act of 1994 parked in a motor cycle bay a parking bay reserved for the parking of motor cycles and mopeds.
