BOROUGH OF TRAFFORD (PROHIBITION OF WAITING AND LOADING **AND PROVISION OF PARKING ORDER 2001)** (AMENDMENT NO 17 PART A) ORDER 2003

Trafford Borough Council in exercise of its powers under Sections 1, 2, 4, 32, 35, 45, 46, 47, 49 and 53 of the Road Traffic Regulation Act 1984 (the Act of 1984) and Part IV of Schedule 9 to the Act of 1984 and of all other enabling powers and after consultation with the Chief Officer of Police for Greater Manchester in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

PART I - GENERAL

- This Order shall come into operation on 3rd March 2003 and may be cited as the Borough of Trafford 1. (Prohibition of Waiting and Loading and Provision of Parking Order 2001) (Amendment No 17 Part A) Order 2003.
- 2. This Order forms an amendment to the provisions of the Borough of Trafford (Prohibition of Waiting and Loading and Provision of Parking) Order 2001 ("the 2001 Order").
- 3. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 4. The expressions, definitions and interpretations specified in Article 4 of the 2001 Order shall apply equally to this Order.

PART II - AMENDMENTS

5. The 2001 Order is hereby amended to include the lengths of roads specified in Schedule 1 to this Order, with the following provisions denoted by the corresponding codes:-

No Waiting At Any Time

Code 7A

b) No Waiting Monday to Saturday 0800 – 1800 Code 6C

No Waiting At Any Time c)

Code 7A5P

No Loading/Unloading0730 - 0930 &1600 - 1800

- The lengths of road specified in Schedule 2 to this Order are deleted from the 2001 Order and the 6. provisions of the 2001 Order do not apply to the said lengths of road.
- 7. The provisions of Articles 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18, 19, 20 and 21 of the 2001 Order apply to the lengths of road specified in Schedule 1 to this Order.
- 8. Save as amended by this Order the provisions of the 2001 Order remain in force.
