THE KENT COUNTY COUNCIL (VARIOUS ROADS, SPELDHURST) (PROHIBITION OF WAITING) ORDER 2011 **ROAD TRAFFIC REGULATION ACT 1984**

THE KENT COUNTY COUNCIL (hereinafter referred to as "the Council") acting as the local traffic authority and in exercise of its powers under Sections 1, 2, 4 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (hereinafter referred to as the "Act of 1984") and as amended by the Traffic Management Act 2004 Part 6 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order.

Interpretation

	"civil enforcement officer"	means a person employed by Tunbridge Wells Borough Council in pursuance of powers granted by Traffic Management Act 2004 (Civil Enforcement Area)	
	"disabled persons badge"	Vehicles) Regulations 1991 or the Disabled Persons (Badges for Motor Vehicles) Regulations 2000;	
	"disabled persons vehicle"		
	"driver"	in relation to a vehicle waiting in a street parking place, means the person driving the vehicle at the time it was left in the parking place;	
	"junction"	means the intersection point of the centrelines, or projected centrelines, of the roads specified have the same meanings as in Section 142 of the Act of 1984	
	"owner" and "traffic sign"		
	"parking disc"	means a disc, issued by a Local Authority, 125mm in diameter coloured blue, and capable of showing the quarter hour period during which a period of waiting begins;	
	"parking exemption certificate"	a certificate or other means of identification which has been issued by the local traffic authority or its appointed agents on which is shown the index	

number of the vehicle to which it has been issued and

- 1) a commencement date and time
- 2) an expiry date and time
- 3) or both and
- 4) may specify those roads or parts thereof in which the certificate is valid

"relevant position"

means:

1) in the case of a vehicle fitted with a dashboard or facia panel, the disabled persons badge is exhibited thereon so that Part I of the badge is legible from outside the vehicle;

- 2) in the case of a vehicle not fitted with a dashboard or facia panel, the disabled persons badge is exhibited in a conspicuous position on the vehicle so that Part I of the badge is legible from outside the vehicle;
- in the case of a parking exemption certificate, in a conspicuous position inside the vehicle so as the certificate is visible in full and legible from outside the vehicle.

"specified road"

means the road or roads specified in the Schedule to this Order.

Prohibition of Waiting

- (2) Save as provided in Articles (3), (4) and (5) of this Order no person shall, except upon the direction or with the permission of a police constable in uniform or of a civil enforcement officer cause or permit: any vehicle to wait at any time in any of the lengths of road specified in the Schedule to this Order
- (3) Nothing in Article (2) of this Order shall prevent any person from causing or permitting a vehicle to wait in any of the lengths of road referred to in that Article for so long as may be necessary:-
 - (a) to enable a person to board or alight from the vehicle;
 - to enable goods to be loaded onto or unloaded from the vehicle provided such loading or unloading is continuous;
 - (c) to enable the vehicle to be used as part of a funeral cortege or a wedding procession;
 - (d) to enable the vehicle, if it cannot conveniently be used for such a purpose in any other road, to be used in the service of any local authority or with the permission of any such authority in pursuance of statutory powers and duties;
 - (e) to enable the vehicle, if it cannot conveniently be used for such purpose elsewhere, to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the carrying out of any roadworks or the laying, erection and alteration or repair of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity, or of any telegraph or telephone wires, cables, posts or supports; or
 - (f) to enable the vehicle to be used for police, ambulance or fire brigade purposes.
- (4) Nothing in Article (2) of this Order shall render it unlawful to cause or permit a disabled persons vehicle which displays in the relevant position a disabled persons badge, and a parking disc (on which the driver, or other person in charge of the vehicle, has marked the time at which the period of waiting began) to wait in any of the lengths of road referred to in the Schedule to this Order for a period not exceeding 3 hours (not being a period separated by an interval of less than 1 hour from a previous period of waiting by the same vehicle in the same length of road) provided always that where the period of the prohibition of waiting does not exceed 3 hours the parking disc need not be displayed.
- (5) Nothing in Article (2) of this Order shall render it unlawful to cause or permit a vehicle which displays in the relevant position a parking exemption certificate to wait in any of the roads specified in the Schedule to the Order provided the certificate has been issued for the vehicle displaying it and is valid for the place where the vehicle is waiting and for both the day and time when the vehicle is waiting.
- (6) The restrictions imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any regulations made or having effect as if made under the said Act of 1984.
- (7) The provisions of this order shall prevail over the provisions of any previous order.

Commencement and citation

This Order may be cited as "THE KENT COUNTY COUNCIL (VARIOUS ROADS, SPELDHURST) (PROHIBITION OF WAITING) ORDER 2011" and shall come into operation on the XXXXXXXXXX 2011

THE SCHEDULE

No waiting at any time

Barden Road, Speldhurst - Both sides - from a point 15 metres north west of its junction with Northfields to a point 15 metres south-east of that junction.

Barden Road, Speldhurst - West side - from its junction with Furzefield Avenue to a point 35 metres north of that junction

Furzefield Avenue, Speldhurst - North-east side - from its junction with Barden Road to a point 20 metres north west of that junction

Langton Road, Speldhurst - East side - from its junction with Penshurst Road to a point 46 metres south of that junction

Langton Road, Speldhurst - West side - from its junction with Penshurst Road to a point 74 metres south of that junction

Northfields, Speldhurst - Both sides - from its junction with Barden Road to a point 18 metres south-west of that junction

Northfields, Speldhurst - Both sides - from a point 12 metres north-east of its junction with St Mary's Lane to a point 12 metres south-west of that junction

Northfields, Speldhurst - Both sides - from its junction with Penshurst Road to a point 14 metres north-east of that junction

Northfields, Speldhurst - South-east side - from a point 11 metres north-east of its junction with Northfields south eastern spur to a point 11 metres south-west of that junction

Northfields (south Eastern Spur), Speldhurst - Both sides - from its junction with Northfields to a point 7 metres south-east of that junction

Penshurst Road, Speldhurst - North-east side - from a point 28 metres north-west of its junction with Northfields to a point 16 metres south-east of that junction

Penshurst Road, Speldhurst - South side - from a point 20 metres west of its junction with Langton Road to a point 20 metres east of that junction

Penshurst Road, Speldhurst - South-west side - from a point 23 metres north-west of its junction with Northfields to a point 28 metres south-east of that junction

Southfields, Speldhurst - East side - from its junction with Penshurst Road to a point 18 metres south-west of that junction

Southfields, Speldhurst - West side - from its junction with Penshurst Road to a point 8 metres south-west of that junction

St Mary's Lane, Speldhurst - Both sides - from a point 5 metres north-west of its junction with Northfields to a point 5 metres south-east of that junction
