

## **THE TUNBRIDGE WELLS BOROUGH COUNCIL**

### **(PARKING PLACES) ORDER 2019 (AMENDMENT No 1) ORDER 2019**

The Tunbridge Wells Borough Council (hereinafter called the "Council") in exercise of their powers under Sections 32, 35 and 124 (and Part IV of Schedule 9) of the Road Traffic Regulation Act 1984 (hereinafter referred to as the "Act of 1984"), the Traffic Management Act 2004 (hereinafter referred to as the "Act of 2004"), the Road Traffic (Permitted Parking Area and Special Parking Area)(County of Kent)(Borough of Tunbridge Wells) Order 1999 as amended by the Act of 2004 and all other enabling powers, with the consent of the County Council of Kent and after consultation with the Chief Officer of Police in accordance with Schedule 9 of the Act of 1984, **HEREBY MAKES THE FOLLOWING ORDER:-**

#### **PART I**

#### **GENERAL**

##### **Commencement and Citation**

1. This Order shall come into operation on the 2nd day of March 2020 and may be cited as the Tunbridge Wells Borough Council (Parking Places) Order 2019 (Amendment No 1) Order 2019.

##### **Interpretation**

2. Interpretation of this Order shall be provided for in the Tunbridge Wells Borough Council (Parking Places) Order 2019, ('the Principal Order'), subject to the following amendments.

##### **Amendments**

3. Articles 14(2), 17(2), 18(2), 22(3), 23(3), 25(2), 26(2), 27(3), 29(3), 32(3) and 33(2) shall be amended to show, in each case, that a season ticket will be valid for a maximum of 2 vehicle registration numbers, only one of which may be parked in the car park for which it is valid at any given time.
4. Article 15 shall be revoked and replaced with the following:-

##### **Beech Street and Union House Car Parks**

15. The following provisions apply to the Beech Street and Union House car parks only:-
  - (1) The owner and/or driver of a vehicle may on application to the Council purchase a season ticket for use at all times at the Beech Street Car Park or Union House Car Park subject to the charges set out in PART THREE (a) of the Schedule to the Principal Order (as amended by this Order). These are issued at the Council's discretion on a first-come first-served basis, subject to any limit imposed by the Tunbridge Wells Borough Council Parking Manager. Full time and part time (4 day) season tickets are available.
  - (2) Season tickets are to be issued to specified vehicles, with each season ticket being valid for a maximum of 2 vehicle registration numbers, only one of which may be parked in the specified car park at any given time.
5. Article 21 shall be revoked and replaced with the following:-

##### **Torrington Car Park, Tunbridge Wells**

21. The following provisions apply to the Torrington Car Park only
  - (1) The owner and/or driver of a vehicle may on application to the Council purchase a season ticket for use at all times at the Torrington Car Park subject to the charges set out in PART THREE (a) of the Schedule to the Principal Order (as amended by this Order). These are issued at the Council's discretion on a first-come first-served basis, subject to any limit imposed by the Tunbridge Wells Borough Council Parking Manager. Full time and part time (4 day) season tickets are available.



- (2) Season tickets are to be issued to specified vehicles, with each season ticket being valid for a maximum of 2 vehicle registration numbers, only one of which may be parked in Torrington Car Park at any given time.

6. Article 30 shall be revoked and replaced with the following:-

**Royal Victoria Place Car Park, Tunbridge Wells**

21. The following provisions apply to the Royal Victoria Place Car Park only

- (1) The Council will, on occasion, offer season tickets for use at the Royal Victoria Place Car Park subject to the charges set out in PART THREE (a) of the Schedule to the Principal Order (as amended by this Order). These are issued at the Council's discretion subject to any limit imposed by the Tunbridge Wells Borough Council Parking Manager. Full time season tickets are available.
- (2) Season tickets are to be issued to specified vehicles, with each season ticket being valid for a maximum of 2 vehicle registration numbers, only one of which may be parked in Royal Victoria Place Car Park at any given time.

7. In PART TWO of the SCHEDULE to the Principal Order, reference to Beech Street Car Park shall be removed. Reference to Torrington Car Park shall be removed and replaced with the following:-

\*The lower rate (£200) season ticket charge is only available to those residents within a permit parking zone where a cap on the number of permits available for issue applies and where that limit has been reached. Only those residents who do not have, and cannot currently purchase, an on-street permit but meet all other qualifying requirements will be allowed to have a season ticket at the lower rate.
