THE ROAD TRAFFIC REGULATION ACT 1984

The Kent County Council, in exercise of the powers given to them under sections 36, 39 and 45(2) of the Road Traffic Regulation Act, 1984, (hereinafter referred to as "the act of 1984"), as amended by section 1 of the Road Traffic Regulation (Parking) Act, 1986 and as amended by the Traffic Management Act 2004 Part 6 and of all other powers enabling them in that behalf, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984, hereby make the following Order:-

In **Part Three** of the Schedule "Two Hour Limited Waiting Mon-Sat 8am-6pm return prohibited within 4 Hours except permit holders" of the KENT COUNTY COUNCIL ZONE C (RESIDENTS PARKING) (TUNBRIDGE WELLS) ORDER 2009 the following shall be inserted

Mount Ephraim, Tunbridge Wells - South-east side - from a point 24 metres south-west of its junction with Church Road to a point 10 metres north-east of its junction with the vehicular access to the Mount Edgecombe Hotel.

Mount Ephraim, Tunbridge Wells - South-east side - from a point 57 metres south-west of its junction with London Road to a point 18 metres north-east of its junction with Molyneux Park Road.

In **Part Two** of the Schedule "One Hour Limited Waiting Mon-Sat 8am-6pm return prohibited within 4 Hours except permit holders" of the KENT COUNTY COUNCIL ZONE C (RESIDENTS PARKING) (TUNBRIDGE WELLS) ORDER 2009 the following shall be revoked
