### (VARIOUS ROADS, TUNBRIDGE WELLS BOROUGH)

## (PROHIBITION OF WAITING) No. 2 ORDER 2003

### **ROAD TRAFFIC REGULATION ACT 1984**

THE KENT COUNTY COUNCIL (hereinafter referred to as "the Council") acting as the local traffic authority and in exercise of its powers under Sections 1, 2, 4 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (hereinafter referred to as the "Act of 1984") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order.

## **Interpretation**

(1) In this Order:-

"disabled persons badge"	has the same meaning as in the Disabled Persons (Badges for Motor Vehicles) Regulations 1991 or the Disabled Persons (Badges for Motor Vehicles) Regulations 2000;
"disabled persons vehicle"	has the same meaning as in the Local Authorities Traffic Orders (Exemptions for Disabled Persons) (England and Wales) Regulations 1991 or the Local Authorities Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000;
"junction"	means the intersection point of the centrelines, or projected centrelines, of the roads specified
"owner" and "traffic sign"	have the same meanings as in Section 142 of the Act of 1984
"parking attendant"	means a parking attendant employed by Tunbridge Wells Borough Council in pursuance of powers granted by The Road Traffic (Permitted Parking Area and Special Parking Area) (County of Kent) (Borough of Tunbridge Wells) Order 1999;
"parking disc"	means a disc, issued by a Local Authority, 125mm in diameter coloured either blue or orange, and capable of showing the quarter hour period during which a period of waiting begins;
"parking exemption certificate"	a certificate or other means of identification which has been issued by the local traffic authority or its appointed agents on which is shown the index number of the vehicle to which it has been issued and
	1) a commencement date and time
	2) an expiry date and time
	3) or both and
	4) may specify those roads or parts thereof in which the certificate is valid
"relevant position"	means;
	<ol> <li>in the case of a vehicle fitted with a dashboard or fascia panel, the disabled persons badge is exhibited thereon so that Part I of the badge is legible from outside the vehicle;</li> </ol>
	<ol> <li>in the case of a vehicle not fitted with a dashboard or fascia panel, the disabled persons badge is exhibited in a conspicuous position on the vehicle so that Part I of the badge is legible from outside the vehicle;</li> </ol>
	<ol> <li>in the case of a parking exemption certificate, in a conspicuous position inside the vehicle so as the certificate is visible in full and legible from outside the vehicle.</li> </ol>
"specified road"	means the road or roads specified in the Schedule to this Order.
"weekday"	means any day of the week except Sunday

## Prohibition of Waiting

- (2) Save as provided in Articles (3), (4) and (8) of this Order no person shall, except upon the direction or with the permission of a police constable in uniform or of a traffic warden or of a parking attendant cause or permit:-
  - (a) any vehicle to wait at any time in any of the lengths of road specified in PART ONE of the Schedule to this Order or
  - (b) any vehicle to wait on any weekday between the hours of 8am and 6pm in any of the lengths of road specified in PART TWO of the Schedule to this Order.
  - (c) any vehicle to wait on any day except Saturday or Sunday between the hours of 8am and 6pm in any of the lengths of road specified in PART THREE of the Schedule to this Order.
- (3) Nothing in Article (2) of this Order shall prevent any person from causing or permitting a vehicle to wait in any of the lengths of road referred to in that Article for so long as may be necessary:-
  - (a) to enable a person to board or alight from the vehicle;
  - (b) to enable goods to be loaded onto or unloaded from the vehicle provided such loading or unloading is continuous;
  - (c) to enable the vehicle to be used as part of a funeral cortege or a wedding procession;
  - (d) to enable the vehicle, if it cannot conveniently be used for such a purpose in any other road, to be used in the service of any local authority or with the permission of any such authority in pursuance of statutory powers and duties;
  - (e) to enable the vehicle, if it cannot conveniently be used for such purpose elsewhere, to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the carrying out of any roadworks or the laying, erection and alteration or repair of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity, or of any telegraph or telephone wires, cables, posts or supports; or
  - (f) to enable the vehicle to be used for police, ambulance or fire brigade purposes.
- (4) Nothing in Article (2) of this Order shall render it unlawful to cause or permit a disabled persons vehicle which displays in the relevant position a disabled persons badge, and a parking disc (on which the driver, or other person in charge of the vehicle, has marked the time at which the period of waiting began) to wait in any of the lengths of road referred to in the Schedule to this Order for a period not exceeding 3 hours (not being a period separated by an interval of less than 1 hour from a previous period of waiting by the same vehicle in the same length of road) provided always that where the period of the prohibition of waiting does not exceed 3 hours the parking disc need not be displayed.
- (5) Nothing in Article (2) of this Order shall render it unlawful to cause or permit a vehicle which displays in the relevant position a parking exemption certificate to wait in any of the roads specified in PART ONE, PART TWO or PART THREE of the Schedule to this Order provided the certificate has been issued for the vehicle displaying it and is valid for the place where the vehicle is waiting and for both the day and time when the vehicle is waiting.

### <u>General</u>

- (6) The restrictions imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any regulations made or having effect as if made under the said Act of 1984 except that any provision made under the Tunbridge Wells Borough Council (Various Roads, Tunbridge Wells) (Bus Stop Clearways) Order 1992 or the Kent County Council (Disabled Parking Bays - Various Roads in Royal Tunbridge Wells) Order 1999 shall prevail over any provisions made under this order.
- (7) All Orders prohibiting waiting in any of the lengths of roads specified in PART FOUR of the schedule to this order are hereby revoked but only in so far as they relate to the said lengths of road.

# **Commencement and citation**

(8) This Order may be cited as "The Kent County Council (Various Roads, Tunbridge Wells Borough) (Prohibition of Waiting) No. 2 Order 2003" and shall come into operation on the 3rd day of March 2003.

## THE SCHEDULE

### PART ONE

#### No waiting at any time

Albion Road, Tunbridge Wells - North side from a point 10 metres east of its junction with Auckland Road to a point 10 metres west of that junction.

Albion Road, Tunbridge Wells - North side from a point 10 metres east of its junction with Dorking Road to a point 10 metres west of that junction.

Albion Road, Tunbridge Wells - South side from a point 10 metres east of its junction with St James' Park to a point 10 metres west of that junction.

Auckland Road, Tunbridge Wells - Both sides from its junction with Albion Road to a point 10 metres north of that junction.

Birken Road, Tunbridge Wells - Both sides from a point 15 metres south its junction with Friars Way to a point 15 metres north of that junction.

Birken Road, Tunbridge Wells - Both sides from its junction with Sandhurst Road to a point 35 metres north east of that junction

Birken Road, Tunbridge Wells - East side from a point 15 metres south its junction with Harries Road to a point 15 metres north of that junction.

Broadmead, Tunbridge Wells - North sides from a point 23 metres east of its junction with Leneda Drive to a point 40 metres west of that junction.

Caley Road, Tunbridge Wells - Both sides from its junction with Liptraps Lane to a point 15 metres west of that junction.

Colebrook Road, Tunbridge Wells - North west side from its junction with Great Brooms Road to a point 20 metres south west of that junction.

Culverden Park Road, Tunbridge Wells - Both sides from its junction with Culverden Park to a point 20 metres north west of that junction.

Culverden Park Road, Tunbridge Wells - North side from its junction with Culverden Park to a point 16 metres east of the junction

Dorking Road, Tunbridge Wells - Both sides from its junction with Albion Road to a point 10 metres north of that junction.

Edward Street, Southborough - Both sides from its junction with Speldhurst Road to a point 10 metres north of that junction.

Friar's Way, Tunbridge Wells - Both sides from its junction with Birken Road to a point 15 metres east of that junction.

Great Brooms Road, Tunbridge Wells - South side from its junction with Colebrook Road to a point 48 metres west of that junction.

Greggswood Road, Tunbridge Wells - Both sides from its junction with Liptraps Lane to a point 15 metres east of that junction.

Harries Road, Tunbridge Wells - Both sides from its junction with Birken Road to a point 15 metres east of that junction.

Liptraps Lane, Tunbridge Wells - East side from a point 15 metres north of its junction with Greggswood Road to a point 15 metres south of that junction.

Liptraps Lane, Tunbridge Wells - West side from a point 15 metres north of its junction with Birch Way to a point 55 metres north of that junction.

Liptraps Lane, Tunbridge Wells - West side from a point 15 metres north of its junction with Caley Road to a point 15 metres south of that junction.

Liptraps Lane, Tunbridge Wells - West side from a point 15 metres north of its junction with Longview Way to a point 15 metres south of that junction.

Longview Way, Tunbridge Wells - Both sides from its junction with Liptraps Lane to a point 15 metres west of that junction.

Prospect Road, Southborough - Both sides from its junction with Speldhurst Road to a point 15 metres north of that junction.

Queens Road, Tunbridge Wells - Both sides from a point 10 metres south east of its junction with Silverdale Road to a point 10 metres south west of that junction.

Queens Road, Tunbridge Wells - South west side from a point 48 metres north west of its junction with Upper Grosvenor Road to a point 10 metres south east of its junction with Silverdale Road.

Sandhurst Road, Tunbridge Wells - Both sides from a point 20 metres south its junction with Birken Road to a point 20 metres north west of that junction.

Silverdale Road, Tunbridge Wells - Both sides from its junction with Queens Road to a point 10 metres north of that junction.

Speldhurst Road, Tunbridge Wells - North side from a point 15 metres west of its junction with Edward Street to a point 15 metres east of that junction.

Speldhurst Road, Tunbridge Wells - North side from a point 15 metres west of its junction with Prospect Road to a point 15 metres east of that junction.

St James' Park, Tunbridge Wells - Both sides of the East/West Spur from its junction with the North/South Spur of St James' Park to a point 10 metres west of that junction.

St James' Park, Tunbridge Wells - Both sides of the North/South Spur from its junction with Albion Road to a point 10 metres south of that junction.

St James' Park, Tunbridge Wells - West side of the North/South Spur from a point 10 metres south of its junction with the East/West Spur of St James' Park to a point 10 metres north of that junction.

# PART TWO

#### No waiting Monday to Saturday 8am - 6pm

Culverden Park Road, Tunbridge Wells - North east side from a point 101 metres north west of its junction with Culverden Park to a point 239 metres north west of that junction.

Queens Road, Tunbridge Wells - North side from a point 70 metres east of its junction with St Johns Road to a point 15 metres west of its junction with Chilston Road.

### PART THREE

#### No waiting Monday to Friday 8am - 6pm

Beltring Road, Tunbridge Wells – Both sides from a point 19 metres west of its junction with St John's Road to a point 40 metres west of that junction.

#### PART FOUR

### Rescind No waiting Monday to Saturday 8am – 6pm

Colebrook Road, Southborough - North west side from a point 18 metres south west of its junction with Great Brooms Road to a point 48 metres south west of that junction.

Colebrook Road, Southborough - South east side from a point 12 metres south west of its junction with Great Brooms Road to a point 21 metres south west of that junction.
