

ROAD TRAFFIC REGULATION ACT 1984  
THE KENT COUNTY COUNCIL  
ZONE C (RESIDENTS PARKING) (TUNBRIDGE WELLS) ORDER 2009  
(AMENDMENT) ORDER 2014

THE KENT COUNTY COUNCIL (hereinafter referred to as 'the Council') acting as the local traffic authority and in exercise of the powers given to them under sections 1,2,3,4,32,35,45,46,47,49,53 and 124 of the Road Traffic Regulation Act, 1984, (hereinafter referred to as "the act of 1984"), as amended by section 1 of the Road Traffic Regulation (Parking) Act, 1986 and as amended by the Traffic Management Act 2004 Part 6 and of all other powers enabling them in that behalf, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984, hereby make the following Order:-

In the Schedule to the KENT COUNTY COUNCIL ZONE C (RESIDENTS PARKING) (TUNBRIDGE WELLS) ORDER 2009 the following shall be inserted:

In **Part Two** of the Schedule "One Hour Limited Waiting Mon-Sat 8am-6pm return prohibited within 4 Hours except permit holders" of the KENT COUNTY COUNCIL ZONE C (RESIDENTS PARKING) (TUNBRIDGE WELLS) ORDER 2009 the following shall be inserted

**Insert.**

**Woodbury Park Road** - south side - from a point 16 metres east of its junction with Amherst Road to a point 33 metres east of that junction

**Woodbury Park Road** - south side - from a point 52 metres east of its junction with Amherst Road to a point 63 metres east that junction

**Woodbury Park Road (east/west spur)** - south side - from a point 10 metres south east of its junction with Woodbury Park Road to a point 20 metres south east of that junction.

**Woodbury Park Road (east/west spur)** - north side - from a point 30 metres south east of its junction with Woodbury Park Road to its south eastern extent

**Woodbury Park Road (east/west spur)** - north side - from a point 7 metres south east of its junction with Woodbury Park Road to a point 30 metres south east of that junction (echelon parking bays)

**Woodbury Park Road** - south east side - from a point 15 metres south west of its junction with Chilston Road to a point 85 metres south west off that junction

**Woodbury Park Road** - south east side - from a point 15 metres north east of its junction with Park Road to a point 95 metres north east of that junction

In the **Appendix** to the KENT COUNTY COUNCIL ZONE C (RESIDENTS PARKING) (TUNBRIDGE WELLS) ORDER 2009 - Postal addresses Zone C – amend Calverley Road to exclude number 55 (Calverley House) and include Woodbury Park Road.

This order shall come in to force on 7th July 2014 and may be cited as "Kent County Council Zone C (Residents Parking) (Tunbridge Wells) Order 2009 (Amendment) Order 2014"
