

THE VALE OF GLAMORGAN COUNCIL (PROHIBITION AND RESTRICTION OF WAITING AND LOADING AND PARKING PLACES) (CIVIL ENFORCEMENT) (AMENDMENT) (NO 6) ORDER 2013

The Vale of Glamorgan Council in exercise of its powers under Sections 1, 2, 3, 4, 32, 35, 45, 46, 53 and 124 of and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and Part 6 of the Traffic Management Act 2004 and of all other powers enabling it in that behalf and after consultation with the Chief Officer of South Wales Police, in accordance with Part III of Schedule 9 to the said Act of 1984 hereby makes the following Order:-

RESTRICTIONS AND LIMITATIONS

Limited Waiting 9.00a.m. to 6.00p.m. Monday to Saturday, for a maximum period of one hour, no return within one hour.

No person, except upon the direction or with the permission of a Police Constable in uniform or a Civil Parking Enforcement Officer, shall cause or permit any vehicle to wait, between the hours of 9.00am and 6.00pm Monday to Saturday for a period longer than one hour with no return within one hour in the lengths of road as described below.

The following Traffic Regulation Order is to be amended as follows:

Vale of Glamorgan Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement) Order 2013

SCHEDULE 1

Delete from map schedules AA27 and AA28 - Limited Waiting, Monday to Saturday, 9:00am to 6:00pm, 1 hour no return within 1 hour.

High Street (Part), Cowbridge

On the northern side, from a point 62.7 metres west of its junction with the western entrance to Town Hall Square, westwards for a distance of 45 metres.

On the northern side, from a point 148 metres west of its junction with the western entrance to Town Hall Square, westwards for a distance of 44 metres.

SCHEDULE 2

Insert new map schedules AA27/6-13 and AA28/6-13 - Limited Waiting, Monday to Saturday, 9:00am to 6:00pm, 1 hour no return within 1 hour.

High Street (Part), Cowbridge -

On the northern side, from a point 62.7 metres west of its junction with the western entrance to Town Hall Square, westwards for a distance of 51 metres.

On the northern side, from a point 145 metres west of its junction with the western entrance to Town Hall Square, westwards for a distance of 47 metres.

Citation and Commencement

The restrictions imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any regulations made or having effect as if made under the Road Traffic Regulation Act 1984 or by or under any other enactment.

This Order shall come into operation on the 9th December 2013 or on the dates that the signs and road markings are in place and may be cited as the "Vale of Glamorgan Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement) (Amendment) (No 6) Order 2013".
