

**THE VALE OF GLAMORGAN COUNCIL  
(PROHIBITION AND RESTRICTION OF WAITING AND  
LOADING AND PARKING PLACES)  
(CIVIL ENFORCEMENT) (AMENDMENT) (NO 6) ORDER 2017**

The Vale of Glamorgan Council in exercise of its powers under Sections 1, 2, 3, 4, 32, 35, 45, 46, 53 and 124 of and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and Part 6 of the Traffic Management Act 2004 and of all other powers enabling it in that behalf and after consultation with the Chief Officer of South Wales Police, in accordance with Part III of Schedule 9 to the said Act of 1984 hereby makes the following Order.-

**Interpretation**

No person shall except upon the direction or with the permission of a police constable in uniform or a Civil Parking Enforcement Officer cause or permit any vehicle to wait at any time in the lengths of road referred to in the Schedules to this Order.

**Citation and Commencement**

The restrictions imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any regulations made or having effect as if made under the Road Traffic Regulation Act 1984 or by or under any other enactment.

This Order shall come into operation on the 26<sup>th</sup> June 2017 or on the dates that the signs and road markings are in place and may be cited as the "Vale of Glamorgan Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement) (Amendment) (No 6) Order 2017".

The following Traffic Regulation Order is to be amended as follows:

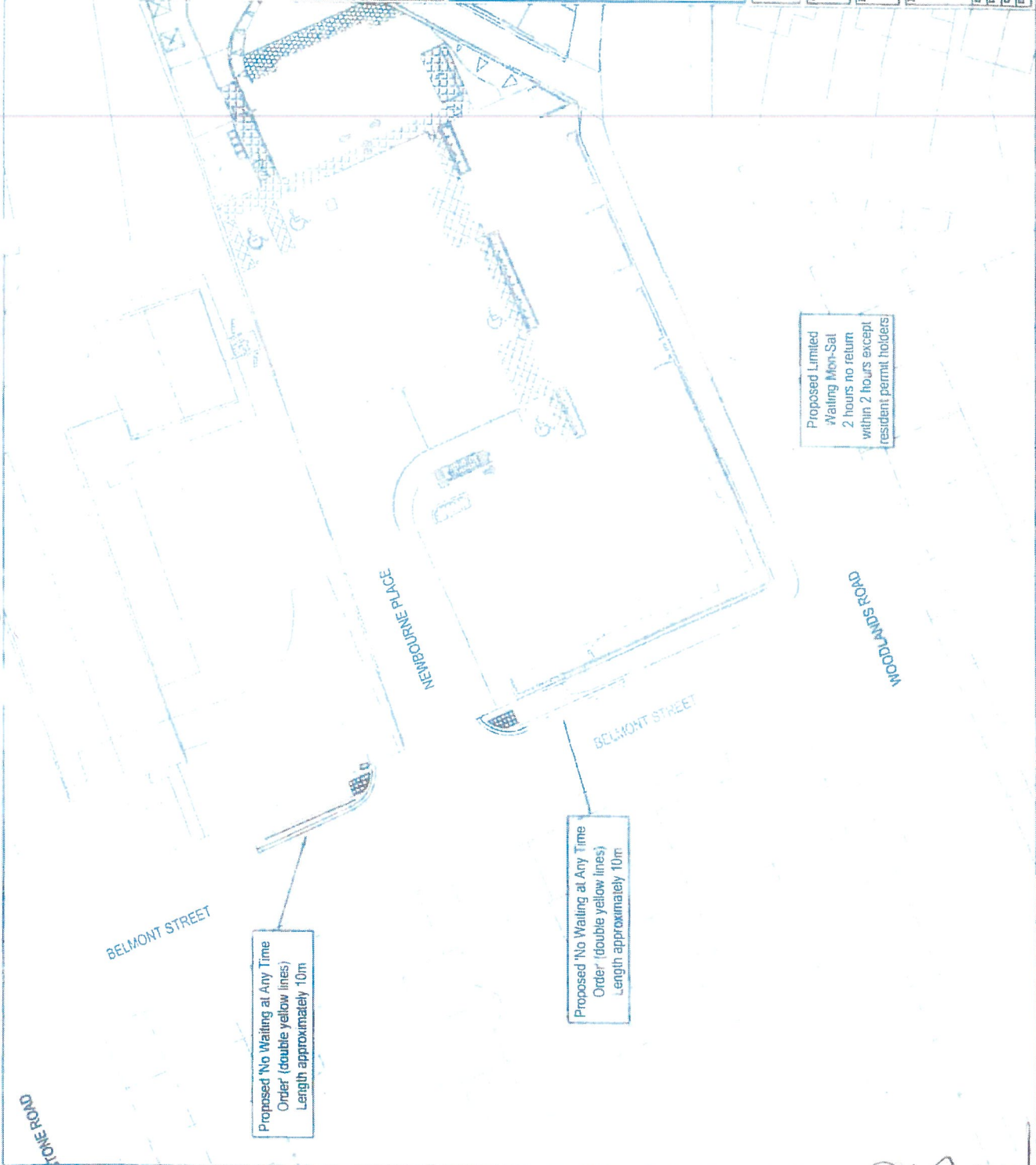
**Belmont Street, Barry – Map AU52**

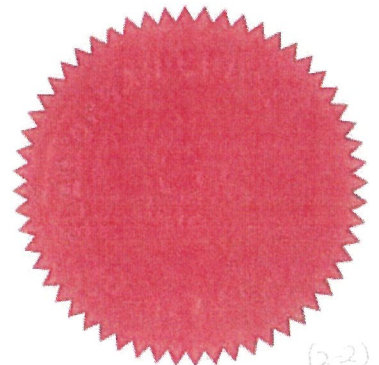
