

**THE VALE OF GLAMORGAN COUNCIL
(PROHIBITION AND RESTRICTION OF WAITING AND
LOADING AND PARKING PLACES)
(CIVIL ENFORCEMENT) (AMENDMENT) (NO 2) ORDER 2013**

The Vale of Glamorgan Council in exercise of its powers under Sections 1, 2, 3, 4, 32, 35, 45, 46, 53 and 124 of and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and Part 6 of the Traffic Management Act 2004 and of all other powers enabling it in that behalf and after consultation with the Chief Officer of South Wales Police, in accordance with Part III of Schedule 9 to the said Act of 1984 hereby makes the following Order:-

INTERPRETATION

'Residents Parking Permit' means a Permit issued by the Council for a period of up to 12 months to a person who has satisfied the Council, as being a bona fide resident of the area to which the Permit relates, having an eligible vehicle within the meaning of Article 1(ii) and who does not enjoy the facility of Off Street Parking.

'Visitors parking Permit' means a Permit issued by the Council for a period of up to 12 months to a person who has satisfied the Council as being a bona fide resident of the area to which the permit relates and who does not have an eligible vehicle within the meaning of Article 1 (iii) but for medical reasons requires a permit for visiting carers.

'Temporary Residents Parking Permit' means a permit issued, for a minimum period of three days and a maximum period of one calendar month, to a resident of an area to which the permit relates, in respect of a vehicle belonging to a visitor temporarily residing at the address of the said resident.

'Permit Holder' means an applicant who has been issued with a Residents Parking Permit, Temporary Residents Parking Permit or Visitors Parking Permit.

1. Resident Parking Place – Permit issue conditions

- i. A duly authorised officer of the Council may at any time require an applicant for a Permit to produce to him such evidence in respect of an application to the Council for a permit as he may reasonably require to verify any particulars or information required pursuant to Clause (ii) (a), (b) or (c) of this Article or in respect of any permit issued by the Council as he may reasonably require to verify that the Permit is in accordance with this Article.
- ii. On receipt of an application for a permit the Council upon being satisfied that:

- a) The applicant is a person who resides in a property having a frontage adjoining a street comprising a Parking Place;
- b) The applicant does not enjoy the facility of Off Street Parking;
- c) The application is made in respect of an eligible vehicle as defined in paragraph (iii) of this Article;

Shall issue to the applicant a permit in respect of that vehicle.

iii. For the purposes of this Article 'eligible vehicle' means:

- a) A passenger vehicle which is a motor vehicle constructed solely for the carriage of passengers and their effects and adapted to carry not more than 12 passengers exclusive of the driver and not drawing a trailer;
- b) A goods vehicle or a hatchback motor car;
- c) A motor vehicle as described in (a) and (b) above which is taxed and insured for use on the highway.

iv. A Permit shall be in writing and shall include the following particulars:

- a) The registration mark of the vehicle in respect of which the Permit was issued except when such Permit is issued to a resident whose vehicle is owned by a bona fide motor trader and which vehicle does not exceed 1500 Kilograms unladen weight in such cases the registration mark will be replaced with the words 'MOTOR TRADER'; or when certain conditions are met it may be replaced by the word 'VISITOR' or the word 'TEMPORARY'.

- b) The expiry date of the Permit pursuant to paragraph (vii) of this Article;

- c) An indication that the Permit was issued by the Council;

- d) The name of the street in which the resident resides.

v. No person shall be entitled to hold a Permit for more than one vehicle at any one time, except that the holder of a resident parking permit may also hold a Temporary Residents Parking Permit.

vi. The Permit shall only be valid in respect of the vehicle for which it is issued and no Permit Holder shall cause or permit any Permit issued to him by the Council to be displayed on any vehicle bearing a different registration number to that contained on the Permit at the

time of issue. A Permit shall cease to be valid in any of the following circumstances:

- a) At the expiration of the date stated thereon; or
 - b) On the occurrence of any one or more of the events set out in paragraph (vii) of this Article; or
 - c) At the expiration of one date from the date of effective service of a notice upon the Permit Holder pursuant to paragraph (viii) of this Article; whichever occurs first.
- vii. A Permit Holder may surrender a Permit to the Council at any time and shall surrender it to the Council on the occurrence of any one or more of the following events.
- a) The applicant ceasing to be resident in the street for which the Permit was issued;
 - b) The applicant ceasing to be the owner of the vehicle in respect of which the Permit was issued or the Permit when issued was marked with the words 'MOTOR TRADER' as provided in subparagraph (iv)(a) of this Article then for the purpose of this subparagraph only for the words 'Permit Holder' there shall be read the words 'Bona Fide Motor Trader';
 - c) The vehicle in respect of which the permit was issued being adapted or used in such manner that it ceased to be an eligible vehicle as defined in paragraph (iii) of this Article;
 - d) The temporary resident no longer residing at the address of the applicant;
 - e) The cessation of visits by carers;
 - f) The issue by the Council of a duplicate Permit.
- viii. The Council may, by notice in writing served on a Permit Holder by delivering the same to the Permit Holder personally or by delivering it at or sending it by first class post to the address shown by that person on the application for the Permit or at any other address believed to be that person's abode, withdraw a Permit if it appears to the Council that any of the events set out in paragraph (viii) of this Article has occurred, or in the event of the revocation of this Order. In the above circumstances the Permit Holder shall surrender the Permit to the Council within 28 days from the date of effective service of the aforementioned Notice.

- ix. For the purposes of this Order the date of effective service shall be:
- a) The date on which the notice or other relevant document was served personally; or
 - b) The second date after the date on which the notice or other relevant document was sent by first class post; whichever is appropriate.

Designation (Resident Parking Place)

2. Each area on a highway referred to in this Order, and marked as prescribed by regulations, for the purposes of this Order, is designated as a Resident Parking Place.
3. Except as provided by this Order or upon the direction or with the permission of a Police Constable in uniform or a Traffic Warden no person shall cause or permit a vehicle to wait between the hours of 8.00am and 6.30pm, Monday to Saturday, in a resident Parking Place designated by this Order, unless the vehicle is displaying in a conspicuous position a Permit issued in accordance with Article 1 above.

Regulation of Designated Parking Places (Resident Parking Places).

4. Where a Police Constable in uniform or a Traffic Warden is of the opinion that the provisions contained in this Order have been contravened he may remove or cause to be removed the vehicle from its Parking Place.
5. A Police Constable in uniform or a Traffic Warden may move or cause to be moved in case of emergency to any place he thinks fit any vehicle kept in a Parking Place and where it is so removed shall provide for the safe custody of the vehicle.
6. Every vehicle left in parking Place shall stand so that every part of the vehicle is within the limits of the Parking Place.
7. A Police Constable in uniform or Traffic Warden or a person duly authorised by the Council may suspend the use of a Parking Place or any part thereof whenever he considers such suspension reasonably necessary:
 - i. For the purpose of facilitating the movement of traffic or promoting its safety;
 - ii. For the purpose of any building operation the maintenance, improvement or reconstruction of the highway or the cleansing of

- gullies in or adjacent to the Parking Place the laying, erection, alteration or repair in or adjacent to the Parking Place or any sewer or of any main pipe or apparatus for the supply of gas water or electricity or of any telecommunication system or the placing maintenance or removal of any traffic sign;
- iii. For the convenience of occupiers of premises adjacent to the Parking Place on any occasion of the delivery or removal of furniture to or from an office or dwelling house adjacent to the parking Place;
 - iv. On any occasion on which it is likely by reason of some special attraction that the street in which the Parking Place is situate will be thronged or obstructed;
 - v. For the convenience of occupiers of premises adjacent to the Parking Place for parking the official vehicles (provided that there are no more than three) being at that time in use in connection with a wedding taking place that day compromising only the vehicles to transport the bride and/or bridegroom and/or bridesmaids to the place of the marriage ceremony on the wedding day;
 - vi. For the conveyance of occupiers of premises adjacent to the Parking Place for the use of a vehicle as a part of a funeral cortege or otherwise in connection with a funeral provided the vehicle is owned by a funeral director or by an owner of funeral vehicles.
8. Any person or Police Constable in uniform or Traffic Warden suspending the use of a Parking Place or any part thereof in accordance with the provisions of this Order shall hereupon place or cause to be placed in or adjacent to that parking Place or as the case may be that part thereof the use of which is suspended a traffic sign of any size colour and type prescribed or authorised under Section 64 of the Act of 1984 indicating that waiting of vehicles is prohibited.

RESTRICTIONS AND LIMITATIONS

Limited Waiting 8.00a.m. to 6.00p.m. Monday to Saturday, for a maximum period of one hour, return prohibited in one hour.

9. No person, except upon the direction or with the permission of a police constable in uniform or a traffic warden, shall cause or permit any vehicle to wait, between the hours of 8.00am to 6.00pm Monday to Saturday for a period longer than one hour with no return within one hour in the lengths of road as described below.

Limited waiting to two hours with no return within two hours, 8.00am – 6.00pm Monday to Saturday, except for resident permit holders

10. No person shall, except upon the direction or with the permission of a police constable in uniform or a traffic warden, cause or permit any vehicle to wait, between the hours of 8.00am and 6.00pm Monday to Saturday for a period longer than two hours with no return within two hours, in the lengths of road as referred to below unless displaying a valid residents parking permit.

The following Traffic Regulation Order is to be amended as follows:

SCHEDULE 1

Delete From Existing Map No AX50 - Loading Only Mon-Sat 8am-5pm 30 minutes No Return within 1 hour

Queen Street, Barry

On its south east side from the south western building line of number 107 Queen Street, south west for a distance of 24.5 metres.

Insert New Map AX50/2-13 – Prohibition of Waiting Mon-Sat 8am-6pm 2 hours no return within 2 hours except Resident Permit Holders

Queen Street, Barry

On its south east side from the south western building line of number 107 Queen Street, south west for a distance of 6.5 metres.

On its south east side from a point 13 metres south west of the south western building line of 107 Queen Street, south west for a distance of 8.5 metres.

SCHEDULE 2

Delete From Existing Map No AK64 - Resident Parking Place Mon-Sat 8am-6.30pm

Hickman Road, Penarth

On its east side from a point 15 metres south of its junction with Windsor Road, south for a distance of 25 metres.

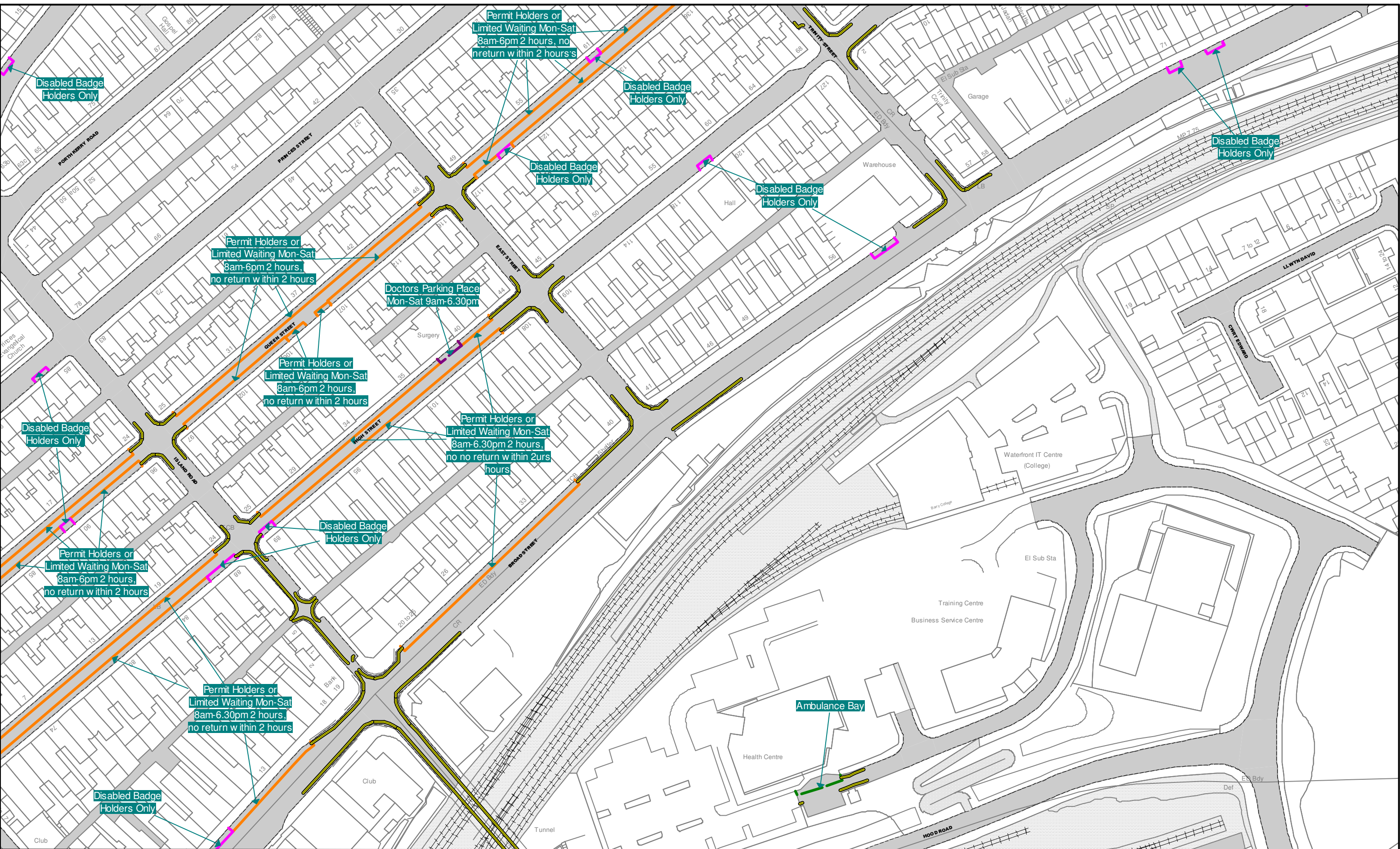

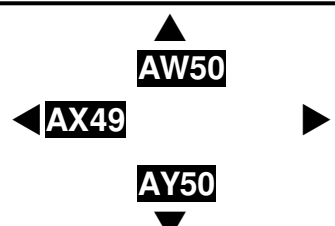
