# WALSALL METROPOLITAN BOROUGH (LOWER FORSTER STREET, HATHERTON ROAD, HATHERTON STREET AND LICHFIELD STREET, WALSALL) (PROHIBITED RIGHT TURNS) (CONSOLIDATION) ORDER, 2024

The Walsall Metropolitan Borough Council (hereinafter referred to as "the Council") in exercise of its powers under Sections 1, 2 and 4 of the Road Traffic Regulation Act, 1984 (as amended) (hereinafter referred to as "The Act") and of all enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

#### Commencement and citation

1. This Order shall come into operation on the 19<sup>th</sup> January 2024, and may be cited as the "Walsall Metropolitan Borough (Lower Forster Street, Hatherton Road, Hatherton Street and Lichfield Street, Walsall) (Prohibited Right Turns) (Consolidation) Order, 2024."

### Interpretation

- 2. (1) In this Order:
  - a. a reference to an Article or Schedule followed by a number is a reference to the Article of, or Schedule to, this Order so numbered;
  - b. "bus" has the same meaning as regulation 2 (schedule 1) of the Traffic Signs Regulations and General Directions 2016;
  - c. "cause" includes permit, and causing shall be construed accordingly;
  - d. "pedal cycle" has the same meaning as in regulation 2 (schedule 1) of the Traffic Signs Regulation and General Directions 2016;
  - e. "vehicle" includes any part of the vehicle.
  - (2) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

## Prohibition of right turn

- 3. Save as provided in Article 6, no person shall cause or permit any vehicle except buses and pedal cycles to make a right turn as specified in Schedule 1 of this Order.
- 4. Save as provided in Articles 6, no person shall cause or permit any vehicle make a right turn as specified in Schedule 2 of this Order.
- 5. Save as provided in Article 6, no person shall cause or permit any vehicle except buses, taxis and pedal cycles to make a right turn as specified in Schedule 3 of this Order.

### **Exemptions**

- 6. Nothing in Articles 3, 4 and 5 shall apply in respect of a vehicle:-
  - (b) under the direction or with the permission of a police constable in uniform; or

(c) being used for ambulance, fire brigade or police purposes in the event of an emergency.

## General

7. The provisions of this Order are in addition to and not in derogation of the provision of any regulation made or having the effect as if made under the Act of 1984, or by any other enactment.

## Revocations

8. The Walsall Metropolitan Borough (Lower Forster Street, Hatherton Road, Hatherton Street and Lichfield Street, Walsall) (Prohibited Right Turns) Order, 2013 shall hereby be revoked in its entirety.

## **SCHEDULE 1**

### **Prohibition of Right Turn except Buses and Pedal Cycles**

### a) Lichfield Street

No vehicle except buses and pedal cycles travelling on Lichfield Street in a south westerly direction, shall make a right turn so as to proceed along Hatherton Road in a north westerly direction.

### **SCHEDULE 2**

#### **Prohibition of Right Turn**

#### a) Lower Forster Street

No vehicle travelling on Lower Forster Street in a south westerly direction, shall make a right turn so as to proceed along Hatherton Road in a westerly direction.

### b) Hatherton Street

No vehicle travelling on Hatherton Street in a southerly direction, shall make a right turn so as to proceed along Hatherton Road in a westerly direction.

## **SCHEDULE 3**

## Prohibition of Right Turn except Buses, Taxis and Pedal Cycles

#### a) Hatherton Road

No vehicle except buses, taxis and pedal cycles travelling on Hatherton Road in a south easterly direction, shall make a right turn so as to proceed along Lichfield Street in a south westerly direction.
