

## WALSALL METROPOLITAN BOROUGH COUNCIL

### (CIVIL ENFORCEMENT OFF-STREET PARKING PLACES) ORDER AMENDMENT 1 2019

The Walsall Metropolitan Borough Council (hereinafter referred to as "the Council") in exercise of its powers under Sections 32, 33 and 35 of the Road Traffic Regulation Act, 1984 (hereinafter referred to as "the Act of 1984"), and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984, hereby makes the following Order:

#### PART I - GENERAL

##### Title and Date of Operation

1. This Order shall come into operation on 1 September 2019, and may be cited as "The Walsall Metropolitan Borough (Civil Enforcement Off-Street Parking Places) Order Amendment 1 2019".

##### Revocations

2. The following Order is hereby revoked in its entirety:  
The Walsall Metropolitan Borough (Civil Enforcement Off-Street Parking Places) Order 2019.

##### General Definitions

3. In this Order, except where the context otherwise requires, the following expressions have the meanings hereby assigned to them:

"bank holiday" includes any standard or specially declared bank holiday applying to England;

"barrier controlled" means a parking place controlled by barriers where payment is made on foot on return prior to leaving the parking place;

"Civil Enforcement Officer" means a person authorised by or on behalf of the Council to supervise the parking places and enforce the restrictions imposed by this Order;

"charging post" means an installation adjacent to a parking place for the purposes of recharging the battery of an electric vehicle by way of a connecting lead;

"disabled persons badge" means the same meaning as in the Local Authorities Traffic Orders (Exemption for Disabled Persons) (England) Regulations 2000;

"driver", in relation to a vehicle waiting in a parking place, means the person driving the vehicle at the time it was left in the parking place;

"electric vehicle" means a vehicle in which the electrical motive power is derived from an electrical storage battery which is not connected to any source of power when the vehicle is in motion;

"expiry time" is the time indicated on the Pay and Display Ticket and is the time by which the Vehicle must leave the parking place;

"heavy commercial vehicle" has the same meaning as in Section 138(1) of the Act of 1984;

"loading/unloading" refers to when a vehicle is parked wholly in a parking place or bay marked for that purpose on site, for the purpose of delivering or collecting goods or merchandise or loading or unloading the vehicle at premises adjacent to the parking place or bay;

"long stay car park" means any of the parking places listed in Part 1 of Schedule 2 and 5 to this Order;

"lorry and lorries" for this Order shall have the same meaning as a heavy commercial vehicle;

"lorry park" means any of the parking places listed in Part 1 of Schedule 5 to this Order where the parking of lorries only or at specified times is permitted;

"motorcycle" has the same meanings as in Section 136 of the Act of 1984;

"owner" in relation to a vehicle means the person who is recorded as the registered keeper by the Driver and Vehicle Licensing Agency on the date on which the vehicle was left in the parking place in question;

"parking place" means each area of land provided by the Council for the purpose of leaving of vehicles and not closed (in part or in whole) by a notice erected thereon by authority of the Council specified by name in Part 1 of the Schedules to this Order;

"parking space" means an area of a parking place, which is provided for the parking of a single vehicle of a class specified and indicated by markings on the surface of the parking place or signed or otherwise indicated by signs in the parking place;

"partner agencies" means organisations or individuals identified by the council as eligible to apply for parking permits for use in the Council's off street parking places where applicable;

"pay and display ticket" means a ticket lawfully obtained from a ticket machine provided by the Council for the issue of parking tickets appropriately dated and time stamped;

"Pay Station" means an apparatus located in a barrier controlled parking place for accepting payments;

"penalty charge" means a charge imposed by legislation in respect of parking contraventions that are subject to civil enforcement and which has the same meaning as in the Civil Enforcement of Parking Contraventions (England) General Regulations 2007;

"penalty charge notice" has the same meaning as in the Civil Enforcement of Parking Contraventions (England) General Regulations 2007;

"permit only long stay car park" means any of the parking places listed in Part 1 of Schedule 4 to this Order where parking is restricted to permit holders;

"Permit" means a permit issued by the Council in accordance with the Council's conditions for issuing parking permits for the time being in force;

"Relevant position" means:

- (a) In respect of a vehicle displaying a valid disabled person's badge:
  - (i) in the case of a vehicle fitted with a dashboard or fascia panel, the badge is exhibited thereon so that Part 1 (the front of the badge), is legible from outside the vehicle; or
  - (ii) in the case of a vehicle not fitted with a dashboard or fascia panel, the badge is exhibited in a conspicuous position on the vehicle so that Part 1 (the front of the badge), is legible from outside the vehicle.
- (b) In respect of a vehicle displaying a pay and display ticket or parking permit:
  - (i) the pay and display ticket or permit is exhibited on the inside surface of the windscreen or in a clearly visible position so that it is facing forwards and can be easily seen and read from the front or side of the vehicle; or
  - (ii) in the case of a vehicle that is not fitted with a transparent windscreen, the pay and display ticket or permit is exhibited on the front of the vehicle facing forwards and clearly visible.

"recharging point" for the purpose of this Order, means a parking space designated for the recharging of electric vehicles' batteries by means of a recharging post;

"season ticket" means a ticket provided by the Council other than a parking ticket;

"short stay car park" means any of the parking places listed in Part 1 of Schedule 1 and 7 to this Order where there is a limit on the maximum stay at the times specified;

"ticket" shall include a token dispensed at entry to a barrier controlled parking place;

"ticket box" means a secure box provided by the Council into which drivers of vehicles the maximum gross weight of which exceeds 3.0 tonnes shall deposit valid parking tickets;

"ticket machine" means an approved ticket issuing machine provided by the Council for the issue of parking tickets appropriately dated and time stamped.

## **PART II - USE OF PARKING PLACES**

### **Use of Parking Places**

4. Each area of land specified by name in Part 1 of the Schedules to this Order may be used, subject to the following provisions of this Order, as a Parking place.

### **Provisions for Parking of Vehicles and for Preventing Obstructions**

5. Every vehicle parked in any of the said parking places:
- (1) Where parking spaces are defined by markings on the ground or otherwise, shall be parked wholly within a marked bay and nowhere else within the parking place;
  - (2) Where parking spaces are not defined by markings, shall be parked in a position so as not to cause an obstruction or as may be reasonably required by a Civil Enforcement Officer on duty at the parking place;
  - (3) Where in a parking place signs are erected or surface markings are laid for the purpose of indicating that a particular parking bay is only to be used for a specific purpose, no person shall cause a vehicle to be parked in such a parking bay for any other purpose than that which is specified;
  - (4) Whether spaces are defined by markings or not, shall not be parked in any location likely to cause an obstruction to other vehicles entering, leaving or manoeuvring around the parking place or using any of the parking spaces.

### **Powers of the Council to Close Parking Places**

6. Nothing in Article 4 of this Order shall restrict the power of the Council to close any or any part of the parking places either temporarily or permanently.

### **Powers of the Council to Suspend the Provisions of the Order**

7. Without prejudice to the provisions of Article 6 of this Order, the Council shall be entitled to suspend any or all of the provisions of this Order on such occasions and for such periods as they shall think fit.



### **Restrictions on Weight and Height of Vehicles Using Parking Places**

8. No person shall cause or permit any vehicle to use or park in any of the parking places specified in Part 1 of the Schedules to this Order which do not comply with the maximum weight and height restrictions specified in Part 6 of the Schedules to this Order.

### **Maximum Length of Stay for Vehicles Using Parking Places**

9. No person shall cause or permit any vehicle to stay in any of the parking places specified in Part 1 of the Schedules to this Order for any longer time than that specified in Part 3 of the Schedules to this Order except for the rider of a motor cycle not having a sidecar attached, or pedal cycle parked in a parking bay specifically designated for motor cycles without a sidecar attached or pedal cycles. Electric vehicles parked in a parking space designated as a recharging point for electric vehicles will be subject to the maximum length of stay as advertised in that parking space.

### **Restrictions on Vehicles Using any Parking Place**

10. (1) No person shall permit any vehicle to wait in any of the parking places specified in the Schedules to this Order unless:
- (a) The vehicle is licensed in accordance with the provisions of the Vehicle (Excise) Act 1971; and
  - (b) There is, in relation to the use of the vehicle by the driver, such a policy of insurance as complies with the requirements of Part VI of the Road Traffic Act 1988.
- (2) No person shall cause or permit any goods vehicle trailer to be left in any of the parking places specified in Part 1 of Schedule 5 to this Order unless coupled to a towing vehicle bearing number plates and having affixed thereto a current excise licence.

### **Restrictions on use of Parking Places**

11. (1) No person shall use a vehicle, while it is in a parking place specified in Part 1 of the Schedules to this Order, in connection with the sale of any article to persons in or near the Parking place or in connection with the selling or offering for hire of his or her skill or services, except with the written consent of the Council.
- (2) Save as provided in Articles 12 and 15 of this Order, no person shall use any part of a parking place specified in Part 1 of the Schedules to this Order or any vehicle left in such a parking place:
- (a) For eating, sleeping, cooking or camping purposes;
  - (b) For the purpose of servicing, washing, maintaining or repairing any vehicle or part thereof other than is reasonably necessary to enable that vehicle to depart from the parking place;
  - (c) For the erection of any tent, booth, stand, building or other structure except with the written consent of the Council; or
  - (d) For the purpose of storing, repairing, maintaining, loading or unloading any goods, materials, equipment or machinery or of carrying, storing, loading or unloading any explosive materials.
  - (e) For the purpose of any right of way whatsoever over the parking place other than for the purposes of parking or removing permitted motor vehicles shall be deemed to have been granted by the Council.
- (3) Where in the car park or any part thereof, signs are erected or surface markings are laid for the purpose of:
- (a) Indicating an entrance to or exit from the car park or any part thereof; or
  - (b) Indicating that a vehicle using the car park or any part thereof shall proceed in a specific direction within the car park or any part thereof
- No person shall drive or permit to be driven any vehicle:
- (i) so that it enters the car park or any part thereof, otherwise than by the entrance, leaves the car park or any part thereof, otherwise than by the exit, so indicated, or
  - (ii) in a direction other than so specified.

### **Restriction on use of Loading Bays**

12. (1) No person shall cause any vehicle to wait during the specified hours in the loading areas or loading bays specified in Schedule 9 during the specified hours.
- (2) Nothing in Section 12 (1) shall apply to any person causing a vehicle to wait in the loading areas or loading bays during the specified hours for so long as may be required to allow the vehicle to be loaded or unloaded.

### **Provision for Eating and Sleeping in Lorry Parks**

13. Nothing in Article 11 of this Order shall prevent any person from using any vehicle left in a parking place specified in Part 1 of Schedule 5 to this Order for eating or sleeping purposes.



## **Parked with Engine Running**

14. The driver of a vehicle using a Parking Place shall stop the engine as soon as the vehicle is in the parking space and shall not start the engine except when about to change the position that the vehicle is in or to depart from the Parking Place.

## **Contravention in use of Parking Places**

15. (1) If a vehicle is left in a parking place without complying with the requirements of this Order, a contravention shall have occurred and a penalty charge shall be payable. A penalty charge notice may then be issued and/or the vehicle may be removed from the location.
- (2) A notice fixed to a vehicle in accordance with Article 15 shall not be removed or interfered with except by or under the authority of:
- (a) The owner, or person in charge of the vehicle
  - (b) The council for the parking place in which the vehicle in question was found
- (3) The particulars given in the notice attached to a vehicle in accordance with this Order shall be treated as evidence in any proceedings relating to failure to pay such penalty charge.

## **Provision for the Payment of Parking Charges**

16. (1) Payment - The driver of a vehicle using a parking place shall upon leaving the vehicle in the parking place pay the appropriate charge (if any) in accordance with the scale of current charges as advertised at the parking place.
- (2) The driver of a vehicle using a parking place, or any parking space within the parking place, shall upon parking the vehicle in a parking space and prior to leaving the parking place, pay by any means prescribed by the council the level of charge for the period required in accordance with the scale of charges as advertised at that parking place.
- (3) The driver of a vehicle using a barrier controlled parking place, or any parking space within the barrier controlled parking place, shall prior to leaving the parking place, pay at a pay station, by any means prescribed by the council the level of charge for the period required in accordance with the scale of charges as advertised at that parking place.
- (4) Means of Payment - The charges referred to in Article 16 and Part 2 of schedules shall be payable by any means prescribed by the council, as advertised at that parking place.
- (5) Display of Ticket - Once a vehicle has been parked within a parking place the driver of the vehicle shall, unless payment has been made by any other means prescribed by the council and advertised at that parking place, ensure that a valid pay and display ticket has been obtained and is displayed at all times the vehicle is parked, to cover the entire period that the vehicle is parked in the parking place, and display the pay and display ticket issued at that parking place in the relevant position on the vehicle in respect of which it was issued. No ticket shall be displayed on a vehicle parked within a parking space in a barrier controlled parking place.
- (6) Validity of pay and display tickets:
- (a) A pay and display ticket is not transferable from one vehicle to another and on transfer the pay and display ticket ceases to be valid.
  - (b) A pay and display ticket or a payment by any other means prescribed by the Council is valid only in the parking place in which it was issued. This is defined by the reference code of the ticket machine located in that parking place printed on the pay and display ticket or the location reference number referred to when making payment by other means prescribed by the Council.
- (7) Expiry of parking period - Where a pay and display ticket has been obtained the expiry of the period for which the appropriate charge has been paid shall be indicated when the time shown on the clock of the issuing ticket machine is later than the expiry time shown on the pay and display ticket displayed. Where payment has been made by any other means prescribed by the council, the expiry of the parking period shall be noted at the point of payment by the payee.
- (8) No pay and display ticket displayed - If at any time while a vehicle is left in a parking place no pay and display ticket is displayed on that vehicle in the relevant position and in accordance with the provisions of Article 16(4), unless payment by any other means prescribed by the council has been recorded, it shall be deemed that the charge has not been paid unless the vehicle has been No ticket shall be displayed on a vehicle parked within a parking space in a barrier controlled parking place.
- (9) Ticket machine out of order - If at the time when a vehicle is left during the charging hours in a parking place and on the nearest ticket machine in that parking place there is a notice placed by any person duly authorised by the Council, indicating that the said ticket machine is out of order, then a ticket shall be obtained from another ticket machine within the same parking place (where provided). Where no valid pay and display ticket can be obtained and displayed, payment must be made by any other means prescribed by the council as advertised at that parking place. Should payment not be made by other means, it shall be deemed that the charge has not been paid.



- (10) Pay and display machines will accept overpayments, however change may not necessarily be given, neither will additional parking time be given. Payments by other means may incur a surcharge as set by third party providers.
- (11) If the driver of a vehicle is unable to leave a barrier controlled parking place because the ticket has been lost the driver of the vehicle shall be liable to pay a lost ticket charge in accordance with the Scale of Charges specified in Schedule 10.
- (12) Retention of a vehicle in the parking place specified in Part 1 of Schedule 10 during a period in which the parking place is closed will incur an additional cost as specified in Part 8 of Schedule 10.
- (13) If the driver of a vehicle is unable to leave a barrier controlled parking place due to an inability to pay the relevant charge the barrier will be raised on the issue of a penalty charge.

#### **Exemptions**

- 17. (1) No daily charge shall be payable in respect of:
  - (a) a vehicle which displays in the relevant position a valid disabled person's badge provided that the vehicle immediately before or after the act of parking has been used or is about to be used by the person(s) in respect of whom the badge is issued;
 

The disabled person's badge shall be displayed on the vehicle in a conspicuous position facing forward at the front of the vehicle, so that the information printed on the front of the badge and clock is clearly visible to a person standing in front of the vehicle. The clock must be set to the time of parking.
  - (b) a motor cycle; or
  - (c) a vehicle left displaying in a relevant position a valid parking permit or season ticket issued by the Council and valid for that parking place.
  - (d) any vehicle parked in an off-street parking place on a bank or public holiday.
  - (e) any electric vehicle parked within a parking place designated as a recharging point for electric vehicles, provided that the vehicle is connected via a recharging lead to the charging post installed in respect of the parking place.

#### **Provisions for Purchase of Parking Permits and Season Tickets**

- 18. (1) Employees of the Council and its partner agencies may, on application to the Council providing he/she has the appropriate permission in accordance with the approved scheme and on payment to the Council of a sum in accordance with a list of charges approved by the Council each year, obtain a parking permit. A parking permit so obtained shall permit the purchaser to park in one of the parking places listed in Part 1 of Schedules 4 and 10 to this Order as applicable to the permit type purchased, subject to any restrictions approved by the Council, providing that a Parking Permit so obtained shall not carry with it the guarantee of a reserved parking space.
- (2) The owner of a vehicle may, on application to the Council and on payment to the Council of a sum in accordance with Part 2 of Schedules 2, 3, 8 and 10 to this Order, obtain a season ticket. A season ticket so obtained shall permit the purchaser to park in any of the parking places listed in Part 1 of Schedules 2, 3, 8 and 10 to this Order, providing that a season ticket so obtained shall not carry with it the guarantee of a reserved parking space.

#### **Provisions for the Display of Parking Permits and Season Tickets**

- 19. (1) The driver of a vehicle, the maximum gross weight of which is less than that listed in Part 6 of Schedules 2, 3 and 4 having obtained a parking permit or season ticket in accordance with Article 18 of this Order shall display the parking permit or season ticket on the vehicle in a conspicuous position facing forward at the front of the vehicle, so that the information printed on the front of the said parking permit or season ticket is clearly visible to a person standing in front of the vehicle.
- (2) If a civil enforcement officer has reasonable cause to believe that a document or article carried on a vehicle or by the driver or person in charge of a vehicle, is a ticket or permit to which this Article applies, or is a document designed to resemble a ticket or permit, he may detain that ticket, document or permit, and may for that purpose require the driver or person in charge of the vehicle to deliver up the document or article.

### **Unexpired Pay and Display Ticket**

20. (1) Where a driver of a vehicle who has purchased a pay and display ticket leaves the parking place with his motor vehicle before the period of waiting has expired, the driver shall not pass his pay and display ticket to the driver of any other motor vehicle or to any other person and the other driver or person shall not accept his or her pay and display so that the other driver or person may take the benefit of any unexpired period of parking to which the original driver/purchaser of the pay and display ticket is entitled.
- (2) The driver of a motor vehicle may not transfer from one parking place to any other parking place without displaying a valid pay and display ticket obtained from each parking place or making a payment by any other means prescribed by the Council for each parking place.

### **Provisions for use of Ticket Boxes**

21. The driver of a vehicle the maximum gross weight of which exceeds 3.0 tonnes, having obtained a pay and display ticket in accordance with Article 16 of this Order, shall clearly write the registration number of the vehicle in the space provided on the pay and display ticket and shall then deposit the pay and display ticket in the ticket box provided by the Council at the parking place.

### **Alteration or Defacement of Pay and Display Ticket, Parking permit or Season Ticket**

22. No person shall knowingly exhibit on any vehicle, or deposit in the ticket box provided, any pay and display ticket, parking permit or season ticket which has been altered, defaced, mutilated or added to, or upon which the figures or particulars have become illegible.

### **Restrictions on Removal of Pay and Display Ticket, Parking Permit or Season Ticket**

23. (1) When a pay and display ticket, parking permit or season ticket has been exhibited on a vehicle in accordance with the provisions of Articles 16 and 19 of this Order, no person shall remove the pay and display ticket, parking permit or season ticket from the vehicle until the vehicle is removed from the Parking place.
- (2) When a parking ticket has been deposited in the ticket box provided in accordance with the provisions of Article 21 of this Order, no unauthorised person shall remove the parking ticket from the ticket box.

### **Provisions for Waiting without Payment of any Charge**

24. Nothing in this Order shall prevent any person from causing or permitting a vehicle to wait in any of the Parking places referred to in Part 1 of the Schedules to this Order for so long as may be necessary and without payment of any charge to enable the vehicle, if it cannot conveniently be used for such purpose in any other place, to be used in connection with the removal of any obstruction to traffic, or with the maintenance, improvement or reconstruction of the Parking places so referred to (subject to the prior written consent of the Council).

### **Provisions for Removal of Vehicles**

25. (1) When a vehicle is left in a parking place in contravention of any of the provisions of this Order, a person authorised by or on behalf of the Council for that purpose may remove the vehicle or arrange for its removal from that parking place.
- (2) A person authorised by or on behalf of the Council for that purpose may remove any unattached goods vehicle trailer or arrange for its removal from the Parking place to a safe place.
- (3) The standard charge specified in Part 4 of the schedules to this Order shall be paid before the collection of the vehicle or trailer can be effected.
- (4) The Council may dispose of any vehicle or trailer which has been removed or immobilised under the provisions of this Article, providing that a minimum of 14 working days have elapsed from the date of removal or immobilisation.
- (5) Any person removing a vehicle in accordance with this Article shall:
- (a) Do so by towing or driving the vehicle or in such other manner as may be considered necessary;
  - (b) Take such measures in relation to the vehicle as are considered necessary to enable it to be removed or its position to be altered as appropriate;
  - (c) Make such arrangements as may be necessary for the safe custody of the vehicle.

### **Provisions for Recharging Points**

26. (1) Subject to the provisions of this Order, each parking place designated as a recharging point shall only be used for the waiting of electric vehicles.
- (2) At all times whilst an electric vehicle is waiting in a recharging point, the driver shall cause that vehicle to be connected via a recharging lead to the charging post installed in respect of the parking place.
- (3) No person shall cause an electric vehicle to wait in a recharging point for longer the duration specified by the council.
- (4) No person shall cause an electric vehicle which has been removed after waiting in a recharging point to wait again in that recharging point within a period specified by the council.
- (5) Every vehicle waiting in a recharging point shall be caused to stand so that every part of the vehicle is within the marked limits of the recharging point.
