

**Walsall Metropolitan Borough Council (Consolidated)**  
**(Waiting, Loading, Stopping, Disabled Parking and Residents Parking)**  
**Amendment Order No.8, November 2012**

The Walsall Metropolitan Borough Council in exercise of its powers under Section 1(1) and (2), 2(1) to (3), 4(2), 32(1), 35(1), 45, 46, 49 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act, 1984 ("The Act") and of all enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

**Commencement and citation**

1. This Order shall come into operation on March 11, 2013, and may be cited as the "Walsall Metropolitan Borough Council (Consolidated) (Waiting, Loading, Stopping, Disabled Parking and Residents Parking) Amendment Order No.8, November 2012".

**Interpretation**

2. (1) In this Order, the "Plan Index" means the (sealed) sheet with that title, that records plans that are current for the purposes of interpretation of the Order;
- (2) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

**General**

3. Under this order, the Plan Index contained in the Walsall Metropolitan Borough Council (Consolidated) (Waiting, Loading, Stopping, Disabled Parking and Residents Parking) Order, July 2011 (as amended) shall be substituted by the Traffic Order Plan Index in this Order.
4. Under this Order, the following articles A8a and A8b shall be inserted into the Walsall Metropolitan Borough Council (Consolidated) (Waiting, Loading, Stopping, Disabled Parking and Residents Parking) Order July 2011 (as amended) after Article 8.

**Prohibition of Waiting by Goods Vehicles**

"A8a. Save as provided in Article A8b no person except upon the direction of a Police Officer in uniform or authorised person shall cause any goods vehicle with a maximum gross weight of 5 tonnes or over to wait at any time in the areas of carriageway shown by shading Type 1.2 on the plan, including areas of adjacent road."

"A8b. Nothing in article A8a shall apply to any person causing a vehicle with a maximum gross weight of 5 tonnes or over to wait at the edge of the carriageway in areas of carriageway shown by shading Type 1.2 on the plan for so long as may be required to allow the vehicle to be loaded or unloaded."

5. Under this Order, the following Articles B1a, B2a & B4a shall be inserted in the Walsall Metropolitan Borough Council (Consolidated) (Waiting, Loading, Stopping, Disabled Parking and Residents Parking) Order July (as amended) after Articles B1, B2 and B4 respectively.

"B1a. Save as provided in B2a, B5 and B6 no person shall cause any vehicle to wait during the specified hours of carriageway shown by shading Type 8.1 on the plan."

"B2a. Save as provided in Articles B3, B4a, B5 and B6 marked bays within the areas of carriageway shown by shading Type 8.1 on the plan are hereby authorised to be used as a parking place for vehicles of the specified class by holders of the relevant permit during the specified hours."

"B4a. Nothing in article B1a shall apply to any person causing a vehicle to wait within a marked bay in the areas of carriageway shown by shading Type 8.1 on the plan during specified hours for a period not exceeding the maximum period and provided that not less than the no return interval has elapsed since the vehicle was last waiting within the same area of carriageway; or the relevant permit is displayed in the front or nearside of vehicle so that all of the particulars specified in article B24 are readily visible from the front or near side of the vehicle."

6. Under this Order, Articles B3, and B5 to B10 inclusive contained within the Walsall Metropolitan Borough Council (Consolidated) (Waiting, Loading, Stopping, Disabled Parking and Residents Parking) Order July 2011 (as amended) shall be substituted by Articles B3, and B5 to B10 inclusive as below:-

"B3. No person shall cause a vehicle to wait in a parking place authorised in Article B2 and B2a:

- a. so as to unreasonably prevent access to any premises adjoining the road by any other person or so as to be a nuisance;
- b. when the Council has closed or suspended that parking place;

provided always that a Civil Enforcement Officer in uniform or a Police Officer may, at any time, require the vehicle to be moved if reasonably necessary or for the purpose of preventing obstruction."

"B5. Nothing in Articles B1, B1a, B2 & B2a shall apply to any person causing a vehicle to wait in the areas of carriageway shown by shading Type 8 and Type 8.1 on the plan upon the direction or with the permission of an authorised person, Civil Enforcement Officer in uniform or a Police Officer."

"B6. Nothing in Articles B1, B1a, B2 & B2a shall apply to any person causing a vehicle to wait within marked bays at the edge of the carriageway in an area of carriageway shown by shading Type 8 and Type 8.1 on the plan:-

- a. to enable a person to board or alight from the vehicle;
- b. to enable a vehicle to be loaded or unloaded from or to premises fronting the parking place;
- c. to enable a vehicle which bears the livery of a universal service provider to wait for so long as may be necessary for the purposes of the provision of a universal postal service (as defined in the Postal Services Act 2000);
- d. to enable the getting or giving of help in consequence of an accident or an emergency, or otherwise taking action for public safety;
- e. to enable the vehicle to be used in an emergency for fire brigade, police or ambulance purposes;
- f. to enable the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in the service of the Council in pursuance of statutory powers or duties;
- g. to enable the vehicle, if it cannot conveniently be used for such a purpose in any other road, to be used in connection with the removal of any obstruction to traffic or the maintenance, improvement or reconstruction of that length of road."

### **Power to Suspend Parking Places**

"B7. Nothing in Article B2 and B2a shall restrict the power of the Council to close, part close or suspend a parking place authorised in Article B2 and B2a."

"B8. An authorised person may suspend the use of all or any part of a parking place authorised in Article B2 and B2a whenever they consider it necessary:

- a. For the purposes of facilitating the movement of traffic or promoting its safety;
- b. For the convenience of the occupiers of premises adjacent to the parking place on any occasion of the moving of the furniture to or from the premises;



- c. For the convenience of occupiers of premises adjacent to the parking place at times of weddings or funerals, or on other special occasions;
- d. For the purpose of any building operation, demolition or excavation adjacent to the parking place or the laying, erection, alteration or repair in or adjacent to the parking place of any sewer or of any main, pipe or apparatus for the supply of gas, water, electricity or telecommunications services;

provided that signs are placed in or adjacent to the parts of the parking place which are suspended indicating that waiting by vehicles is prohibited."

"B9. Save as provided in Article B5, no person shall cause any vehicle to wait in a parking place which has been suspended by virtue of Article B8."

#### **Procedure for Removal of Vehicles**

"B10. Subject to the provisions of Article B11 an authorised person may arrange for the removal of a vehicle left in contravention of Articles B1, B1a, B2, B2a, B3, B4, B4a or B9 by towing, driving or other means."

- 7. Under this order, Schedule 3 contained in the Walsall Metropolitan Borough Council (Consolidated) (Waiting, Loading, Stopping, Disabled Parking and Residents Parking) Order, July 2011 (as amended) shall be substituted by Schedule 3 in this Order.
