THE BOROUGH OF WARRINGTON (TRAFFIC MANAGEMENT) (CIVIL ENFORCEMENT) (AMENDMENT NO. 113) CONSOLIDATION ORDER 2016

The Warrington Borough Council (hereinafter referred to as "the Council"), in exercise of their powers under Sections 1, 2, 4, 32, 35 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act"), and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order: -

- 1. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
- The Interpretation Act 1978 shall apply to the interpretation of this Order as it applies
 for the interpretation of an Act of Parliament and as if for the purposes of Section 21 of
 that Act this Order were an Act of Parliament and the Orders revoked by this Order
 were Acts of Parliament thereby repealed.
- 3. The making of this Order by the Council is done so under the duty imposed by Section 122(1) of The Road Traffic Regulation Act 1984 to secure the expeditious, convenient and safe movement of vehicular and other traffic and the provision of suitable and adequate parking facilities on and off the Highway, insofar as practicable having regard to the matters in Section 122(2) of the said Act.
- 4. The Orders specified in Column 1 of Schedule 1 to this Order are revoked to the extent as specified in Column 2 of that said Order.
- 5. The Order specified in Schedule 2 to this Order is hereby varied or amended as detailed in the said Schedule.
- 6. The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirements imposed by any regulations made or having effect as if made under the Act or by or under any other enactment.
- 7. This Order shall come into operation on the 3rd day of March 2016 and may be cited as "The Borough of Warrington (Traffic Management) (Civil Enforcement) (Amendment No. 113) Consolidation Order 2016".

SCHEDULE 2

The Borough of Warrington (Traffic Management) (Civil Enforcement) Consolidation Order 2008, is hereby further varied or amended as follows: -

(a) In the Sixth Schedule by the addition of: -

NO WAITING AT ANY TIME

Farrell Street (North West Side)	From the centre line of St. Katherines Way in a south westerly direction for a distance of 43 metres.
Farrell Street (North Side)	From the centre line of St. Katherines Way in an easterly direction for a distance of 127.8 metres.
Farrell Street (North Side)	From a point 219.2 metres east of the centre line of St. Katherines Way in an easterly direction to a point 274.3 metres east of the centre line of St. Katherines Way.
Farrell Street (South Side)	From a point 19 metres north east of its junction with Howley Lane to a point 175 metres east of the centre line of Holmsfield Road.
St Katherines Way	From its junction with Farrell Street in a northerly direction for a distance of 12 metres.

(b) In the Fifty Second Schedule by the addition of: -

NO WAITING BETWEEN THE HOURS OF 8:00AM TO 9:00AM AND 3:00PM TO 4:00PM, MONDAY TO FRIDAY

St Katherines Way (Both Sides)	From its junction with College Close in an easterly and southerly direction to a point 12 metres north of its junction with Farrell Street including both sides of the radius adjacent to properties 1 & 3 St. Katherines Way.
College Close (Both Sides)	From its junction with St. Katherines Way in a westerly direction for a distance of 24 metres.

(c) In the Fortieth Schedule by the addition of: -

DISABLED PERSONS PARKING PLACES

Areas of Highway Designated as Disabled Person's Parking Places. Each area described below in this column being an area forming part of the carriageway of a specified highway, as a Designated Disabled Person's Parking Place	Special Manner of Standing Of Vehicle in Parking Place
All that part of the northern kerbline of Farrell Street which is

carriageway of that highway as extends from a point 127.8 metres

Farrell Street (North Side)	From a point 274.3 metres east of the centre line of St. Katherines Way in an easterly direction for a distance of 24 metres.
