The Warwickshire County Council in exercise of its powers under section 1(1) and (2), 2(1) to (3) and 4(2) of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984, (hereinafter referred to as "the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

1. The Warwickshire County Council (District of Warwick) (Civil Enforcement Area) (Waiting Restrictions, On Street Parking Places and Residents' Parking) (Consolidation) Order 2017 (which said Order of 2017 is hereinafter referred to as 'the Principal Order') is hereby varied in the manner and to the extent hereinafter provided.
2. In Schedule 2 to the Principal Order, replace the revision numbers of the plans listed in column 1 of the Schedule below with the revision numbers listed in relation to those respective plans in column 2 of the Schedule below.
