**THE BOROUGH OF WATFORD (NORTH WATFORD) (PROHIBITION OF WAITING) ORDER 1972  
(AMENDMENT) (NO.1) ORDER 2017**

The Watford Borough Council, pursuant to arrangements made with Hertfordshire County Council ("the County Council") under Section 10 of the Local Government Act 2000 and the provisions of the Local Government (Arrangements for Discharge of Functions) (England) Regulations 2012, in exercise of the powers conferred on the said County Council by Sections 1, 2, 3 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, hereby makes the following Order:

1. This Order may be cited as THE BOROUGH OF WATFORD (NORTH WATFORD) (PROHIBITION AND RESTRICTION OF WAITING) ORDER 1972 (AMENDMENT) (NO.1) ORDER 2017 and shall come into operation on the 2<sup>nd</sup> day of October 2017.
2. The interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament
3. The prohibitions imposed by this Order shall be in addition to, and not in derogation of, any restriction or requirement imposed by any regulation made or having effect as if made under the Act or under any other enactment.
4. The BOROUGH OF WATFORD (NORTH WATFORD) (PROHIBITION AND RESTRICTION OF WAITING) ORDER 1972 (the "1972 Order") shall be amended in accordance with the Articles 5 to 7 of this Order.
5. The restriction referred to in Schedule 1 to this Order shall be deleted from Schedule 3 of the 1972 Order.
6. The restriction referred to in Schedule 2 to this Order shall be added to Schedule 3 of the 1972 Order.
7. The restriction referred to in Schedule 3 to this Order shall be added to Schedule 1 of the 1972 Order.

**SCHEDULE 1: DELETION FROM PROHIBITION AND RESTRICTION OF WAITING MON-SAT 8AM-6.30PM**

To be removed from Schedule 3 of the 1972 Order

| Street name    | Side of street | Location  |
|----------------|----------------|---|
| St Albans Road | East           | The east side, from a point 25 metres north of its junction with Windsor Road to a point 180 metres north of its junction with Buckingham Road. |

**SCHEDULE 2: ADDITION TO PROHIBITION AND RESTRICTION OF WAITING MON-SAT 8AM-6.30PM**

To be added to Schedule 3 of the 1972 Order

| Street name    | Side of street | Location  |
|----------------|----------------|---|
| St Albans Road | East           | From the northern kerb line of Buckingham Road to a point 0.5 metres south of the northern boundary of property number 386.   |
| St Albans Road | East           | From a point 0.5 metres north of the common boundary of property numbers 388 and 390 northward to a point 5.5 metres north of the common boundary of property number 396 and 398. |
| St Albans Road | East           | From a point 3 metres south of the common boundary of property numbers 400 and 402 northwards for a distance of 72 metres.  |

**SCHEDULE 3: ADDITION TO PROHIBITION AND RESTRICTION OF WAITING AT ANY TIME**

To be added to Schedule 1 of the 1972 Order

| Street name    | Side of street | Location   |
|----------------|----------------|--|
| St Albans Road | East           | From a point 0.5 metres south of the northern boundary of property number 386 northward for a distance of 7 metres.          |
| St Albans Road | East           | From a point 5.5 metres north of the common boundary of property number 396 and 398 northwards for a distance of 5.5 metres. |
