Watford Borough Council, pursuant to arrangements made under Section 19 Local Government Act 2000 and Local Authorities (Arrangements for the Discharge of Functions) (England) Regulations 2000 with the Hertfordshire County Council, and in exercise of the powers conferred on that County under Sections 1, 2(1), 2(2), 4, 45, 46(1), 49, 51, 53 and 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (“the Act of 1984”) and the Road Traffic Act 1991 and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. This Order shall come into operation on Monday 8<sup>th</sup> November 2021 and may be cited as The Borough of Watford (Watford) (Controlled Parking Zones) (Consolidation) Order 2018 (Amendment No.11) Order 2021.
2. In this Order, the expression “enactment” means any enactment, whether public general or local, and includes any order, byelaw, rule, regulation, scheme or other instrument having effect by virtue of an enactment and any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, the Borough of Watford (Watford) (Controlled Parking Zones) (Consolidation) Order 2018, “The Order of 2018”, shall have effect as though:
  - (a) Schedule B6 of the Order of 2018 were amended by the substitution in the Title and Sub Title of the wording “between 10:00am and 11:00am” by the wording “between 9:00am and 11:00am”.
  - (b) Article 78 (2) of the Order of 2018 were amended by the substitution of the wording “Zone U” by the wording “Zones U and W”
  - (c) Article 78 (3) of the Order of 2018 were omitted.
  - (d) Sub paragraphs (4) and (5) of Article 78 of the Order of 2018 were described as (3) and (4) respectively.
