THE BOROUGH OF WATFORD (WATFORD) (CONTROLLED PARKING ZONES) (CONSOLIDATION) ORDER 2018 (AMENDMENT) (NO. 9) ORDER 2022

Watford Council No. 700

The Watford Borough Council, pursuant to arrangements made under Section 19 of the Local Government Act 2000 and the Local Authorities (Arrangements for the Discharge of Functions) (England) Regulations 2012 with the Hertfordshire County Council, and in exercise of powers conferred on that County under Sections 1, 2, 4, 45, 46, 46A, 47, 49, 51 and 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and the Road Traffic Regulation Act 1991 and Part 6 of the Traffic Management Act 2004 and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, hereby makes the following Order:

- 1. This Order may be cited as THE BOROUGH OF WATFORD (WATFORD) (CONTROLLED PARKING ZONES) (CONSOLIDATION) ORDER 2018 (AMENDMENT) (NO.9) ORDER 2022 and shall come into operation on the 27th May 2022.
- 2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 3. The prohibitions imposed by this Order shall be in addition to, and not in derogation of, any restriction or requirement imposed by any regulation made or having effect as if made under the Act or by or under any other enactment.
- 4. THE BOROUGH OF WATFORD (WATFORD) (CONTROLLED PARKING ZONES) (CONSOLIDATION) ORDER 2018 (the "2018 Order") shall be amended in accordance with the Articles 5 to 6 of this Order.
- 5. The sides of road referred to in columns 1, 2 and 3 of the Schedule One to this Order shall be added to the parts of Schedules A1, A4, & A10 of the 2018 Order as are indicated in Schedule One to this Order.
- 6. The sides of road referred to in columns 1, 2 and 3 of the Schedule Two to this Order shall be deleted from the parts of Schedules A1, A4, A10 of the 2018 Order as are indicated in Schedule Two to this Order.
