Watford Borough Council, pursuant to arrangements made under Section 19 of the Local Government Act 2000 and the Local Government (Arrangements for Discharge of Functions) (England) Regulations 2012 with the Hertfordshire County Council, and in exercise of the powers conferred on that County under sections 1, 2, 4, 32, 35, 45, 46, 46A, 47, 49, 51, 53 and 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and the Road Traffic Act 1991 and Part 6 of The Traffic Management Act 2004 and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:

PART 1 - PRELIMINARY

Citation and commencement

- 1 This Order shall come into operation on 7th June 2021 and may be cited as the Borough of Watford (Watford) (Controlled Parking Zones) Minor Order 2021.
- 2 The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
- 4 The Borough of Watford (Watford) (Controlled Parking Zones) (Consolidation) Order 2018 referred to as the '2018 Order' shall be amended in accordance with the Articles 5 to 9 of this Order.
5. Article 2 of the '2018 Order' shall be amended by the addition of the following:-
"pay by phone facility" means a "ticket parking meter" equipped for a phone facility whereby the person using a parking place may make and record the appropriate payment for that use;".
6. Article 13 of the '2018 Order' shall be amended by the addition of paragraph (3) (g) "(g) or for which payment of an initial charge has been made via pay by phone in parking places with pay by phone facilities".
7. Article 14 of the '2018 Order' shall be amended by the addition of the text "or for which a payment of the initial charge has been made by pay by phone in parking places with pay by phone facilities" after the text "a valid parking ticket".
8. Article 40 of the '2018 Order' shall be amended by the addition of paragraph (3) " (3) The provisions of this Article shall not apply where a payment of the initial charge has been made by pay by phone in parking places with pay by phone facilities."

9. Article 42 of the '2018 Order' shall be amended by the addition of the text "or by payment using a pay by phone facility" at the end of paragraph (1) and by the addition of paragraph (5) "(5) paragraph (2) shall not apply if payment has been made by pay by phone."
