

## WATFORD BOROUGH COUNCIL

### THE BOROUGH OF WATFORD (HOLYWELL ESTATE) (PROHIBITION OF WAITING) ORDER 2004 (AMENDMENT) (NO.1) ORDER 2017

The Watford Borough Council, pursuant to arrangements made with Hertfordshire County Council ("the County Council") under Section 10 of the Local Government Act 2000 and the provisions of the Local Government (Arrangements for Discharge of Functions) (England) Regulations 2012, in exercise of the powers conferred on the said County Council by Sections 1, 2, 3 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, hereby makes the following Order:

1. This Order may be cited as THE BOROUGH OF WATFORD (HOLYWELL ESTATE) (PROHIBITION OF WAITING) ORDER 2004 (AMENDMENT) (NO.1) ORDER 2017 and shall come into operation on the 18<sup>th</sup> day of December 2017.
2. The interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. The prohibitions imposed by this Order shall be in addition to, and not in derogation of, any restriction or requirement imposed by any regulation made or having effect as if made under the Act or under any other enactment.
4. THE BOROUGH OF WATFORD (HOLYWELL ESTATE) (PROHIBITION OF WAITING) ORDER 2004 (the "2004 Order") shall be amended in accordance with the Articles 5 and 6 of this Order.
5. The restriction referred to in Schedule 1 to this Order shall be deleted from Schedule 1 of the "2004 Order".
6. The restriction referred to in Schedule 2 to this Order shall be added to Schedule 1 of the "2004 Order".

#### SCHEDULE 1: DELETION FROM PROHIBITION AND RESTRICTION OF WAITING AT ANYTIME

To be removed from Schedule 1 of the "2004 Order"

Street name	Side of street	Location
Scammell Way	North	From its junction with the eastern arm of Crusader Way eastward for a distance of 15 metres.
	North	From its junction with the western arm of Crusader Way north westward for a distance of 15 metres.
	South	From the service road entrance of Skye House westward for a distance of 8 metres.
	South	From the service road entrance of Alderney House south eastward for a distance of 8 metres.
Crusader Way (western arm)	North west	From its junction with Scammell Way north eastward for a distance of 10 metres.
	South east	From its junction with Scammell Way north eastward for a distance of 10 metres.
Crusader Way (eastern arm)	North west	From its junction with Scammell Way northward for a distance of 10 metres.
	South east	From its junction with Scammell Way northward for a distance of 10 metres.

**SCHEDULE 2: ADDITION TO PROHIBITION AND RESTRICTION OF WAITING AT ANYTIME**

To be added to Schedule 1 of the "2004 Order"

Street name	Side of street	Location
Scammell Way	North	From its junction with the eastern arm of Crusader Way for a distance of 23.5 metres in an eastward direction.
	North	From its junction with the western arm of Crusader Way for a distance of 29 metres in a north westward direction.
	South	From the service road entrance of Skye House for a distance of 28 metres in a westward direction.
	South	From the service road entrance of Alderney House for a distance of 16.5 metres in a south eastward direction.
Crusader Way (western arm)	North west	From its junction with Scammell Way for a distance of 14.5 metres in a north eastward direction.
	South east	From its junction with Scammell Way for a distance of 14.5 metres in a north eastward direction.
Crusader Way (eastern arm)	North west	From its junction with Scammell Way for a distance of 14.5 metres in a northward direction.
	South east	From its junction with Scammell Way for a distance of 14.5 metres in a northward direction.
