THE BOROUGH OF WATFORD (OFF-STREET PARKING PLACES) ORDERS (AMENDMENT) ORDER 2020

TRO No. 902

The Watford Borough Council (hereinafter referred to as "the Council") in exercise of the powers conferred by Sections 32, 35, 35A and 124 of the Road Traffic Regulation Act 1984 ("the 1984 Act") and Schedule 3 of the Road Traffic Act 1991 ("the 1991 Act") and in accordance with the provisions of Part 6 of The Traffic Management Act 2004 and Part IV of Schedule 9 of the Act of 1984 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby make the following Order.

- 1. This Order shall come into operation on 27th July 2020 and may be cited as "The Borough of Watford (Off-Street Parking Places) Orders (Amendment) Order 2020.
- 2. The provisions of The Borough of Watford (Watford Museum Car Park) (Off-Street Parking Place) Order 2015 ("the 2015 Order") are hereby amended in accordance with Articles 3 and 11 of this Order.
- 3. In Article 2 (1) of the 2015 Order the definition "permit" shall be amended by the replacement of the words "Article 9" by the words "Article 10".
- 4. The provisions of The Borough of Watford (Off-Street Parking Places) Order 2019 ("the 2019 Order") are hereby amended in accordance with Articles 5 to 9 of this Order.
- 5. In Article 2 (a) of the 2019 Order the definition "valid" shall be amended by the addition of the paragraph "(iv) the permit is issued for the particular parking place as indicated by Column 1 of Schedules 1 and 3".
- In Article 2 (a) of the 2019 Order the definition "Penalty Charge" shall be substituted by
 - "Penalty Charge" and "Reduced Penalty Charge" have the same meaning as the charges set by the Council in accordance with The Civil Enforcement of Parking Contraventions (Guidelines on Levels of Charges) (England) Order 2007 and the provisions of Part 6 and Schedule 9 of the Traffic Management Act 2004",

and the following definition shall be added:

""penalty charge notice" has the same meaning as given in Regulation 8 of The Civil Enforcement of Parking Contraventions (England) General Regulations 2007".

- Article 9 (d) of the 2019 Order shall be amended by the addition of "or as recorded by a Pay by Phone facility" after "by a ticket machine".
- 8. In Article 13 of the 2019 Order the present paragraph c. shall be identified as paragraph c (i) and paragraph c (ii) added as follows:- c (ii) In respect of the Bushey Arches Car Park applicants from property nos. 1 31 Chalk Hill and flats above nos. 33 55 Chalk Hill, Ye Corner, Attenborough Court and Nos. 9 35 Aldenham Avenue may apply for and receive one permit per household subject to such terms and conditions as the Council shall deem appropriate.
- 9. In Schedule1 of the 2019 Order under the heading Shaftesbury Road Parking Place the wordings 'Mondays to Saturdays' in Column 4 shall be replaced by 'Mondays to Sundays' and the wordings '8 am to 6.30 pm' in Column 5 shall be replaced by '8.00 am to 10.00 pm'.
- 10. The provisions of The Borough of Watford (Watford Leisure Centre Woodside and Woodside Stadium and Playing Fields, Watford) (Off-Street Parking Place) Order 2020 ("the 2020 Order") are hereby amended in accordance with Articles 11 to 16 of this Order.
- 11. The following items shall be added to Article 2 (1) of the 2015 Order and to Article 2 (1) of the 2020 Order:-

""penalty charge" and "reduced penalty charge" have the same meaning as the charges set by the Council in accordance with The Civil Enforcement of Parking Contraventions (Guidelines on Levels of Charges) (England) Order 2007 and the provisions of Part 6 and Schedule 9 of the Traffic Management Act 2004.",

""penalty charge notice" has the same meaning as given in Regulation 8 of The Civil Enforcement of Parking Contraventions (England) General Regulations 2007."

- 12. In Article 2 (1) of the 2020 Order the definition "operating times" shall be amended by the replacement of the wording "Article 9" by the wording "Article 15", the definitions "permit" and "permit holder" shall be amended by the replacement of the wording "Article 10" by the wording "Article 16", the definition "ticket" shall be amended by the replacement of the wording "Article 6 (1)" by the wording "Article 6" and the definition "valid" shall be amended by the addition of the paragraph "(d) the permit is issued for the particular parking place as indicated by Column 1 of Schedules 1 and 2".
- 13. In Article 4 (h) of the 2020 Order the numerical expression "6" shall be replaced by the wording "Article 6".
- 14. In Article 5 of the 2020 Order the heading shall be amended by the addition of the word "place" after the word "parking" and in paragraph (1) the words "in putting" shall be replaced by the word "inputting".

- 15. Paragraph (3) of Article 5 and paragraph (1) of Article 8 of the 2020 Order shall be deleted.
- 16. In Schedule 1 of the 2020 Order under the heading "Watford Leisure Centre, Woodside Obtain and Display Disabled Parking Bays the text "Comprises of parking bays 01-19 inclusive" shall be substituted by "Comprises of parking bays 01-04 and 07-19 inclusive".
- 17. The Borough of Watford (Bushey Arches, Watford) (Off-street Parking Places) Order 2016 as amended is hereby revoked.
- 18. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
