THE BOROUGH OF WATFORD (RADLETT ROAD ESTATE, WATFORD) (PROHIBITION & RESTRICTION OF WAITING) ORDER 2016 (AMENDMENT) (NO.1) ORDER 2017

The Watford Borough Council, pursuant to arrangements made with Hertfordshire County Council ("the County Council") under Section 10 of the Local Government Act 2000 and the provisions of the Local Government (Arrangements for Discharge of Functions) (England) Regulations 2012, in exercise of the powers conferred on the said County Council by Sections 1, 2, 3 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, hereby makes the following Order:

1. This Order may be cited as THE BOROUGH OF WATFORD (RADLETT ROAD ESTATE, WATFORD) (PROHIBITION & RESTRICTION OF WAITING) ORDER 2016 (AMENDMENT) (NO.1) ORDER 2017 and shall come into operation on the 18th day of December 2017.
2. The interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. The prohibitions imposed by this Order shall be in addition to, and not in derogation of, any restriction or requirement imposed by any regulation made or having effect as if made under the Act or under any other enactment.
4. THE BOROUGH OF WATFORD (RADLETT ROAD ESTATE, WATFORD) (PROHIBITION & RESTRICTION OF WAITING) ORDER 2016 (the "2016 Order") shall be amended in accordance with the Articles 5, 6 and 7 of this Order.
5. The restriction referred to in Schedule 1 to this Order shall be deleted from Schedule 3 of the "2016 Order".
6. The restriction referred to in Schedule 2 to this Order shall be added to Schedule 3 of the "2016 Order".
7. The restriction referred to in Schedule 3 to this Order shall be added to Schedule 1 of the "2016 Order".

To be removed from Schedule 3 of the "2016 Order"
