TRAFFIC REGULATION ORDER

THE BOROUGH OF WATFORD (ROSSLYN ROAD) (PROHIBITION AND RESTRICTION OF WAITING) (AMENDMENT NO.1) ORDER 2018

Coming into operation on... 7th day of May 2018

Watford Borough Council, pursuant to arrangements made under Section 19 of the Local Government Act 2000(a) and the Local Government (Arrangements for Discharge of Functions) (England) Regulations 2000(b) with the Hertfordshire County Council, and in exercise of the powers conferred on that County Council under Sections 1, 2(1), 2(2), 4, 45, 46(1), 49, 51, 53 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984(c) ("the Act of 1984") and the Road Traffic Act 1991(d) and of all other enabling powers, and after consulting with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. This Order shall come into operation on the 7th day of May 2018 and may be cited as The Borough of Watford (Rosslyn Road) (Prohibition and Restriction of Waiting) (Amendment No. 1) Order 2018.
2. In this Order, the expression "enactment" means any enactment, whether public general or local, and includes any order, byelaw, rule, regulation, scheme or other instrument having effect by virtue of an enactment and any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, the Hertfordshire (Rosslyn Road, Watford) (Restriction of Waiting) Order 2012(e) shall have effect as though that part of the item in the Schedule to that Order that relates to a length of road on the north-east side of Rosslyn Road were hereby omitted.
4. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, the Borough of Watford (South Watford) (Prohibition & Restriction of Waiting) (Consolidation) Order, 1974(f) shall have effect as though that part of the item in Schedule 1 to that Order that relates to a length of road on the north-east side of Rosslyn Road were hereby omitted.

Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, the Borough of Watford (Central Watford Area) (One Way Traffic, No Waiting At Any Time and Removal of Coach Bays) Order 2003(g) shall have effect as though that part of the item in Schedule 2 to that Order that relates to a length of road on the north-east side of Rosslyn Road were hereby omitted.
6. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, the Borough of Watford (Rosslyn Road) (Prohibition of Waiting) Order 1977(h) is hereby revoked.
