## THE BOROUGH OF WATFORD (WATFORD CENTRAL AREA AND WEST WATFORD) (CONTROLLED PARKING ZONES) (CONSOLIDATION) ORDER 2010 (AMENDMENT) (NO.2) ORDER 2017

The Watford Borough Council, pursuant to arrangements made with Hertfordshire County Council ("the County Council") under Section 10 of the Local Government Act 2000 and the provisions of the Local Government (Arrangements for Discharge of Functions) (England) Regulations 2012, in exercise of the powers conferred on the said County Council by Sections 1, 2, 4, 45, 46, 47, 49, 51 and 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, herby makes the following Order:

- This Order may be cited as THE BOROUGH OF WATFORD (WATFORD CENTRAL AREA AND WEST WATFORD) (CONTROLLED PARKING ZONES) (CONSOLIDATION) ORDER 2010 (AMENDMENT) (NO.2) ORDER 2017 and shall come into operation on the 18<sup>th</sup> day of December 2017.

- The prohibitions imposed by this Order shall be in addition to, and not in derogation of, any restriction or requirement imposed by any regulation made or having effect as if made under the Act or under any other enactment.
