## **THE BOROUGH OF WATFORD (WATFORD CENTRAL AREA AND WEST WATFORD) (CONTROLLED PARKING ZONES) (CONSOLIDATION) ORDER 2010 (ST ALBANS ROAD) (AMENDMENT) (NO. 19) ORDER 2017**

**Watford Council No. 681**

The Watford Borough Council, pursuant to arrangements made under Section 19 of the Local Government Act 2000 and the Local Government (Arrangements for Discharge of Functions) (England) Regulations 2012 with the Hertfordshire County Council, and in exercise of powers conferred on that County under Sections 1, 2, 4, 32, 35, 45, 46, 46A, 47, 49, 51 and 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and the Road Traffic Regulation Act 1991 and Part 6 of the Traffic Management Act 2004 and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, hereby makes the following Order:

1. This Order may be cited as THE BOROUGH OF WATFORD (WATFORD CENTRAL AREA AND WEST WATFORD) (CONTROLLED PARKING ZONES) (CONSOLIDATION) ORDER 2010 (ST ALBANS ROAD) (AMENDMENT) (NO. 19) ORDER 2017 and shall come into operation on 17th April 2017.
2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. The prohibitions imposed by this Order shall be in addition to, and not in derogation of, any restriction or requirement imposed by any regulation made or having effect as if made under the Act or by or under any other enactment.
4. The BOROUGH OF WATFORD (WATFORD CENTRAL AREA AND WEST WATFORD) (CONTROLLED PARKING ZONES) (CONSOLIDATION) ORDER 2010 (the "2010 Order") shall be amended in accordance with the Articles 5 to 13 of this Order.
5. Article 8 of the 2010 Order shall be amended as follows:
  - a). In sub paragraph (1) "Schedules 17, 18, 19 and 20" shall be replaced by "Schedules 17, 18, 19, 20 and 20A".
  - c). new sub paragraph 2(e) shall be added as follows:-  
 "2(e) as referred to by Schedule 20A, between 8.00 and 9.30 am and between 5.00 and 6.30 pm on any day."
6. Article 9 of the 2010 Order shall be amended as follows:
  - a). In sub paragraph (1) "Schedules 21, 21A and 22" shall be replaced by "Schedules 21, 21A, 21B and 22".
  - b). sub paragraph 2(c) shall be referred to as 2(d),
  - c). new sub paragraph 2(c) shall be added as follows:-  
 "2(c) as referred to by Schedule 21B, between 7 am and 7 pm except in accordance with paragraph (3),"
7. Article 30 of the 2010 Order shall be amended by the addition in sub paragraph (a) of a reference to Schedule 21B and Article 34 shall be amended by the addition in sub paragraph (a) of a reference to Schedules 20A, 21A and 21B.
8. The sides of road referred to in columns 1, 2 and 3 of the Schedule One to this Order shall be added to the parts of Schedules 1, 16 and 20 of the 2010 Order as are indicated in Schedule One to this Order.



9. The sides of road referred to in columns 1, 2 and 3 for the maximum stay in column 4 of the Schedule One to this Order shall be added to Schedule 9 of the 2010 Order as are indicated in Schedule One to this Order.
10. Add Schedule 2 of this Order to the 2010 Order as Schedule 20A
11. Add Schedule 3 of this Order to the 2010 Order as Schedule 21B.
12. Schedule 26 of the 2010 Order shall be amended as follows:-  
Under the heading 'CPZ Standard Zones' -  
in Parking Zone A 'St. Albans Road (eastern side, between No. 12 and No. 70)' shall be replaced by 'St Albans Road (eastern side, between Beechen Grove and the south side of the railway bridge)' and  
in Parking Zone D 'St. Albans Road (western side, from No. 35 to No. 147)' shall be replaced by 'St Albans Road (western side, from The Avenue to the south side of the railway bridge)'
13. The following Orders or Schedules thereof are revoked in so far as they refer to St Albans Road, south of the railway bridge:-
