**THE BOROUGH OF WATFORD (WATFORD MUSEUM - OFF-STREET
PARKING PLACE) ORDER 2015
(AMENDMENT) (NO. 1) ORDER 2020**

Watford Council No. 856

The Watford Borough Council, in exercise of the powers conferred under sections 32, 35, 35A and 124 to the Road Traffic Regulation Act 1984 ("the 1984 Act") and Part IV of Schedule 9 of the Act of 1984 and Schedule 3 of the Road Traffic Act 1991 ("the 1991 Act") and in accordance with the provisions of Part 6 of the Traffic Management Act 2004 and of all other enabling powers, and after consulting with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, hereby makes the following Order:-

1. This Order may be cited as The Borough of Watford (Watford Museum - Off-Street Parking Place) Order 2015 (Amendment) (No 1.) Order 2019 and shall come in to operation on 1st April 2020.
2. The provisions of The Borough of Watford (Watford Museum - Off-Street Parking Place) Order 2015 shall be amended in accordance with Articles 3 to 5 of this Order.
3. Article 2 shall be amended as follows:-

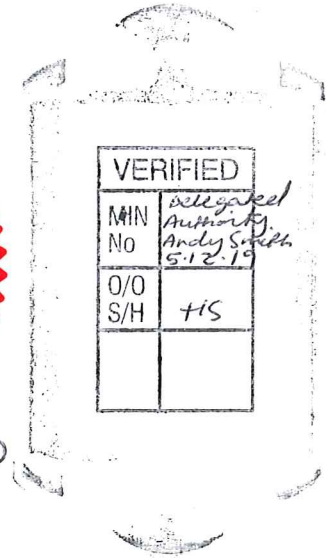
"Penalty Charge" and "Reduced Penalty Charge" shall have the same meaning as a charge set by the Council in accordance with The Civil Enforcement of Parking Contraventions (Guidelines on Levels of Charges) (England) Order 2007 and the provisions of Part 6 and Schedule 9 of the 2004 Act.
4. Schedule 1 to the 2015 Order shall be substituted by the Schedule to this Order.
5. Plan Number TRO/792/WBC/JY/01 which accompanied the 2015 Order shall be substituted with Plan number WBC/TRO/856/JY/01 attached to this Order.
6. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
7. The prohibitions imposed by this Order shall be in addition to, and not in derogation of, any restriction or requirement imposed by any regulation made or having effect as if made under the Act of 1984 by or under any other enactment.
