Watford Borough Council, pursuant to arrangements made under Section 19 of the Local Government Act 2000(a) and the Local Government (Arrangements for Discharge of Functions) (England) Regulations 2000(b) with the Hertfordshire County Council, and in exercise of the powers conferred on that County under Sections 1, 2(1), 2(2), 4, 45, 46(1), 49, 51, 53 and 124 of and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984(c) ("the Act of 1984") and the Road Traffic Act 1991(d) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. This Order shall come into operation on the 7<sup>th</sup> day of May 2018 and may be cited as The Borough of Watford (Watford) (Controlled Parking Zones) (Consolidation) Order 2018 (Amendment No. 1) Order 2018.
2. In this Order, the expression "enactment" means any enactment, whether public general or local, and includes any order, byelaw, rule, regulation, scheme or other instrument having effect by virtue of an enactment and any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, the Borough of Watford (Watford) (Controlled Parking Zones) (Consolidation) Order 2018 ("The Order of 2018")(e) shall have effect as though:
  - (a) in Article 2 to that Order, in the assignment of meaning to the words "entitled business user", for the words "except parking zone H" there were substituted the words "except parking zone H or Rosslyn Road";
  - (b) there were added to the part of Schedule A1 to that Order headed "Waiting Prohibited At Any Time: Watford Central Area Vicarage: Zone G" the item set out in columns 1, 2 and 3 of Schedule 1 to this Order;

- (c) there were added to the part of Schedule B1 to that Order headed "Parking Bays for Permit Holders Only: Monday to Saturday inclusive: 8.00 am to 6.30 pm Watford Central Area Vicarage: Zone G" the item set out in columns 1, 2 and 3 of Schedule 2 to this Order; and
- (d) there were added to Schedule E1 to that Order, under the heading "parking Zone G", under the heading "The CPZ Standard Zone" the following:

"Rosslyn Road (excluding Ballinger Court and The Beeches)".

Rosslyn Road	north-east side	Between the south-eastern kerb-line of Rickmansworth Road and a point 8 metres north-west of a point opposite the common boundary of No. 4 and Nos. 6 to 8 Rosslyn Road
Rosslyn Road	north-east side	Between a point 13 metres south-east of a point opposite the common boundary of No. 4 and Nos. 6 to 8 Rosslyn Road and a point 16.5 metres south-east of a point opposite that common boundary
Rosslyn Road	north-east side	Between a point 18 metres south-east of a point opposite the common boundary of Nos. 14 and 16 Rosslyn Road and the northern kerb-line of Upton Road

Rosslyn Road	north-east side	Between a point 16.5 metres south-east of a point opposite the common boundary of No. 4 and Nos. 6 to 8 Rosslyn Road and a point 18 metres south-east of a point opposite the common boundary of Nos. 14 and 16 Rosslyn Road
