THE BOROUGH OF WATFORD (WATFORD) (CONTROLLED PARKING ZONES) (CONSOLIDATION) ORDER 2018 (AMENDMENT NO.2) ORDER 2018

The Watford Borough Council, pursuant to arrangements made with Hertfordshire County Council ("the County Council") under Section 10 of the Local Government Act 2000 and the provisions of the Local Government (Arrangements for Discharge of Functions) (England) Regulations 2012, in exercise of the powers conferred on the said County Council by Sections 1, 2, 4, 45, 46, 47, 49, 51 and 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, herby makes the following Order:

- This Order may be cited as THE BOROUGH OF WATFORD (WATFORD) (CONTROLLED PARKING ZONES) (CONSOLIDATION) ORDER 2018 (AMENDMENT NO.2) ORDER 2018 and shall come into operation on the 16th day of July 2018.
- 2. The interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament
- 3. The prohibitions imposed by this Order shall be in addition to, and not in derogation of, any restriction or requirement imposed by any regulation made or having effect as if made under the Act or under any other enactment.
