

**WATFORD BOROUGH COUNCIL**

**THE BOROUGH OF WATFORD (VARIOUS ROADS INCLUDING GREYCAINE ROAD, WATFORD)  
(PROHIBITION & RESTRICTION OF WAITING) ORDER 2013 (AMENDMENT) (NO.1) ORDER 2018**

The Watford Borough Council, pursuant to arrangements made with Hertfordshire County Council ("the County Council") under Section 10 of the Local Government Act 2000 and the provisions of the Local Government (Arrangements for Discharge of Functions) (England) Regulations 2012, in exercise of the powers conferred on the said County Council by Sections 1, 2, 3 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, hereby makes the following Order:

1. This Order may be cited as THE BOROUGH OF WATFORD (VARIOUS ROADS INCLUDING GREYCAINE ROAD, WATFORD) (PROHIBITION & RESTRICTION OF WAITING) ORDER 2013 (AMENDMENT) (NO.1) ORDER 2018 and shall come into operation on the 16<sup>th</sup> day of July 2018.
2. The interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. The prohibitions imposed by this Order shall be in addition to, and not in derogation of, any restriction or requirement imposed by any regulation made or having effect as if made under the Act or under any other enactment.
4. THE BOROUGH OF WATFORD (VARIOUS ROADS INCLUDING GREYCAINE ROAD, WATFORD) (PROHIBITION & RESTRICTION OF WAITING) ORDER 2013 (the "2013 Order") shall be amended in accordance with the Articles 5, 6 and 7 of this Order.
5. The restriction referred to in Schedule 1 to this Order shall be deleted from Schedule 2 of the "2013 Order".
6. The restriction referred to in Schedule 2 to this Order shall be added to Schedule 2 of the "2013 Order".
7. The restriction referred to in Schedule 3 to this Order shall be added to Schedule 1 of the "2013 Order".

**SCHEDULE 1: DELETION FROM WAITING PROHIBITED MONDAY TO SATURDAY 8AM-6.30PM**

To be removed from Schedule 2 of the "2013 Order"

Horseshoe Lane	Both	From a point in line of the western kerb line of the A405 North Orbital Road westwards to a point 12 metres west of a point on the line of the western kerb line of The Glebe.
The Glebe	West	From a point on the line of the north kerb line of Horseshoe Lane northwards for a distance of 15 metres.
	East	From a point on the line of the north kerb line of Horseshoe Lane northwards for a distance of 20 metres.

	North	From a point in line of the western kerb line of the A405 North Orbital Road westwards to a point 1.5 metres west of the common boundary of property numbers 23 & 25.
	North	From a point 5.5 metres west of the common boundary of property numbers 27 & 29 westward to a point 12 metres west of a point on the line of the western kerb line of The Glebe.
The Glebe	East	From a point 11 metres north of the junction of Horseshoe Lane northwards for a distance of 9 metres.
	West	From a point 11 metres north of the junction of Horseshoe Lane northwards to the junction of All Saints Crescent.
All Saints Crescent	South	From a point in line with the easternmost wall of No. 1 All Saints Crescent eastward to the junction with The Glebe.

The Glebe	East	From the junction of Horseshoe Lane northwards for a distance of 11 metres.
	West	From the junction of Horseshoe Lane northwards for a distance of 11 metres.
