THE BOROUGH OF WATFORD (SOUTH WATFORD) (PROHIBITION  
AND RESTRICTION OF WAITING) (CONSOLIDATION) (AMENDMENT)  
(No.2) ORDER, 1977

The Watford Borough Council pursuant to arrangements made under Section 101 of the Local Government Act 1972 with the County Council of Hertfordshire, in exercise of the powers of the said County Council under Section 1(1), (2), (3) and 84D of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974 (which said Act of 1967 as so amended is hereinafter referred to as "the Act of 1967") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Section 84C(1) of the Act of 1967 hereby make the following Order:-

1. Schedule 1 to the Borough of Watford (South Watford) (Prohibition and Restriction of Waiting) (Consolidation) Order, 1974 is hereby amended such that -

(i) paragraph (a) on Page 5 relating to Church Street shall read as follows:-

"the west and north-west side from its junction with George Street to its junction with New Street."

(ii) the paragraph on Page 6 relating to George Street shall read as follows:-

"the west side from its junction with Church Street to its junction with King Street."

2. Schedule 2 to the Borough of Watford (South Watford) (Prohibition and Restriction of Waiting) (Consolidation) Order, 1974 is hereby amended such that the paragraph on Page 11 relating to Church Street shall read as follows:-

"the east and south-east side from its junction with George Street in a north-westerly and thence north-easterly direction for a distance of 109 metres."

3. The Interpretation Act 1889 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament, and as if for the purposes of Section 38 of that Act this Order were an Act of Parliament and the Order amended by Articles 1 and 2 of this Order were an Act of Parliament thereby varied.

4. This Order shall come into operation on the 1st day of August, 1977 and may be cited as the Borough of Watford (South Watford) (Prohibition and Restriction of Waiting) (Consolidation) (Amendment) (No.2) Order, 1977.
