**WATFORD BOROUGH COUNCIL**

**TRAFFIC REGULATION ORDER**

**2006 NO. 716**

**THE BOROUGH OF WATFORD  
(PROHIBITION OF STOPPING & RESTRICTION OF  
WAITING OUTSIDE SCHOOLS) (AMENDMENT) ORDER 2006**

The Watford Borough Council, pursuant to arrangements made under Section 19 of the Local Government Act 2000 and the Local Government (Arrangements for Discharge of Functions) (England) Regulations 2000 with the Hertfordshire County Council, and in exercise of powers conferred on that County under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

1. This Order may be cited as The Borough of Watford (Prohibition of Stopping & Restriction of Waiting Outside Schools) (Amendment) Order 2006 and shall come into operation on the 18<sup>th</sup> May 2006.
2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. The restrictions imposed by this Order shall be in addition to, and not in derogation of, any restriction or requirement imposed by any regulation made or having effect as if made under the Act or by or under any other enactment.
4. Article 2(1) of The Borough of Watford (Prohibition of Stopping & Restriction of Waiting Outside Schools) Order 2000 the "2000 Order" is amended by the substitution of:

" "disabled person's badge" has the same meaning as in Section 142 (1) of the Act of 1984 " and " "disabled person's vehicle" has the same meaning as in Section 142 (1) of the Act of 1984 "

by

" "disabled person's badge" and "disabled person's vehicle" have the same meaning as in The Local Authorities Traffic Orders (Exemptions for Disabled Persons) (England and Article 2 of The Borough of Watford (Prohibition of Stopping & Restriction of Waiting Outside Schools) Regulations 1986 and The Disabled Persons (Badges for Motor Vehicles) Amendment Regulations 1992 and as amended by The Local Authorities Traffic Orders (Exemption for Disabled Persons) (England) Regulations 2000. "
5. Article 2(1) of the "2000 Order" is amended by the addition of :-

" "designated officer" has the same meaning as in Article 2 of the Borough of Watford (Watford Central Area and West Watford) (Controlled Parking Zones) (Consolidation) Order 2002. "

and " "Watford Special Parking Area" means the area designated in Article 4 of The Road Traffic (Permitted Parking Area and Special Parking Area) (County of Hertfordshire) (Borough of Watford) Order 1997. "
6. Articles 3 and 4 of the "2000 Order" are amended by the substitution of "Police Constable in uniform" by "designated officer".



7. Article 4A shall be added to the "2000 Order" as follows:

"4A Save as provided in Articles 5, 6 and 7 of this Order, no person shall, except upon the direction or with the permission of a designated officer, cause or permit any vehicle to stop between the hours of 8.30 am to 9.30 am and 2.30 pm to 4.00 pm on Monday to Friday inclusive on the sides of road or the lengths of road referred to in Schedule 3 of this Order".

8. The Borough of Watford (North Watford) (Prohibition and Restriction of Waiting) Order 1992 is amended by the deletion of Schedule 2 to that Order.

9. The "2000 Order" is amended in accordance with the following Articles 12 to 17.

10. In Schedule 1 of the "2000 Order" item 10 headed "Coates Way (Coates Way JMI School) a) east side part (i)" is amended by the substitution of the wording:

"from a point 6 metres south-west of its junction with Coates Dell in a northerly direction for a distance 25 metres"

by

"from a point 6 metres north of its junction with Coates Dell in a northerly direction for a distance of 25 metres"

11. Schedule 1 of the "2000 Order" is amended by the deletion of item 18 headed "Harvest End (Meriden JMI School)"

12. Schedule 1 of the "2000 Order" is amended by the addition of the following:-

"37 Greenbank Road (Holy Rood Infant and Junior Schools)

a) west side	(i)	between points 7 metres south and 19 metres north of the centre line of the vehicular entrance to Holy Rood Infant and Junior Schools

38 Southwold Road (Parkgate Junior School)

a) north west side	(i)	from a point 116 metres south west of its junction with Bushey Mill Lane for a distance of 43 metres in a south westerly direction

39 Coates Dell (Coates Way JMI School)

a) north side	(i)	from a point 24 metres east of its junction with Coates Way for a distance of 26 metres in an easterly direction"

13. In Schedule 2 of the "2000 Order" item 2 is amended by the deletion from the item headed "Fourth Avenue" of the wording "b) south east side (i) from a point 15 metres north of its south western end in a north easterly direction for a distance of 47 metres."

14. In Schedule 2 of the "2000 Order" item 5 headed "Leadbetter Drive a) north side" is amended by the substitution of the wording:

"(i) from its junction with Greenbank Road in an easterly direction for a distance of 10 metres"

by

"(i) from its junction with Greenbank Road to its junction with Hopwood Close a distance of 17 metres"

15. Schedule 2 of the "2000 Order" is amended by the addition of the following:-

"6 Coates Dell

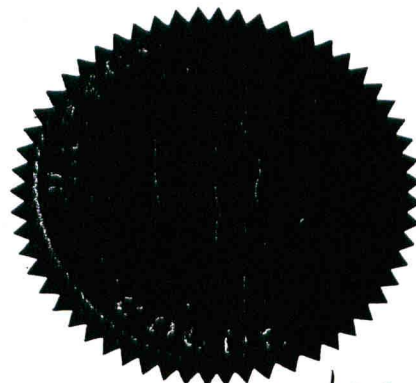
a) south side (i) from a point 22 metres east of its junction with Coates Way for a distance of 19 metres in an easterly direction

7 Hopwood Close

a) west side (i) from its junction with Leadbetter Drive for a distance of 6 metres in a northerly direction"

17. The Schedule of this Order shall be added to the "2000 Order" as Schedule 3 No Waiting: Monday to Friday inclusive: 8.30 to 9.30 am and 2.30 to 4.00 pm
