TRAFFIC REGULATION ORDER

**THE BOROUGH OF WATFORD
(COATES WAY/COATES DELL)
(PROHIBITION OF WAITING) (AMENDMENT) ORDER 2006**

The Watford Borough Council, pursuant to arrangements made under Section 19 of the Local Government Act 2000 and the Local Government (Arrangements for Discharge of Functions) (England) Regulations 2000 with the Hertfordshire County Council, and in exercise of powers conferred on that County under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

1. This Order may be cited as The Borough of Watford (Coates Way/Coates Dell) (Prohibition of Waiting) (Amendment) Order 2006 and shall come into operation on the 18th May 2006.
2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. The restrictions imposed by this Order shall be in addition to, and not in derogation of, any restriction or requirement imposed by any regulation made or having effect as if made under the Act or by or under any other enactment.
4. Article 2 of The Borough of Watford (Coates Way/Coates Dell) (Prohibition of Waiting) Order 1983 is amended by the substitution of:

" "disabled persons' badge" has the same meaning as the Disabled Persons' (Badges for Motor Vehicles) Regulations 1975; " and " "disabled persons' vehicle" has the same meaning as in the Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England and Wales) (Amendment) Regulations 1975; "
by
" "disabled person's badge" and "disabled person's vehicle" have the same meaning as in The Local Authorities Traffic Orders (Exemptions for Disabled Persons) (England and Wales) Regulations 1986 and The Disabled Persons (Badges for Motor Vehicles) Amendment Regulations 1992 and as amended by The Local Authorities Traffic Orders (Exemption for Disabled Persons) (England) Regulations 2000. "

5. Article 2 of The Borough of Watford (Coates Way/Coates Dell) (Prohibition of Waiting) Order 1983 is amended by the addition of :-

“designated officer” has the same meaning as in Article 2 of the Borough of Watford (Watford Central Area and West Watford) (Controlled Parking Zones) (Consolidation) Order 2002. “

and “Watford Special Parking Area” means the area designated in Article 4 of The Road Traffic (Permitted Parking Area and Special Parking Area) (County of Hertfordshire) (Borough of Watford) Order 1997. “

6. Article 3 of The Borough of Watford (Coates Way/Coates Dell) (Prohibition of Waiting) Order 1983 is amended by the substitution of “police constable in uniform or of a traffic warden” by “designated officer”.

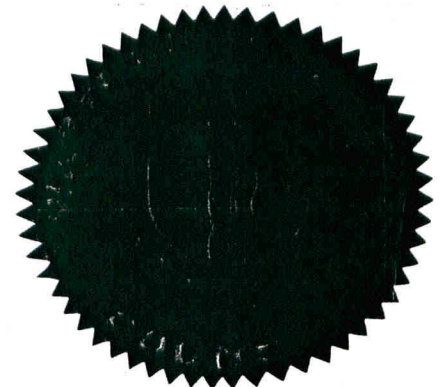
7. The Schedule of The Borough of Watford (Coates Way/Coates Dell) (Prohibition of Waiting) Order 1983 is amended by the addition of the following:-

Coates Dell

a) north side from a point 66 metres east of its junction with Coates Way for a distance of 13 metres in an easterly direction.

b) south side from a point 62 metres east of its junction with Coates Way for a distance of 16 metres in an easterly direction.
