

WATFORD BOROUGH COUNCIL**THE BOROUGH OF WATFORD (WATFORD CENTRAL AREA AND WEST WATFORD) (CONTROLLED PARKING ZONES) (CONSOLIDATION) ORDER 2006 (AMENDMENT) (NO. 2) ORDER 2006****Watford Council No. 642**

The Watford Borough Council, pursuant to arrangements made under Section 19 of the Local Government Act 2000 and the Local Government (Arrangements for Discharge of Functions) (England) Regulations 2000 with the Hertfordshire County Council, and in exercise of powers conferred on that County under Sections 1, 2, 4, 45, 46, 47, 49, 51 and 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and the Road Traffic Regulation Act 1991 and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, hereby makes the following Order:

1. This Order may be cited as THE BOROUGH OF WATFORD (WATFORD CENTRAL AREA AND WEST WATFORD) (CONTROLLED PARKING ZONES) (CONSOLIDATION) ORDER 2006 (AMENDMENT) (NO. 2) ORDER 2006 and shall come into operation on (day month) 2006.
2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. The prohibitions imposed by this Order shall be in addition to, and not in derogation of, any restriction or requirement imposed by any regulation made or having effect as if made under the Act or by or under any other enactment.
4. The BOROUGH OF WATFORD (WATFORD CENTRAL AREA AND WEST WATFORD) (CONTROLLED PARKING ZONES) (CONSOLIDATION) ORDER 2006 (the "2006 Order") shall be amended in accordance with the Articles 5 to 13 of this Order.
5. The following shall be added to the 2006 Order as Article 5A:-

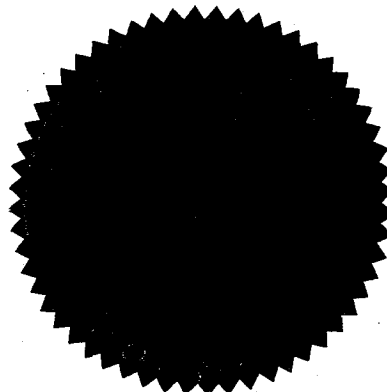
"Limited Waiting (No Charges) Areas Within the Controlled Parking Zones

- 5A (1) Subject to the provisions of this Order, the sides of street referred to in Schedule 25 are hereby designated as being limited waiting (no charges),
- (2) Except in accordance with paragraphs (3) and (4) below, no person shall cause or permit any vehicle to wait in the same place in a limited waiting (no charges) area in the Combined Zones as referred to in Schedule 25 during the CPZ Extended Hours for longer than the period stated in column 4 for the location described in columns 1, 2 and 3 and such vehicle shall not return to the same place within the period described accordingly in column 4,
 - (3) A vehicle being used for the purpose of delivering or collecting goods or of loading or unloading at premises adjacent to the street,
 - (4) A disabled person's vehicle which displays in the relevant position a disabled person's badge issued by any Local Authority.

6. Article 10 of the 2006 Order shall be amended by the replacement of the words "Nothing in Articles 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 15, 16, 17 or 18" by "Nothing in Articles 3, 4, 5, 5A, 6, 7, 8, 9, 10, 11, 12, 13, 15, 16, 17 or 18"
7. Article 14 of the 2006 Order shall be amended by the replacement of the words "Where a parking attendant is of the opinion that any of the provisions contained in Articles 3(2), 4(2), 5(2), 6(2), 7(2), 23(3), 32, 35 or 37" by "Where a parking attendant is of the opinion that any of the provisions contained in Articles 3(2), 4(2), 5(2), 5A(2), 6(2), 7(2), 23(3), 32, 35 or 37"
8. Schedules 1, 5, and 12 of the 2006 Order shall be amended in respect of the sides of the road referred to in columns 1 and 2 of Schedule 1 to this Order by the substitution for the location described in column 3 from the Schedules of the 2006 Order by the location described in column 4 of Schedule 1 to this Order.
9. The sides of road referred to in columns 1, 2 and 3 of Schedule 2 to this Order shall be added to the parts of Schedules 1, 3 and 6 of the 2006 Order as are indicated in Schedule 2 to this Order.
10. The sides of the roads referred to in columns 1 and 2 at the locations in column 3 of Schedule 3 to this Order shall be deleted from Schedule 6 of the 2006 Order as are indicated in Schedule 3 to this Order.
11. The sides of the roads referred to in Columns 1 and 2 at the locations in column 3 for the maximum stay in column 4 of Schedule 4 to this Order shall be added to Schedules 8 or 13 of the 2006 Order as are indicated in Schedule 4 to this Order.
12. The premises referred to in columns 1, 2 and 3 with the types of permit shown in column 4 and the special conditions shown in column 5 of Schedule 5 to this Order shall be added to Schedule 22: Part Two of the 2006 Order as indicated in Schedule 5 to this Order.
13. Schedule 6 of this Order shall be added to the 2006 Order as Schedule 25 of that Order.
