WATFORD BOROUGH COUNCIL TRAFFIC REGULATION ORDER

2007 NO. 721

THE BOROUGH OF WATFORD (HOLYWELL ESTATE, BELLMOUNT WOOD AVENUE AND NORTHFIELD GARDENS) (PROHIBITION OF WAITING) (AMENDMENT NO. 1) ORDER 2007

The Watford Borough Council, pursuant to arrangements made under Section 19 of the Local Government Act 2000 and the Local Government (Arrangements for Discharge of Functions) (England) Regulations 2000 with the Hertfordshire County Council, and in exercise of the powers conferred on that County Council under Sections 1, 2(1), 2(2), 4(2) and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act of 1984") and of all other enabling powers, and after consulting with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

- 1. This Order may be cited as The Borough of Watford (Holywell Estate, Bellmount Wood Avenue and Northfield Gardens) (Prohibition of Waiting) (Amendment No. 1) Order 2007 and shall come into operation on the 1st July 2007.
- 2. (1) In this Order -

"designated officer" has the same meaning as in Article 2 of the Borough of Watford (Watford Central Area and West Watford) (Controlled Parking Zones) (Consolidation) Order 2006;

"disabled person's badge" and "parking disc" have the same meanings as in Regulation 3(1) of the Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000 and "relevant position" has the same meaning as in Regulation 4 of those Regulations.

- (2) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 3. Save as provided in Article 5 or 6 of this Order, no person shall, except upon the direction or with the permission of a designated officer or a police officer in uniform, cause or permit any vehicle to wait on any length of road referred to in Schedule 1 to this Order at any time.

- Save as provided in Article 5 or 6 of this Order, no person shall, except upon the direction or with the permission of a designated officer or a police officer in uniform, cause or permit any vehicle to wait on any length of road referred to in Schedule 2 to this Order between the hours of 8am and 5pm on Mondays to Fridays inclusive.
- 5. Nothing in Article 3 or 4 of this Order shall render it unlawful to cause or permit any vehicle to wait on any length of road referred to therein, for so long as may be necessary to enable
 - (a) a person to board or alight from the vehicle;
 - (b) loading or unloading;
 - (c) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations, namely
 - (i) building, industrial or demolition operations;
 - (ii) the removal of any obstruction to traffic;
 - (iii) the maintenance, improvement or reconstruction of the highway;
 - (iv) the laying, erection, alteration or repair in or adjacent to the said lengths of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any electronic communication network within the meaning of the Communications Act 2003;
 - (d) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in the service of a local authority or a water authority in pursuance of statutory powers or duties;
 - (e) the vehicle to be used for the purpose of delivering or collecting postal packets as defined in the Postal Services Act 2000;
 - (f) the vehicle to be used for Fire and Rescue Service, Ambulance or Police purpose.

- 6. Nothing in Article 3 or 4 of this Order shall render it unlawful to cause a vehicle which displays in the relevant position a disabled person's badge and a parking disc (on which the driver or other person in charge of the vehicle has marked the time at which the period of waiting began) to wait on any of the lengths of roads referred to in that Article for a period not exceeding three hours (not being separated by an interval of less than one hour from a previous period of waiting by the same vehicle on the same length of road on the same day), provided that such period lies entirely within the period during which loading is permitted in that location.
- The restrictions imposed by this Order shall be in addition to, and not in derogation of, any restriction or requirement imposed by any regulation made or having effect as if made under the Act of 1984 or by or under any other enactment.
- Without prejudice to the validity of anything done, or to any liability incurred in respect of any act or omission before the coming into operation of this Order
- (A) The Schedule of the Borough of Watford (Bellmount Wood Avenue & Cassiobury Drive) (Prohibition of Waiting) Order 2005(a) is amended by the addition of the following:-

CHARLOCK WAY

(a) North and North-east Side

- (iii) from a point 4 metres north-west of the common boundary of Nos. 51 and 53 Charlock Way to a point 4 metres north-west of the common boundary of Nos. 57 and 59 Charlock Way (including any part named as Caractacus Green within this length)
- (iv) from a point opposite the south-westernmost wall of No. 67 Charlock Way to a point 10 metres north-west of a point opposite the common boundary of Nos. 38 and 40 Charlock Way (including any part named as Caractacus Green within this length)

(b) South and South-west Side

- (iii) from a point 4 metres north-west of a point opposite the common boundary of Nos. 51 and 53 Charlock Way to a point 10 metres north-west of the common boundary of Nos. 38 and 40 Charlock Way (including any part named as Caractacus Green within this length)
- (c) Both Sides, from a point 10 metres north-west of the north-western kerb-line of Clyston Road to a point 10 metres south-east of the south-eastern kerb-line of Clyston Road

CRUSADER WAY - EASTERN ARM

(c) both sides, from a point 10 metres south-east of the south-eastern kerb-line of Pioneer Way to its junction with the northern arm of Crusader Way

CRUSADER WAY - WESTERN ARM

(c) both sides, from the south-western kerb-line of Himalayan Way southwestward for a distance of 10 metres

CRUSADER WAY - NORTHERN ARM

Both sides

- (a) from its junction with the eastern arm of Crusader Way to a point opposite the party wall of Nos. 14 and 16 Crusader Way
- (b) from its junction with the western arm of Crusader Way to a point 10 metres south-east of the south-eastern kerb-line of the western arm of Crusader Way

MOOR VIEW - NORTHERN ARM

(c) both sides, from its junction with the eastern arm of Moor View to a point 10 metres north-west of the north-western kerb-line of Jellicoe Road

SCAMMELL WAY

(c) both sides, from the south-eastern kerb-line of Tolpits Lane south-eastward for a distance of 11.5 metres.
