THE BOROUGH OF WATFORD (WATFORD CENTRAL AREA AND WEST WATFORD) (CONTROLLED PARKING ZONES) (CONSOLIDATION) ORDER 2006 (AMENDMENT) (NO. 3) ORDER 2007

Watford Council No. 644

The Watford Borough Council, pursuant to arrangements made under Section 19 of the Local Government Act 2000 and the Local Government (Arrangements for Discharge of Functions) (England) Regulations 2000 with the Hertfordshire County Council, and in exercise of powers conferred on that County under Sections 1, 2, 4, 45, 46, 47, 49, 51 and 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and the Road Traffic Regulation Act 1991 and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, hereby makes the following Order:

1. This Order may be cited as THE BOROUGH OF WATFORD (WATFORD CENTRAL AREA AND WEST WATFORD) (CONTROLLED PARKING ZONES) (CONSOLIDATION) ORDER 2006 (AMENDMENT) (NO. 3) ORDER 2007 and shall come into operation on 23rd July 2007.
2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. The prohibitions imposed by this Order shall be in addition to, and not in derogation of, any restriction or requirement imposed by any regulation made or having effect as if made under the Act or by or under any other enactment.
4. The BOROUGH OF WATFORD (WATFORD CENTRAL AREA AND WEST WATFORD) (CONTROLLED PARKING ZONES) (CONSOLIDATION) ORDER 2006 (the "2006 Order") shall be amended in accordance with the Articles 5 to 10 of this Order.
5. Schedules 1, 2 and 7 of the 2006 Order shall be amended in respect of the sides of the road referred to in columns 1 and 2 of Schedule 1 to this Order by the substitution for the location described in column 3 of the Schedules of the 2006 Order by the location described in column 4 of Schedule 1 to this Order.
6. The sides of the roads referred to in Columns 1 and 2 at the locations in column 3 of Schedule 2 to this Order shall be added to Schedules 1 and 4 of the 2006 Order as are indicated in Schedule 2 to this Order.
7. The sides of the roads referred to in Columns 1 and 2 at the locations in column 3 of Schedule 3 to this Order shall be deleted from the parts of Schedule 4 of the 2006 Order as are indicated in Schedule 3 to this Order.
8. Schedule 21 of the 2006 Order shall be amended by the addition of addresses referred to in Schedule 4 to this Order.

9. The premises referred to in columns 1, 2, 3 and 4 of Schedule Five to this Order shall be added to Schedule 22: Part One of the 2006 Order as indicated in Schedule Five to this Order.
10. The premises referred to in columns 1, 2 and 3 with the types of permit shown in column 4 and the special conditions shown in column 5 of Schedule Six to this Order shall be added to Schedule 22: Part Two of the 2006 Order as indicated in Schedule Six to this Order
