THE BOROUGH OF WATFORD (WATFORD CENTRAL AREA AND WEST WATFORD) (CONTROLLED PARKING ZONES) (CONSOLIDATION) ORDER 2006 (AMENDMENT) (NO. 5) ORDER 2008

Watford Council No. 648

The Watford Borough Council, pursuant to arrangements made under Section 19 of the Local Government Act 2000 and the Local Government (Arrangements for Discharge of Functions) (England) Regulations 2000 with the Hertfordshire County Council, and in exercise of powers conferred on that County under Sections 1, 2, 4, 45, 46, 47, 49, 51 and 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and the Road Traffic Regulation Act 1991 and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, hereby makes the following Order:

- 1. This Order may be cited as THE BOROUGH OF WATFORD (WATFORD CENTRAL AREA AND WEST WATFORD) (CONTROLLED PARKING ZONES) (CONSOLIDATION) ORDER 2006 (AMENDMENT) (NO. 5) ORDER 2008 and shall come into operation as follows:
 - a) As regards those measures identified in Schedules 1, 2 and 4 as referring to Clarendon Road, on March 10th 2008;
 - b) As regards the measures in Schedules 5 and 6, on March 10th 2008;
 - c) As regards the revised charges identified in Article 16, on March 10th 2008;
 - d) As regards the remaining measures, April 28th 2008
- 2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 3. The prohibitions imposed by this Order shall be in addition to, and not in derogation of, any restriction or requirement imposed by any regulation made or having effect as if made under the Act or by or under any other enactment.
- 4. The BOROUGH OF WATFORD (WATFORD CENTRAL AREA AND WEST WATFORD) (CONTROLLED PARKING ZONES) (CONSOLIDATION) ORDER 2006 (the "2006 Order") shall be amended in accordance with the Articles 5 to 16 of this Order.
- 5. Article 2: Interpretation of the "2006 Order" shall be amended by the addition of the following:-

"taxi' means a vehicle licensed by Watford Borough Council under Section 37 of the Town Police Clauses Act 1847 or any other similar enactment."

6. The following shall be added as Article 4A of the "2006 Order"

"Stopping and Waiting Places for Taxis within the Controlled Parking Zones

- 4A (1) Subject to the provisions of this Order, the sides of street referred to in Schedule 26 are hereby designated as being a stopping and waiting place for taxis only.
 - (2) No person shall cause or permit any vehicle except a taxi to stop, wait, load or unload at any time in the same place in any area designated as a stopping and waiting place for taxis only.
 - (3) A stopping and waiting place for taxis only shall be delineated on the highway by a longitudinal yellow line together with a taxi rank carriageway box marking and the obscuring or obliteration of such a line and marking, or any part thereof, shall not render the restriction contained in paragraph (2) ineffective."



- 7. Article 10 of the '2006 Order' shall be amended by the addition of "4A, " after the words "Nothing in Articles 3, 4, ".
- 8. Article 14 of the '2006 Order' shall be amended by the addition of "4A(2), " after the words "provisions contained in Articles 3(2), 4(2), ".
- 9. The Borough of Watford (Clarendon Road) Hackney Carriage Stand Appointment 2005 is hereby revoked.
- 10. The sides of road referred to in columns 1, 2 and 3 of Schedule 1 to this Order shall be added to the parts of Schedules 1 and 5 of the 2006 Order as are indicated in Schedule 1 to this Order.
- 11. The sides of the roads referred to in columns 1 and 2 at the locations in column 3 of Schedule 2 to this Order shall be deleted from Schedules 1 and 2 of the 2006 Order as are indicated in Schedule 2 to this Order.
- 12. Schedules 8 and 9 of the 2006 Order shall be amended in respect of the sides of the road referred to in columns 1, 2 and 3 of Schedule 3 to this Order by the substitution for the maximum stay in column 4 from the Schedules of the 2006 Order by the maximum stay described in column 5 of Schedule 3 to this Order.
- 13. Schedule 4 of this Order shall be added to the 2006 Order as Schedule 26 of that Order.
- 14. The premises referred to in columns 1, 2, 3 and 4 of Schedule 5 to this Order shall be added to Schedule 22: Part One of the 2006 Order as indicated in Schedule 5 to this Order.
- 15. The premises referred to in columns 1, 2 and 3 with the types of permit shown in column 4 and the special conditions shown in column 5 of Schedule 6 to this Order shall be added to Schedule 22: Part Two of the 2006 Order as indicated in Schedule 6 to this Order.
- 16. In Article 31 of the 2006 Order Table One shall be replaced by the following table:-
