THE BOROUGH OF WATFORD (WATFORD CENTRAL AREA AND WEST WATFORD) (CONTROLLED PARKING ZONES) (CONSOLIDATION) ORDER 2006 (AMENDMENT) (NO. 6) ORDER 2008

Watford Council No. 649

The Watford Borough Council, pursuant to arrangements made under Section 19 of the Local Government Act 2000 and the Local Government (Arrangements for Discharge of Functions) (England) Regulations 2000 with the Hertfordshire County Council, and in exercise of powers conferred on that County under Sections 1, 2, 4, 45, 46, 47, 49, 51 and 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and the Road Traffic Regulation Act 1991 and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, hereby makes the following Order:

- This Order may be cited as THE BOROUGH OF WATFORD (WATFORD CENTRAL AREA AND WEST WATFORD) (CONTROLLED PARKING ZONES) (CONSOLIDATION) ORDER 2006 (AMENDMENT) (NO. 6) ORDER 2008 and shall come into operation on April 28th 2008.
- 2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 3. The prohibitions imposed by this Order shall be in addition to, and not in derogation of, any restriction or requirement imposed by any regulation made or having effect as if made under the Act or by or under any other enactment.
- 4. The BOROUGH OF WATFORD (WATFORD CENTRAL AREA AND WEST WATFORD) (CONTROLLED PARKING ZONES) (CONSOLIDATION) ORDER 2006 (the "2006 Order") shall be amended in accordance with the Articles 5 to 31 of this Order.
- Article 41 of the 2006 Order shall be amended by: In paragraph (1) by the substitution of the wording "other than a resident within Parking Zones B, C or H" by "other than a resident within Parking Zones B, C, H, M or N"

And by the addition of paragraph (2A) as follows:

"(2A) Any resident within Parking Zone M or N who is the owner of a vehicle of the class specified in Article 11(1) may apply to the Council for the issue of a residents' permit relating to Parking Zones M and N in respect of that vehicle and any such application shall be made on a form issued by and obtainable from the Council and shall include the particulars and information required by such form to be supplied."

And In paragraph (3) by the substitution of the wording "except Parking Zones E, J, K, L, M, N, P, R, S and T" by "except Parking Zones E, J, K, L, M, N, S and T"

6. Paragraph (2) (d) of Article 60 of the 2006 Order shall be deleted.

- 7. Paragraph (1) (b) of Article 62 of the 2006 Order shall be substituted by the following:-:
 - for up to a maximum of 4 hours from the time and date indicated on the permit, subject to Article 60 and the charge therefore shall be seven pounds (but three pounds fifty pence if the applicant is aged 60 years or over) for 20 permits."
- 8. Paragraph (1) of Article 63 of the 2006 Order shall be substituted by the following:
 "(1) A long-stay residents' visitor permit shall authorise parking as follows:-
 - (a) for up to a maximum of one day from the time and date indicated on the permit, subject to Article 60, and the charge therefore shall be three pounds fifty pence (but one pound seventy five pence if the applicant is aged 60 years or over) for five permits."
 - (b) for up to a maximum of seven days from the time and date indicated on the permit, subject to Article 60, and the charge therefore shall be three pounds fifty pence (but one pound seventy five pence if the applicant is aged 60 years or over) per permit."
- 9. Paragraph (2) of Article 63 of the 2006 Order shall be substituted by the following:
 "(2) The Council shall not during a period of one year issue:-
 - (a) a long stay residents' visitor permit of the type referred to in Paragraph (1) (a) to a resident in any household in respect of which other long stay residents' permits of that type have been issued with a cumulative duration of 15 days (but 30 days if the resident is aged 60 years or over) and which have not been surrendered or withdrawn under Article 64 (2) or (3)."
 - (b) a long stay residents' visitor permit of the type referred to in Paragraph (1) (b) to a resident in any household in respect of which other long stay residents' permits of that type have been issued with a cumulative duration of 14 days (but 28 days if the resident is aged 60 years or over) and which have not been surrendered or withdrawn under Article 64 (2) or (3)."
- 10. Paragraph (2) (d) of Article 90 of the 2006 Order shall be deleted.
- 11. Paragraph (2) of Article 92 of the 2006 Order shall be amended by the substitution of the words "in respect of which 25 (but 50 if the resident is aged 60 years or over)" by "in respect of which 30 (but 60 if the resident is aged 60 years or over)".
- 12. The section of Schedule 1 of the 2006 Order entitled "Watford Rookery: Zone R" shall be deleted from that Schedule and the lengths of street described in Columns 1, 2 and 3 shall be added to that Schedule under the title "Watford St James: Zone J"
- 13. The section of Schedule 1 of the 2006 Order entitled "West Watford Hagden East Zone P" shall be deleted from that Schedule and the lengths of street described in Columns 1, 2 and 3 shall be added to that Schedule under the title "Watford Cassiobridge: ZoneT"

- 14. The section of Schedule 2 of the 2006 Order entitled "Watford Lower Town Centre: Zone E" shall be deleted from that Schedule and the lengths of street described in Columns 1, 2 and 3 shall be added to Schedule 3 of the 2006 Order under the title "Schedule 3: Waiting Restricted: Monday to Saturday inclusive: 8.00 am to 6.30 pm and match day hours Watford Lower Town Centre: Zone E"
- 15. The section of Schedule 3 of the 2006 Order entitled "West Watford Hagden East: Zone P" shall be retitled "Schedule 3: Waiting Restricted: Monday to Saturday inclusive: 8.00 am to 6.30 pm and match day hours Watford Cassiobridge: Zone T"
- 16. The section of Schedule 4 of the 2006 Order entitled "Watford Lower Town Centre: Zone E" shall be deleted from that Schedule and the lengths of street described in Columns 1, 2 and 3 shall be added to Schedule 5 of the 2006 Order under the title "Schedule 5: Parking Bays for Permit Holders Only: Monday to Saturday inclusive: 8.00 am to 6.30 pm and match day hours Watford Lower Town Centre: Zone E"
- 17. The section of Schedule 6 of the 2006 Order entitled "West Watford Hagden East: Zone P" shall be deleted from that Schedule and the lengths of street described in Columns 1, 2 and 3 shall be added to Schedule 5 of the 2006 Order under the title "Schedule 5: Parking Bays for Permit Holders Only: Monday to Saturday inclusive: 8.00 am to 6.30 pm and match day hours Watford Lower Town Centre: Zone E"
- 18. The section of Schedule 6 of the 2006 Order entitled "Watford Rookery: Zone R" shall be deleted from that Schedule and the lengths of street described in Columns 1, 2 and 3 shall be added to Schedule 5 of the 2006 Order under the title "Schedule 5: Parking Bays for Permit Holders Only: Monday to Saturday inclusive: 8.00 am to 6.30 pm and match day hours Watford Cassiobridge: Zone T"
- 19. The section of Schedule 7 of the 2006 Order entitled "Watford Lower Town Centre: Zone E" shall be deleted from that Schedule and the lengths of street described in Columns 1, 2 and 3 shall be added to Schedule 8 of the 2006 Order under the title "Schedule 8: Parking Bays for Shared Use: Monday to Saturday inclusive: 8.00 am to 6.30 pm and match day hours Watford Lower Town Centre: Zone E"
- 20. The section of Schedule 9 of the 2006 Order entitled "Watford Lower Town Centre: Zone E" shall be deleted from that Schedule and the lengths of street described in Columns 1, 2 and 3 shall be added to Schedule 10 of the 2006 Order under the title "Schedule 10: Parking Bays for Limited Waiting (Pay and Display): Monday to Saturday inclusive: 8.00 am to 6.30 pm and match day hours Watford Lower Town Centre: Zone E"
- 21. The section of Schedule 21 of the 2006 Order labelled 'The CPZ Standard Zones: Parking Zone D' shall be amended by the addition of 'The Spinney' and 'Church Road (west of a point 10 metres west of the junction with Manor Road)'.
- 22. In the section of Schedule 21 of the 2006 Order labelled 'The CPZ Standard Zones' the Parking Zone E and the streets listed within Parking Zone E shall be transferred to the section of Schedule 21 labelled 'The Combined (CPZ Standard and Matchday Hours) Zones'

- 23. In the section of Schedule 21 of the 2006 Order labelled 'The Matchday Only Zones' the Parking Zone P shall be deleted and the streets listed within Parking Zone P shall be transferred to the section of Schedule 21 labelled 'The Combined (CPZ Standard and Matchday Hours) Zones' and added under 'Parking Zone T'.
- 24. In the section of Schedule 21 of the 2006 Order labelled 'The Matchday Only Zones' the Parking Zone R shall be deleted and the streets listed within Parking Zone R shall be transferred to the section of Schedule 21 labelled 'The Combined (CPZ Standard and Matchday Hours) Zones' and added under 'Parking Zone J'.
- 25. Schedule 5 of the 2006 Order shall be amended in respect of the sides of the road referred to in columns 1 and 2 of Schedule 1 to this Order by the substitution for the location described in column 3 from the Schedules of the 2006 Order by the location described in column 4 of Schedule 1 to this Order.
- 26. The sides of road referred to in columns 1, 2 and 3 of Schedule 2 to this Order shall be added to the parts of Schedules 1 and 5 of the 2006 Order as are indicated in Schedule 2 to this Order.
- 27. The premises referred to in columns 1, 2, 3 and 4 of Schedule 3 to this Order shall be added to Schedule 22: Part One of the 2006 Order as indicated in Schedule 3 to this Order.
- 28. The premises referred to in columns 1, 2 and 3 with the types of permit shown in column 4 and the special conditions shown in column 5 of Schedule 4 to this Order shall be added to Schedule 22: Part Two of the 2006 Order as indicated in Schedule 4 to this Order.
- 29. In Schedule 22 Parts One and Two all references to Parking Zone P shall be amended to Parking Zone T and all references to parking Zone R shall be amended to Parking Zone J.
- 30.1n Schedule 22 Part Two of the 2006 Order the wording "Only 200 hrs (400 hrs if the resident is 60 years or over) short term visitor permits and 14 days (28 days if the resident is 60 years or over) long term visitor permits to be issued to each household. Charges as per Articles 62 and 63." in column 5 for the type of permit 'Residents' Visitor Parking Permit' in column 4 in respect of each address identified in columns 1, 2 and 3 shall be replaced by the following wording:-

"Only 200 hrs (400 hrs if the resident is 60 years or over) short stay Visitor Permits

together with

7 days (14 days if the resident is 60 years or over) long stay 'one week' Visitor Permits

and

8 days (15 days if the resident is 60 years or over) long stay 'one day' Visitor Permits

to be issued to each household.

Charges are as per Articles 62 and 63."

And the wording "Only fifteen (twenty five if the resident is 60 years or over) match day visitor permits to be issued to each household. Charges as per Article 92." in column 5 for the type of permit 'Residents' Visitor Parking Permit' in column 4 in respect of each address identified in columns 1, 2 and 3 shall be replaced by the following wording:-

"Only fifteen (thirty if the resident is 60 years or over) match day visitor permits to be issued to each household. Charges as per Article 92."

31. In Article 110 of the 2006 Order Table Two shall be replaced by the following table:-


