

**WATFORD BOROUGH COUNCIL****The Borough of Watford (St Albans Road and Various Side Roads)  
(Prohibition and Restriction of Waiting and Parking Places ) (Amendment)  
( No. 2) Order 2008****Order No. 725**

The Watford Borough Council, pursuant to arrangements made under Section 19 of the Local Government Act 2000 and the Local Government (Arrangements for Discharge of Functions) (England) Regulations 2000 with the Hertfordshire County Council, and in exercise of powers conferred on that County under Sections 1, 2, and 4 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and the Road Traffic Regulation Act 1991 and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, hereby makes the following Order:

1. This Order may be cited as the Borough of Watford (St Albans Road and Various Side Roads) (Prohibition and Restriction of Waiting and Parking Places) (Amendment) (No. 2) Order 2008 and shall come into force on Monday 4th August 2008.
2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. The restrictions, prohibitions and requirements imposed by this Order are in addition to and not in derogation of any restriction, prohibition or requirement imposed by any other enactment and any exception or exemption from the provisions of this Order is without prejudice to the provisions of any other enactment.
4. THE BOROUGH OF WATFORD (PARK, NASCOT AND LEGGATTS AREA) (PROHIBITION AND RESTRICTION OF WAITING) ORDER 1998 (the "1998 Order") shall be amended in accordance with Article 5 of this Order.
5. Schedule 2 of the "1998 Order" shall be amended by the substitution in the paragraphs identified by 1. Beechwood Rise: a) north west side (i) and by 1. Beechwood Rise: b) south west side of the words "St Albans Road" by the word "Longspring".
6. THE BOROUGH OF WATFORD (ST ALBANS ROAD AND VARIOUS SIDE ROADS) (PARKING PLACES) ORDER 2006 (the "Parking Places Order") shall be amended in accordance with the Articles 7 to 15 of this Order.
7. The following will be added to the "Parking Places Order" as Article 4A:-  
"4A Subject to the provisions of this Order, parking places may be used for the leaving during the permitted hours of vehicles of the following class, that is to say, passenger vehicles, goods carrying vehicles (the overall height of which does not exceed 2.3 metres and the

overall length of which does not exceed 5.25 metres), motor cycles and invalid carriages.”

8. Articles 5, 6, 18, 19 and 22 of the “Parking Places Order” shall be amended by the substitution of “Schedule 1 or 2” by “Schedule 1, 2 or 4”.
9. Articles 7, 12 and 20 of the “Parking Places Order” shall be amended by the substitution of “Schedules 1, 2 or 3” by “Schedules 1, 2, 3 or 4”.
10. Article 15 of the “Parking Places Order” shall be amended in accordance with the provisions of the Notice of Variation of On-Street Parking Charges 2007 made by Watford Borough Council in exercise of delegated powers under S46A of the Road Traffic Regulation Act 1984 and contained in paragraph (c) (i) of that Notice.
11. Article 16 of the “Parking Places Order” shall be amended by the substitution of Schedule 2” by “Schedule 2 and 4”.
12. Article 16 of the “Parking Places Order” shall be amended in accordance with the provisions of the Notice of Variation of On-Street Parking Charges 2007 made by Watford Borough Council in exercise of delegated powers under S46A of the Road Traffic Regulation Act 1984 and contained in paragraph (c) (ii) of that Notice.
13. Article 20 of the “Parking Places Order” shall be amended by the addition of a prefix “(1)” to the paragraph which begins with the words “A motor cycle may be left.....” and by the addition of the following paragraph “ (2) Where a parking space is marked ‘motor cycles’ it shall be reserved solely for the leaving of motor cycles as defined by the Road Vehicles (Construction and Use) Regulations 1986 and in accordance with paragraph (1).
14. Schedule One of this Order shall be added to the “Parking Places Order” as Schedule 4 of that Order.
15. Schedule 3 of the “Parking Places Order” shall be amended by the substitution in the second column of the word “Leavesden” by the words “Leavesden Road”.
16. THE BOROUGH OF WATFORD (REGENT STREET, CECIL STREET, JUDGE STREET) (PARKING PLACES) (DISABLED PERSONS) ORDER 2006 (the “Parking Places – Disabled Persons Order”) shall be amended in accordance with the Article 17 of this Order.
17. The parking place referred to in columns 1, 2 and 3 of Schedule Two to this Order shall be added to the Schedule of the “Parking Places – Disabled Persons Order” as is indicated in Schedule Two to this Order.
18. THE BOROUGH OF WATFORD (ST ALBANS ROAD AND VARIOUS SIDE ROADS) (PROHIBITION AND RESTRICTION OF WAITING, LOADING AND UNLOADING) ORDER 2006 (the “Waiting, Loading and Unloading Order”) shall be amended in accordance with the Article 19 of this Order.
19. The following lengths of road shall be added to Schedule 3 of the “Waiting, Loading and Unloading Order”:

**Street**

“The Harebreaks (that section of public highway situated to the north west of the junction of The Harebreaks with St Albans Road and separated therefrom by a public footway)”

## SCHEDULE ONE

INSERT new Schedule 4 to The Borough Of Watford (St Albans Road And Various Side Roads) (Parking Places) Order 2006 titled:

**SCHEDULE 4:** Pay and Display Parking Places designated for the leaving of vehicles for a maximum period of two hours with no return within two hours during the permitted hours between 8.30am and 5.00pm on Mondays to Saturdays inclusive.

The Harebreaks (that section of public highway situated to the north west of the junction of The Harebreaks with St Albans Road and separated therefrom by a public footway)	Around the north and east and south and west sides from a point 3 metres from the junction with The Harebreaks (north side) to a point 3 metres from the junction with The Harebreaks (south side) (measured clockwise along the kerbline), a total distance of 117 metres, excluding the following lengths: between 19 metres and 31 metres (on the north east side) between 60 metres and 68 metres (on the east side) between 75 metres and 79 metres (on the south east side) DISABLED BAY between 79 metres and 88 metres (on the south side) all measured clockwise along the kerbline from the junction with The Harebreaks (north side).	26 parking bays standing at 90 degrees to the outer edge of the carriageway including one bay marked "motor cycles"

Length of Street

- "(31) the north west side of the entrance from The Harebreaks: from its junction with The Harebreaks for a distance of 3 metres in a north easterly direction,
- (32) the south east side of the entrance from The Harebreaks: from its junction with The Harebreaks for a distance of 3 metres in a north easterly direction,
- (33) the north east side between points 19 metres and 31 metres measured clockwise along the kerbline from the junction with The Harebreaks (north side),
- (34) the east side between points at 60 metres and 68 metres measured clockwise along the kerbline from the junction with The Harebreaks (north side)
- (35) the south side between points at 79 metres and 88 metres measured clockwise along the kerbline from the junction with The Harebreaks (north side)".
