THE BOROUGH OF WATFORD (WATFORD CENTRAL AREA AND WEST WATFORD) (CONTROLLED PARKING ZONES) (CONSOLIDATION) ORDER 2006 (AMENDMENT) (NO. 9) ORDER 2009

Watford Council No. 653

The Watford Borough Council, pursuant to arrangements made under Section 19 of the Local Government Act 2000 and the Local Government (Arrangements for Discharge of Functions) (England) Regulations 2000 with the Hertfordshire County Council, and in exercise of powers conferred on that County under Sections 1, 2, 4, 45, 46, 47, 49, 51 and 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and the Road Traffic Regulation Act 1991 and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, hereby makes the following Order:

1. This Order may be cited as THE BOROUGH OF WATFORD (WATFORD CENTRAL AREA AND WEST WATFORD) (CONTROLLED PARKING ZONES) (CONSOLIDATION) ORDER 2006 (AMENDMENT) (NO. 9) ORDER 2009 and shall come into operation on 2nd February 2009.
2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. The prohibitions imposed by this Order shall be in addition to, and not in derogation of, any restriction or requirement imposed by any regulation made or having effect as if made under the Act or by or under any other enactment.
4. The BOROUGH OF WATFORD (WATFORD CENTRAL AREA AND WEST WATFORD) (CONTROLLED PARKING ZONES) (CONSOLIDATION) ORDER 2006 (the "2006 Order") shall be amended in accordance with the Articles 5 to 13 of this Order.
5. The sides of road referred to in columns 1, 2 and 3 of the Schedule One to this Order shall be added to the parts of Schedules 1, 2 and 4 of the 2006 Order as are indicated in Schedule One to this Order.
6. The street name, together with the sides of street and the locations identified as (a) and (b) in the Schedule to The Borough of Watford (Terrace Gardens) (Prohibition of Waiting) Order 1977 shall be added to columns 1, 2 and 3 respectively of that part of Schedule 1 of the 2006 Order as is indicated as Zone D.
7. The following street names, sides of street and locations shall be added to columns 1, 2 and 3 respectively of that part of Schedule 1 of the 2006 Order as is indicated as Zones A, B and C:-

Orphanage Road	north west	From its junction with Woodford Road to the entrance to the railway goods yard

Orphanage Road	south east	From its junction with Queens Road for a distance of 100 metres in a north easterly direction

8. Schedule 20 of the 2006 Order shall be amended by the addition of the following paragraph and table:
 "At the following sides of street, parking places may comprise parking bays marked so that the sides are set at an oblique angle to the edge of the carriageway.

9. Schedule 21 of the 2006 Order shall be amended by the addition of 'Bedford Street' under the sub heading 'The CPZ Standard Zones – Parking Zone D'.
10. The premises referred to in columns 1, 2, 3 and 4 of Schedule 2 to this Order shall be added to Schedule 22: Part One of the 2006 Order as indicated in Schedule 2 to this Order.
11. The premises referred to in columns 1, 2 and 3 with the types of permit shown in column 4 and the special conditions shown in column 5 of Schedule 3 to this Order shall be added to Schedule 22: Part Two of the 2006 Order as indicated in Schedule 3 to this Order.
12. The following traffic regulation orders are hereby revoked:-
 (a) The Borough Of Watford (Bedford Street) (Prohibition Of Waiting) Order 1978,
 (b) The Borough of Watford (Terrace Gardens) (Prohibition of Waiting) Order 1977.
13. That The Borough of Watford (Central Area Controlled Parking Zone B) Order 1992 as refers to Orphanage Road is hereby revoked.
